**ADOPTED** at a regular meeting of the Wilmington Metropolitan Bicycle and Pedestrian Committee on January 8, 2009.

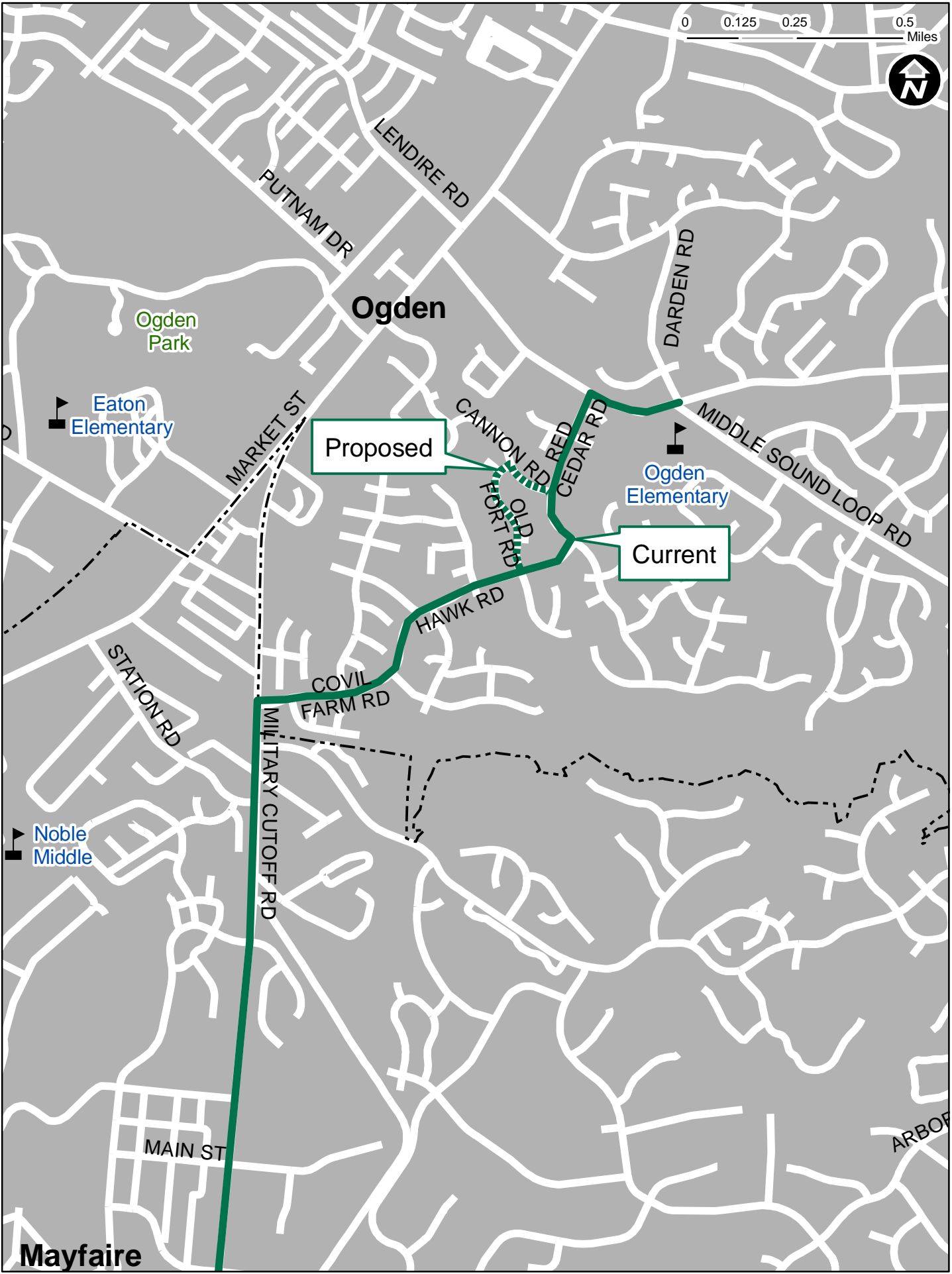
