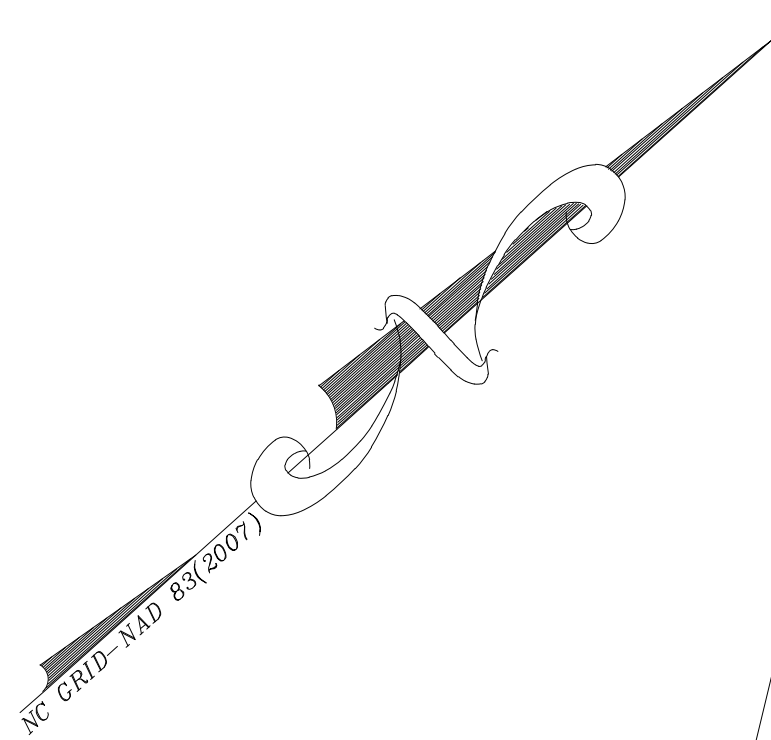


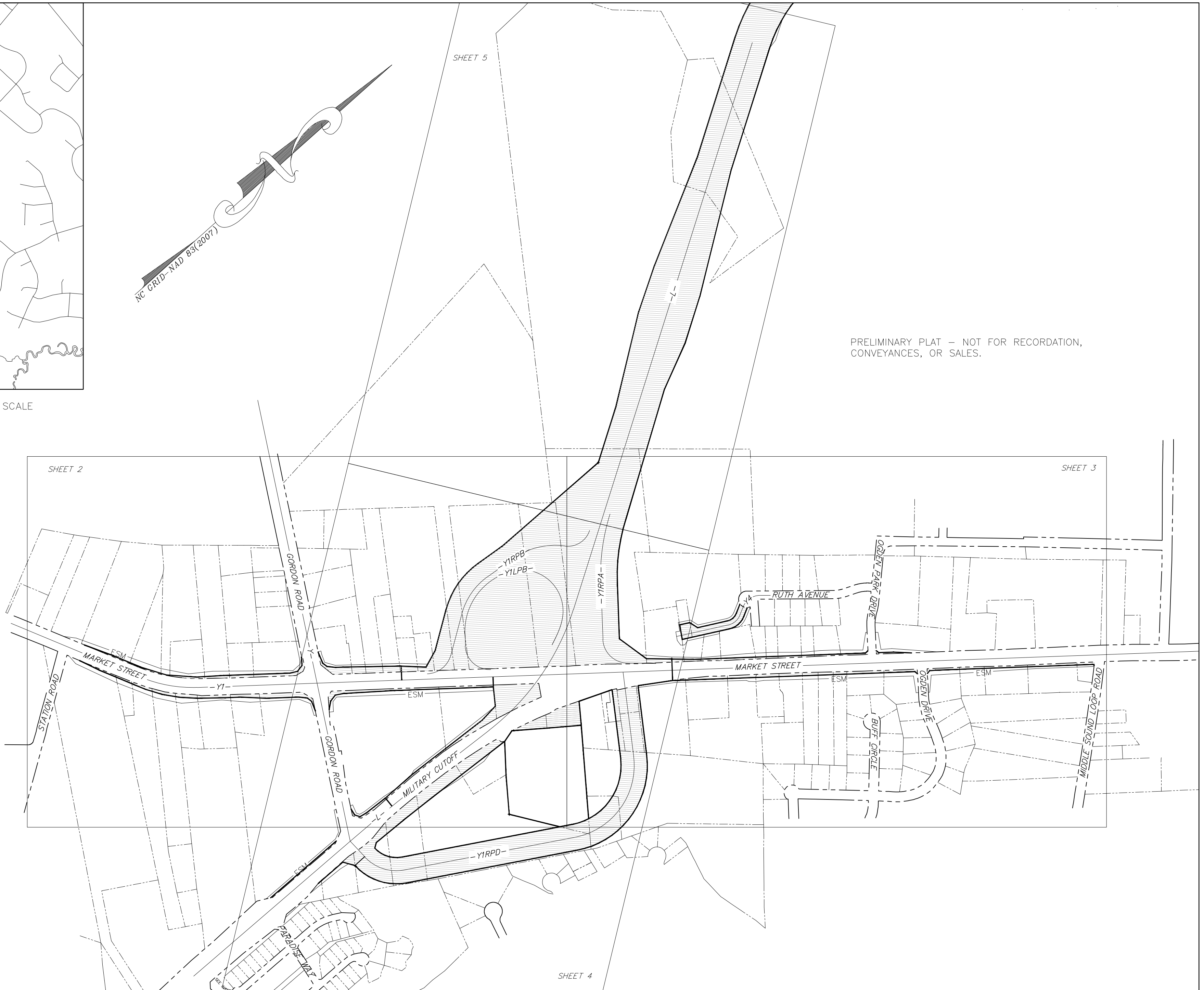
LOCATION MAP NOT TO SCALE

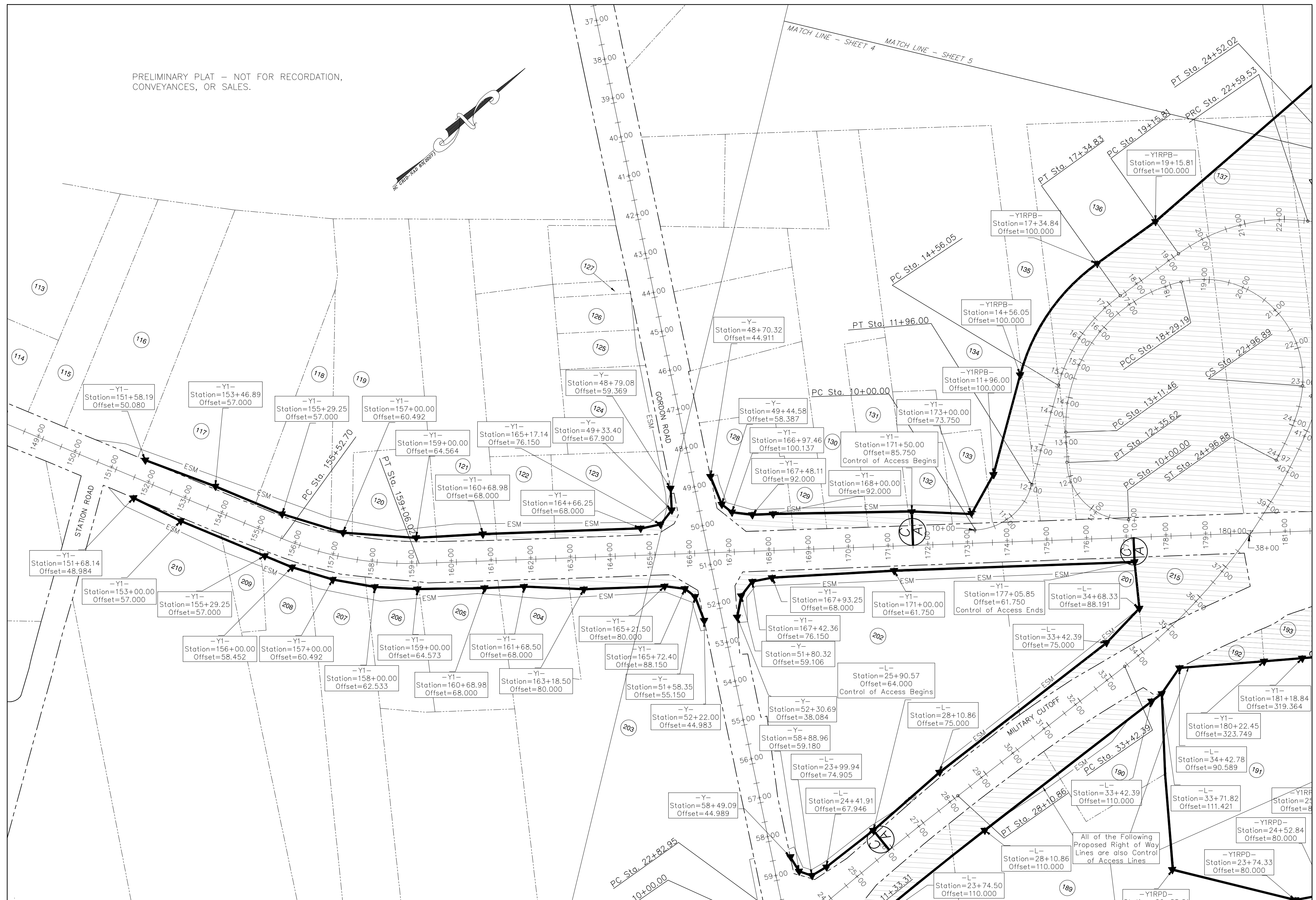
TRANSPORTATION CORRIDOR OFFICIAL MAP

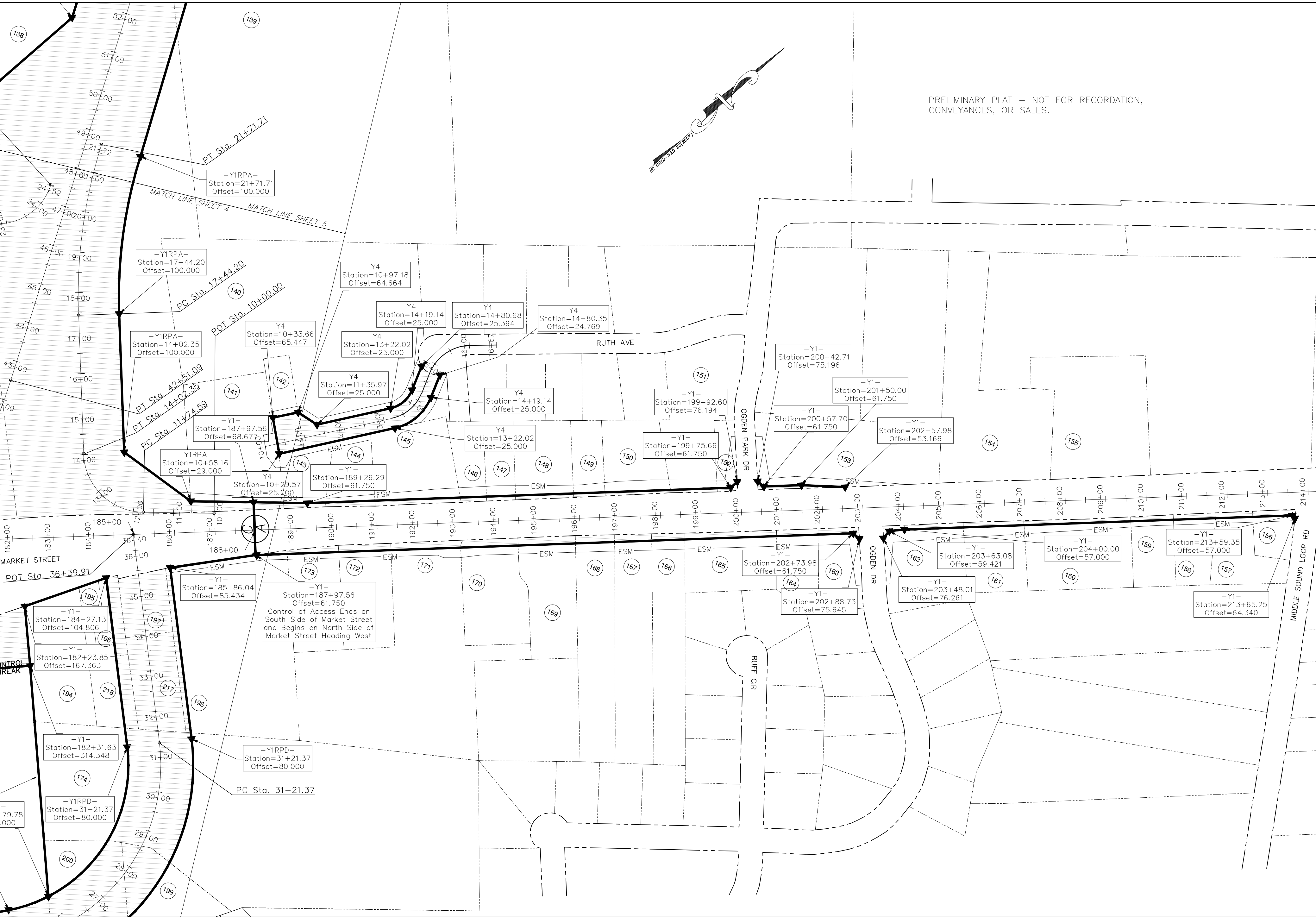

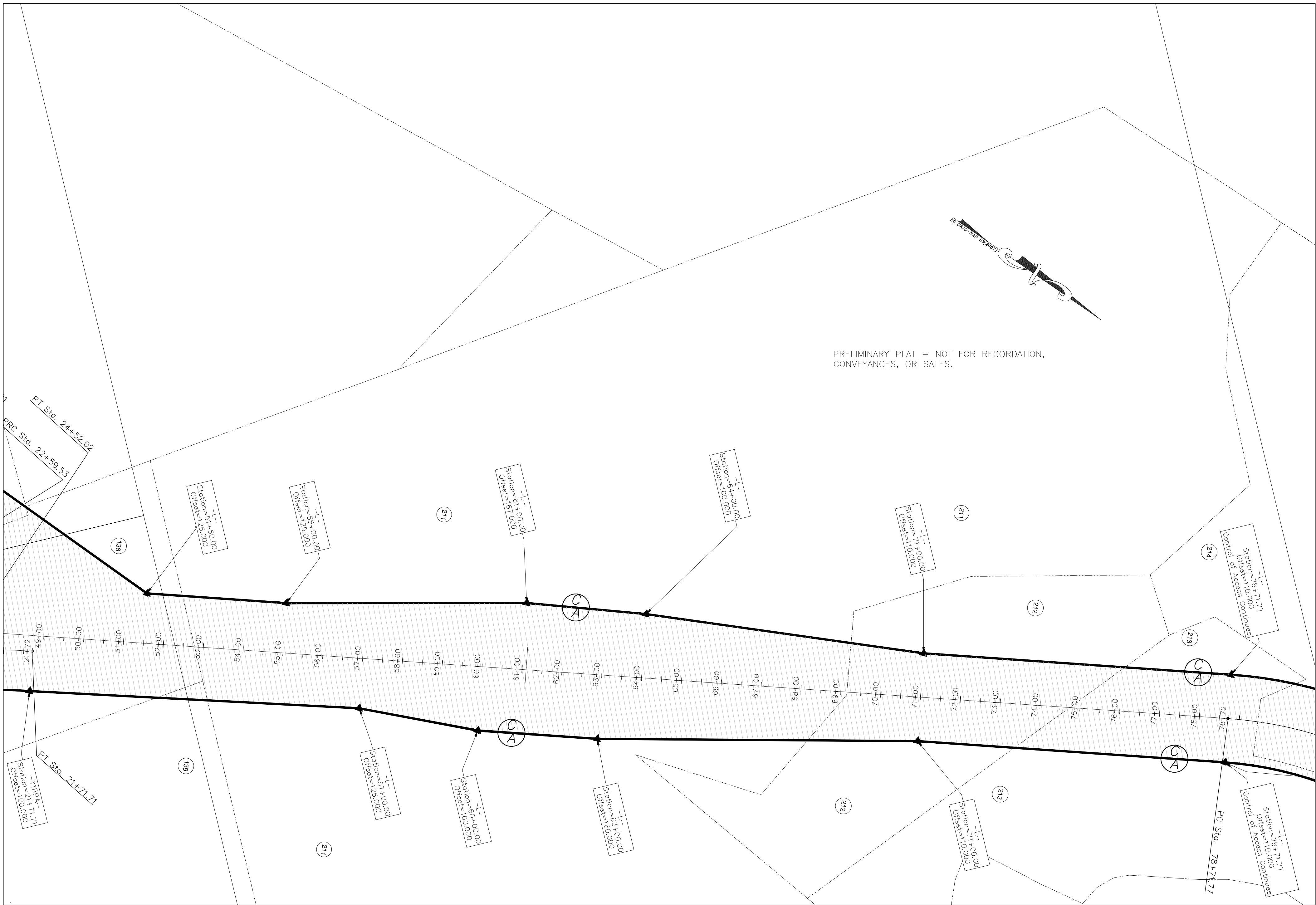
