### 1. Call to Order

Mr. Kozlosky called the meeting to order at 10:05am.

# 2. Approval of Minutes

The minutes for the meeting November 18, 2015 were approved unanimously.

## 3. Election of Officers

Mr. Vafier nominated Mr. Kozlosky as Chair of the TCC. Mr. Serkin seconded the nomination. Ms. Avery made the motion to close nominations and Mr. Waring seconded the motion. The vote to elect Mr. Kozlosky as Chair carried unanimously.

Mr. Serkin nominated Mr. Bennett as Vice Chair. Mr. Vafier seconded the nomination. Mr. Snipes made the motion to close nominations and Ms. Avery seconded the motion. The vote to elect Mr. Bennett as Vice Chair carried unanimously.

Mr. Bennett made the motion to approve the items on the consent agenda and forward to the TAC for consideration. Ms. Harrington seconded to motion and it carried unanimously.

# 5. Regular Agenda

a. Resolution adopting the Wilmington Urban Area MPO's Comprehensive Transportation Plan
Mr. Snipes told members that projects in the Comprehensive Transportation Plan (CTP) come from
the adopted Metropolitan Transportation Plan (MTP). The CTP includes all the funded project from
the MTP plus all the remaining project in the MTP that are not fiscally constrained.

Ms. Avery made the motion to adopt the Wilmington Urban Area MPO's Comprehensive Transportation Plan and forward to the TAC for consideration. Mr. Riddle seconded the motion and it carried unanimously.

## b. Resolution approving 2016 STP-DA Allocations

Mr. Knight told members that 2016 funding requests for Surface Transportation Program-Direct Attributable (STP-DA) allocations came from the Town of Leland (two projects), the Town of Carolina Beach and Cape Fear Public Transportation Authority (CFPTA). Mr. Knight said staff reviewed the application submittals using the approved competitive scoring process for the 2016 STP-DA allocation. He told members that with a maximum score of 120 points for Bicycle/Pedestrian projects, CFPTA's Multi-modal Transportation Center scored 91, Leland's Westgate Multi-use Path scored 44 points, and Carolina Beach's St. Joseph Street Bike Lanes scored 40.75. Mr. Knight said Leland's Northgate Intersection Realignment Project was evaluated using the scoring criteria for Intersection Improvement Projects. He noted that the maximum score for Intersections Improvement Projects was 48 points and Leland's Northgate Intersection Realignment project scored 14. Mr. Knight stated that staff recommended allocating \$2.4 million of STP-DA funding to the CFPTA for the Multi-modal Transportation Center.

Mr. Knight told members that staff received one request for the TAP-DA funding. The Town of Navassa submitted the only application. Mr. Knight noted that the maximum score for TAP-DA Bike/Ped projects is 135 points and Navassa's Multi-use Path at Navassa Park project scored 22. Their funding request was also over the amount of funding available. Mr. Knight told members that staff recommends holding the funds from the FY16 allocation to roll into FY17. That will allow the next call for TAP-DA projects to be more powerful and attract more applicants.

Mr. Kozlosky told members one of the reasons behind staff's recommendation to allocate funds to the Multi-modal Transportation Center was that funds have been appropriated for FY13, FY14 and FY15; and, currently there is only one project from FY13 that is actually ready to go. The allocation of funds to the Multi-modal Transportation Center would allow local jurisdictions to catch up and get their projects under construction before next year's allocations are awarded.

Mr. Eby told members that the new multi-modal center will help address safety concerns for passengers who are currently using the 2<sup>nd</sup> Street WAVE transfer site. Many of those passenger are crossing mid-block to make transfer connections. With the increased development in that area, problems will continue to grow.

Mr. Kozlosky noted that there is still around \$700,000.00 in NC Moving Ahead Funds that were setaside by the State in the 2004 that has already be committed to this project.

Mr. Eby made the motion to support the allocation of the FY16 STP-DA funds to the CFPTA for the Wilmington Multi-modal Transportation Center and forward to the TAC for consideration. Ms. Harrington seconded the motion and it carried with 15 members voting in favor of the resolution. Mr. Waring voted in opposition.

Mr. Kozlosky told members that staff will be discussing organizational Improvements for the WMPO with TAC members at their January meeting. Staff will gauge their interest in the possibility of holding a retreat to discuss details for updating the MPO's Strategic Business Plan.

Mr. Kozlosky noted that staff has been working on a SWOT analysis and customer survey to help identify ways to better improve the organization. Staff will present the survey to TAC members for review and approval prior to releasing it to the TAC, TCC and the member's various boards. He said the survey will be sent to the entities who interact with the WMPO's staff, and not the general public.

## b. 2016 TAP-DA Allocation

Mr. Kozlosky told members that staff will be asking that the TAP-DA funds be carried forward and the funds rolled over to FY17 in order to allow for a larger amount of funds available for a call for projects.

# c. Current Funded STP-DA and TAP-DA Projects

Mr. Knight told members that he will be contacting staff members from the municipalities who have STP-DA and TAP-DA projects in an effort see what can be done the get these projects moving forward at a faster pace in order to meet project funding timelines.

### d. 2016 Wilmington MPO Legislative Agenda

Mr. Kozlosky reviewed the proposed 2016 legislative agenda. He noted that 3 of the 4 items are carry-overs from previous years. The only new item on the agenda is regarding the Moped Legislation. Staff will be present the agenda to the TAC at their next meeting.

#### e. Southport-Ft. Fisher Ferry Rates

Mr. Kozlosky told members that in 2014 the MPO adopted a resolution supporting an increase in ferry tolls for the Ft. Fisher to Southport Ferry. He noted that some of the ferry tolls in North Carolina are in administrative code and some are adopted by the NC Board of Transportation by resolution. The Department is pursuing having all of the ferry tolls adopted by the Board of Transportation by resolution.

Mr. Kozlosky stated that in 2014 the TAC requested an increase in ferry tolls. Based on state law, NCDOT had 180 days to implement that increase but they did not. They are now asking if the MPO still supports the increase in the tolls. The Department is asking the Board of Transportation to adopt their resolution for ferry tolls in February. That will move everything to being adopted by the Board of Transportation by resolution, and then, if there is still support for the increase, staff would bring that back for re-affirmation by the TAC.

Mr. Serkin asked if it's true that the fares collected for the Ft. Fisher to Southport Ferry stay in an account dedicated to improvements for this ferry. Mr. Kozlosky said yes, staff confirmed with NCDOT attorneys that the will stay here.

Mr. Kozlosky told members that House Bill 97 accelerated funding for several projects. These are administrative modifications for projects that were already in the STIP and are being accelerated. They do not require a 30-day public comment period.

# **Transportation Financing**

The Wilmington MPO supports prioritization and funding for local transportation and infrastructure projects and to explore new transportation and infrastructure revenue sources to address the growing needs of the state and the nation. Including, but not limited to road and highway projects, public transportation, bicycle and pedestrian infrastructure, beach nourishment, waterway maintenance, port infrastructure, airports, etc.

### **Moped Legislation**

The Wilmington MPO supports the North Carolina Department of Transportation's policy recommendation of restricting mopeds on public roadways with posted speed limits of 45 mph or greater. The MPO also encourages the North Carolina General Assembly to implement laws that regulate the use of mopeds in a manner that promotes the safety and welfare of the citizens and visitors of North Carolina and pursue education and clarity on existing regulations for mopeds, golf carts, and low-speed vehicles.

# **Corridor Preservation**

The Wilmington MPO requests the General Assembly continue support for corridor preservation to protect vital Transportation Corridors in the state of North Carolina.

#### **Opposition to Transfer of State Road Maintenance**

The Wilmington MPO respectfully and urgently requests the North Carolina General Assembly reject proposals which would transfer responsibility for large portions of the state's road system to local governments, and weaken or dismantle municipal Powell Bill Street maintenance funding.

# MEMORANDUM OF UNDERSTANDING FOR

# COOPERATIVE, COMPREHENSIVE, AND CONTINUING TRANSPORTATION PLANNING

## AMONG

THE CITY OF WILMINGTON, TOWN OF CAROLINA BEACH, TOWN OF KURE BEACH, TOWN OF WRIGHTSVILLE BEACH, COUNTY OF NEW HANOVER, TOWN OF BELVILLE, TOWN OF LELAND, TOWN OF NAVASSA, COUNTY OF BRUNSWICK, COUNTY OF PENDER, CAPE FEAR PUBLIC TRANSPORTATION AUTHOTIRY AND THE NORTH CAROLINA DEPARTMENT OF TRANSPORTATION

#### IN COOPERATION WITH THE UNITED STATES DEPARTMENT OF TRANSPORTATION

### WITNESSETH

**WHEREAS**, Each MPO is required to develop a comprehensive transportation plan in cooperation with NCDOT and in accordance with 23 U.S.C., Section 134, any subsequent amendments to that statute, and any implementing regulations; and Chapter 136, Article 3A, Section 136-66.2(a) of the General Statutes of North Carolina,

# WHEREAS, the said Chapter 136, Article 3A, Section 136-66.2(b) provides that:

"After completion and analysis of the plan, the plan shall be adopted by both the governing body of the municipality or MPO and the Department of Transportation as the basis for future transportation improvements in and around the municipality or within the MPO. The governing body of the municipality and the Department of Transportation shall reach agreement as to which of the existing and proposed streets and highways included in the adopted plan will be a part of the State highway system and which streets will be a part of the municipal street system. As used in this Article, the State highway system shall mean both the primary highway system of the State and the secondary road system of the State within municipalities;" and,

# WHEREAS, the said Chapter 136, Article 3A, Section 136.66.2(d) provides that:

"For MPOs, either the MPO or the Department of Transportation may propose changes in the plan at any time by giving notice to the other party, but no change shall be effective until it is adopted by both the Department of Transportation and the MPO;" and

**WHEREAS**, a transportation planning process includes the operational procedures and working arrangements by which short and long-range transportation plans are soundly conceived and developed and continuously evaluated in a manner that will:

- 1. Assist governing bodies and official agencies in determining courses of action and in formulating attainable capital improvement programs in anticipation of community needs; and
- 2. Guide private individuals and groups in planning their decisions which can be important factors in the pattern of future development and redevelopment of the area; and

**WHEREAS**, it is the desire of these agencies that a previously established continuing, comprehensive, cooperative transportation planning process as set forth in a Memorandum of Understanding dated the 6<sup>th</sup> day of August 2007 be revised and updated to comply with 23 U.S.C. 134; any subsequent amendments to that statute, and any implementing regulations; and

**WHEREAS**, the effective date of this document shall be the date on which it was signed by the Governor of the State of North Carolina or his/her designee.

**NOW THEREFORE BE IT RESOLVED** by the Wilmington Urban Area Metropolitan Planning Organization which will serve as the Metropolitan Planning Organization for the Wilmington Urban Area that the following Memorandum of Understanding (MOU) is made:

:

SECTION 1. It is hereby agreed that the municipalities of City of Wilmington, Town of Carolina Beach, Town of Kure Beach, Town of Wrightsville Beach, Town of Belville, Town of Leland, Town of Navassa, the Counties of Brunswick, New Hanover and Pender, Cape Fear Public Transportation Authority and the North Carolina Department of Transportation, in cooperation with the United States Department of Transportation, will participate in a continuing, coordinated, comprehensive transportation planning process with the responsibilities and undertakings as outlined in the following paragraphs:

- A. The Wilmington Urban Area Metropolitan Planning Organization's planning area will consist of the Wilmington Urbanized Area as defined by the United States Department of Commerce, Bureau of the Census, in addition to that area beyond the existing urbanized area boundary that is expected to become urban within a twenty-year planning period. This area is hereinafter referred to as the Metropolitan Planning Area.
  - B. The Wilmington Urban Area Metropolitan Planning Organization's planning, hereinafter referred to as the Wilmington Urban Area MPO, shall include the local governments of the Municipalities and the Counties, Cape Fear Public Transportation Authority and the North Carolina Department of Transportation, a Board hereinafter defined, a Technical Coordinating Committee hereinafter defined, and the various agencies and units of local and State government participating in the transportation planning for the area.
- C. The Wilmington Urban Area MPO is an organization that is funded through federal, state and local funds to conduct transportation planning in a continuing, cooperative and comprehensive manner. The Wilmington Urban Area population has exceeded 200,000 and in July 2012 the Federal Highway Administration designated the Wilmington Urban Area as a Transportation Management Area (TMA). This new designation provides for additional requirements. Along with the TMA designation, the additional requirements include the completion and monitoring of a Congestion Management Process, official FHWA/FTA Certification process, additional federal and reporting requirements and the administration of Surface Transportation Block Grant Program.
- D. The continuing transportation planning process will be a cooperative one, and all planning discussions will be reflective of and responsible to the comprehensive plans for growth and development of the Metropolitan Planning Area.
- E. The continuing transportation planning process will be conducted in accordance with the intent, procedures, and programs of Title VI of the Civil Rights Act of 1964, as amended.

- F. The Urbanized Area Boundary and the Metropolitan Planning Area shall be periodically reviewed and revised in light of new developments and basic data projections.
- G. Transportation plans, programs and data collection will be coordinated with the Lead Planning Agency for the adjacent Rural Planning Organization and shall be conducted according to applicable interagency agreements.

# H. Wilmington Urban Area Metropolitan Planning Organization Board Established

The Wilmington Urban Area MPO Board [hereinafter referred to as "Board" or "the Board"] is hereby established with the responsibility for cooperative transportation planning decision making for the Wilmington Urban Area MPO. The Board shall have the responsibility for keeping the policy boards of the participating local governments informed of the status and requirements of the transportation planning process; for assisting in the dissemination and clarification of the decisions and policies of the policy boards; and for providing opportunities for citizen participation in the transportation planning process.

The Board, in cooperation with the State, and in cooperation with publicly owned operators of mass transportation services, shall be responsible for carrying out the urban transportation planning process specified in the U. S. Department of Transportation Program Manuals and shall develop the planning work program, Metropolitan Transportation Plan, and Transportation Improvement Program as specified in such manuals.

This shall be the forum for cooperative decision-making by elected officials of the member local governments. However, this shall not limit the Board's local responsibility for insuring that the transportation planning process, plans and improvement projects which emerge from that process are consistent with the policies and desires of local government. This shall also serve as a forum for the resolution of conflicts which arise during the course of developing the Metropolitan Transportation Plan and the Transportation Improvement Program.

# I. Board Membership

The Wilmington Urban Area MPO Board will consist of the Chief Elected or other elected representative(s) from the following Local Government as well as the appointed member from the North Carolina Board of Transportation. Each agency will have a single representative except as indicated below:

- 1. Two members of the Wilmington City Council;
- 2. One member of the Carolina Beach Town Council;
- 3. One member of the Kure Beach Town Council:
- 4. One member of the Wrightsville Beach Board of Alderman;
- 5. One member of the New Hanover County Board of Commissioners;
- 6. One member of the Belville Board of Commissioners;
- 7. One member of the Leland Town Council:
- 8. One member of the Navassa Town Council;
- 9. One member of the Brunswick County Board of Commissioners;
- 10. One member of the Pender County Board of Commissioners;
- 11. One member of the Cape Fear Public Transportation Authority (New Hanover County Representative);
- 12. One member of the North Carolina Board of Transportation;

Each of the above member agencies may also appoint an alternate, in accordance with the rules contained within the Wilmington Urban Area MPO Bylaws. If alternates attend meetings where the primary representative is present, only the primary representative(s) shall be counted for voting purposes as specified in the Bylaws.

Representatives from each of the following bodies will serve as non-voting members of the Board.

- Federal Highway Administration (North Carolina Division Administrator, or his designee)
- Cape Fear Council of Governments
- North Carolina State Ports Authority
- New Hanover County Airport Authority
- North Carolina Turnpike Authority

At the invitation of the Board, other local, regional, State, or Federal agencies impacting transportation within the Planning Area may serve as advisory, non-voting members of the Board. The Executive Director will serve as secretary to the Board.

### J. Board Duties.

The duties and responsibilities of the Board are as follows:

- 1. Establish **mission, goals and objectives** for the transportation planning process reflective of and responsive to comprehensive plans for growth and development in the Metropolitan Planning Area adopted by Boards of General Purpose Local Government.
- 2. Review and approve a **Prospectus** for transportation planning which defines work tasks and responsibilities for the various agencies participating in the transportation planning process.
- 3. Review and approve changes to the **Urbanized Area Boundary** and the **Metropolitan Planning Area** as well as review and recommend changes to the **National Highway System** and the Federal Functional Classification System in conformance with Federal regulations.
- 4. Review and approve the transportation **Unified Planning Work Program**.
- 5. Review and approve the **Metropolitan Transportation Plan** and adopt the **Comprehensive Transportation Plan** pursuant to G.S. 136-66.2. The Comprehensive Transportation Plan shall be mutually adopted by the Board and the State of North Carolina.
- 6. Develop and Approve the **Metropolitan Transportation Improvement Program** (MTIP).
- 7. Develop prioritized needs list (PNL) for transportation improvements in conjunction with development of the MTIP. This list represents candidate projects for inclusion in the MTIP.

- 8. Review and approve related **air quality planning** in conformance with Federal regulations.
- 9. Distribute funds distributed directly to MPO's under the provisions of the FAST Act and any subsequent re-authorization of the FAST Act.
- 10. The Wilmington Urban Area MPO is responsible for ensuring that their planning process is being carried out in accordance with applicable Federal requirements as outlined in 23 CFR 334.
- 11. The Wilmington Urban Area MPO shall be responsible for the development and implementation of a performance-based transportation planning process; including the establishment of measures, metrics, targets, the processes for the collection of performance based data, and for identifying the roles and responsibilities for the performance-based planning process.
- 12. Develop, approve, and implement a **Public Involvement Policy.**
- 13. The Wilmington Urban Area MPO shall have the primary responsibility for citizen input into the continuing transportation planning process.
- 14. The Wilmington Urban Area MPO is responsible for conducting public involvement and technical analysis to determine preliminary alignments for all modes of transportation included in the MTP and CTP. These alignments will be used by the MPO and local jurisdictions through their land development ordinances for right of way protection purposes. Once the Wilmington Urban Area MPO has adopted an official alignment, it can be modified only by the official action of the Board. The Wilmington Urban Area MPO adopts the alignment for right of way purposes even if the alternatives are produced through a State or locally funded environmental study process. Adoption of any alignment shall not predetermine a corridor through the state and federal environmental review processes.
- 15. Develop and approve committee **Bylaws** governing operating policies and procedures. Through the Bylaws, the Board may establish subcommittees and may delegate duties of planning and analysis to these subcommittees as outlined in Section M. below.
- 16. **Self-Certify** the Long-Range Planning Process.
- 17. Conduct any other duties identified as necessary to further facilitate the transportation planning process.

# J. Board Voting Policy

1. Voting representatives of the Municipalities and the Counties shall be designated by their respective governing boards. A quorum is required for the transaction of all business, including conducting meetings or hearings, participation in deliberations, or voting upon or otherwise transacting the public business. A quorum consists of fifty-one percent (51%) of the voting members of the Board, plus as many additional members as may be required to ensure that fifty-one percent (51%) of the total votes are present.

2. Each member shall receive one vote. A simple majority of the members present shall determine all issues.

# K. Metropolitan Transportation Improvement Program (MTIP) Development

- 1. The Metropolitan Transportation Improvement Program (MTIP) shall be adopted in accordance with adoption schedules for the State Transportation Improvement Program (STIP). The MTIP shall include all information typically contained in the STIP, including, but not limited to route number, project I.D. number, project limits, project description, proposed implementation schedule, funding source, and projected cost. The MTIP is intended to represent local priorities for transportation improvements. Once it is adopted, any discrepancies between the MTIP and the STIP will be negotiated through established State and Federal processes.
- 2. For the purpose of implementing its transportation priorities, the Board may develop a supplement to the MTIP containing descriptions of project design. Design information for a particular project will be included in the supplement on an as needed basis at the request of member jurisdictions. For roadway projects, the information may include the preferred alignment, the number of lanes, the inclusion of medians, and the extent and location of pedestrian and bicycle facilities. Other design information will be included in the supplement as needed to establish the general parameters of project design. The supplement shall serve as a planning document to guide MTIP development, and shall be amended as needed. Generally, project design information will not be included in the supplement until a project has completed the NEPA process, design public hearing process, or any other required public involvement process.

# L. Project Prioritization

The Board shall develop a list of projects for transportation improvements in conjunction with the NCDOT prioritization process as codified in NCGS § 136–18.42. This entails preparing a list of projects to evaluate against NCDOT's quantitative measures, then choosing a subset of projects. The subset of projects chosen will be assigned points by the Board based on locally and regionally developed criteria and submitted to NCDOT and the Wilmington Urban Area MPO Board to compete for available funding in the STIP and MTIP, respectively.

### M. Board Subcommittees

The Board may establish subcommittees and advisory groups through its bylaws or through a vote at a regularly scheduled meeting. The subcommittees may consist of existing members of the Board, the Technical Coordinating Committee, and other officials and citizens as appropriate to achieve the objectives of the subcommittee. Subcommittees may include, but are not limited to the following groups: Bicycle and Pedestrian Advisory Committee, Citizen Advisory Committee, Transportation Demand Committee and others. Further, the Wilmington Urban Area MPO Board shall allow these groups to establish their own bylaws, meeting schedule, and elected officers. The purpose of the subcommittees will be to provide analysis and recommendations to the Board.

# N. Transit Planning and Programming

The Wilmington Urban Area MPO will coordinate transit planning and programming within the Metropolitan Planning Area. The duties and responsibilities of the Board with regard to transit planning and programming are as follows:

- 1. Establish policies for distribution of federal mass transit funds that are provided directly to the Metropolitan Planning Organization. These policies will be reviewed and approved annually by the Board
- 2. Develop and approve a list of prioritized projects for transit improvements.
- 3. Program transit improvements in the Metropolitan Transportation Improvement Program (MTIP).

In developing transit plans, programs, and funding formulas, the Board shall consider the following factors: federal mass transit funding formulas, population served by the transit system, ridership, and present and future demand for transit service.

# O. Technical Coordinating Committee Established

A Technical Coordinating Committee, hereinafter referred to as the TCC, shall be established with the responsibility of general review, guidance, and coordination of the transportation planning process for the Metropolitan Planning Area and with the responsibility for making recommendations to the respective local and State governmental agencies and the Board regarding any necessary actions relating to the continuing transportation planning process. The TCC shall be responsible for development, review, and recommendation for approval of goals and objectives, the Prospectus, Unified Planning Work Program (UPWP), Urbanized Area Boundary, Metropolitan Planning Area, National Highway System, Metropolitan Transportation Plan, Comprehensive Transportation Plan, Metropolitan Transportation Improvement Program (MTIP), Priority Needs List (PNL), air quality planning, distribution of directly allocated funds, public involvement, and any other duties identified as necessary to facilitate the transportation planning process.

Membership of the TCC shall include technical representation from all local and State governmental agencies directly related to and concerned with the transportation planning process for the planning area. Membership to the TCC may be altered on the basis of a majority vote of its membership, provided that any party may appeal decisions regarding TCC membership changes to the Board. The initial TCC voting membership shall include, but not be limited to the following:

- 1. MPO Executive Director, Wilmington Urban Area MPO
- 2. Transportation Demand Management Coordinator; Wilmington Urban Area MPO
- 3. Traffic Engineer, City of Wilmington;
- 4. Assistant Town Manager, Town of Carolina Beach;
- 5. Town Clerk, Town of Kure Beach;
- 6. Director of Planning and Parks, Town of Wrightsville Beach;
- 7. Director, New Hanover County Planning Department;
- 8. Deputy Director, Wilmington International Airport;
- 9. Planner, North Carolina State Ports Authority;
- 10. Director, Cape Fear Public Transportation Authority
- 11. Town Administrator, Town of Belville;
- 12. Planning Director, Town of Leland (Alternate Town Manager)
- 13. Town Planning Administrator, Town of Navassa;
- 14. Director, Brunswick County Planning Department;

- 15. Director, Pender County Planning Department;
- 16. Planning Director, Cape Fear Council of Governments;
- 17. Division Engineer, Division of Highways, North Carolina Department of Transportation;
- 18. Wilmington Urban Area Coordinator, Transportation Planning Branch, North Carolina Department of Transportation;

Representatives from each of the following bodies will serve as non-voting members of the Technical Coordinating Committee.

- 19. Director of Department of Planning, Development and Transportation Services, City of Wilmington;
- 20. Assistant Manager, New Hanover County;
- 21. Division Construction Engineer, Division of Highways, North Carolina Department of Transportation;
- 22. Planning, Development and Transportation Director, City of Wilmington
- 23. Division Traffic Engineer, Division of Highways, North Carolina Department of Transportation;
- 24. Transit Planner, Public Transportation Division, North Carolina Department of Transportation;
- 25. District Engineer, North Carolina Division, Federal Highway Administration, United States Department of Transportation;
- 26. Transportation Planner, North Carolina Division, Federal Highway Administration, United States Department of Transportation (Advisory and non-voting);
- 27. General Manager, Brunswick Transit Systems
- 28. Director, Pender Adult Services

Each TCC member shall have one vote. Through the Wilmington Urban Area MPO's bylaws, the TCC may designate other local agencies, organizations, or individuals as voting and non-voting members of the TCC.

A quorum is required for the transaction of all business, including conducting meetings, participation in deliberations, or voting upon or otherwise transacting the public business. A quorum consists of fifty-one percent (51%) of the voting members of the TCC.

The Board may establish subcommittees and advisory groups through the bylaws or through a vote at a regularly scheduled meeting. The purpose of the subcommittees will be to provide analysis and recommendations to the TCC and Board.

The TCC shall operate as determined by the Wilmington Urban Area MPO's adopted bylaws. Any agency not listed above which wishes representation on the TCC may request such representation for consideration.

**SECTION II**. It is further agreed that the subscribing agencies will have the following responsibilities:

# The Municipalities and Counties

The Municipalities and the Counties will assist in the transportation planning process by providing assistance, data and inventories in accordance with the Prospectus. The Municipalities and the Counties shall be responsible for any zoning and subdivision approvals that are impacted by adopted Transportation Plans. The City of Wilmington will serve as the Lead Planning Agency for the Wilmington Urban Area MPO.

# **North Carolina Department of Transportation**

The Department will assist in the transportation planning process by providing planning assistance, data and inventories in accordance with the Prospectus.

**SECTION III.** The rules contained in the current edition of Robert's Rules of Order, Newly Revised, shall govern the Board in all cases to which they are applicable and in which they are not inconsistent with this "Memorandum of Understanding", the bylaws and/or any special rules of order the Board may adopt.

**SECTION IV.** The Board by a majority vote may invite other municipalities located within the Metropolitan Planning Area Boundary to join the MPO. The municipality may join the MPO by agreeing to become party to this MOU by signing an Addendum to this MOU authorized by appropriate and proper resolution of the municipality to sign the Addendum. The Addendum shall become part of this MOU and shall be distributed to all parties to this MOU.

**SECTION V.** All transportation and related federal aid planning grant funds available to promote the comprehensive transportation planning process will be expended in accordance with the Unified Planning Work Program adopted by the Board. These funds require a twenty percent (20%) Local Match. Parties to this Memorandum of Understanding agree to fund the Local Match in an amount in direct proportion to their share of the total population contained in the approved Metropolitan Area Boundary. Population figures for determination of Local Match contribution shall be determined based on the most recent Federal decennial Census. Member governments may be asked to contribute additional local funding for projects.

This funding share shall be invoiced on a regular basis by the City of Wilmington, acting as Lead Planning Agency, and as recipient of the Federal Planning funds distributed by the North Carolina Department of Transportation.

**SECTION VI.** This Amended Memorandum of Understanding supersedes and replaces any prior memorandum(s) of understanding between the parties regarding the Wilmington Urban Area MPO.

**SECTION VII.** Parties to this Memorandum of Understanding may terminate their participation in the continuing transportation planning process of the MPO by giving (60) days written notice to the other parties prior to the date of termination. When annexation occurs and member municipality boundaries extend beyond the adopted urbanized area boundary, the new boundaries will automatically become part of the urbanized area. It is further agreed that these agencies will assist in the transportation planning process by providing planning assistance, data, and other requested information. Additionally, these agencies shall coordinate zoning and subdivision approval in accordance with the adopted Transportation Plan(s). All files, records and planning maps and documents will remain the property of the MPO.

**SECTION VIII.** In witness whereof, the parties of this Memorandum of Understanding have been authorized by appropriate and proper resolutions to sign the same, the City of Wilmington by its mayor, the Town of Carolina Beach by its mayor, the Town of Kure Beach by its mayor, the Town of Wrightsville Beach by its mayor, New Hanover County by its chairman of the Board of Commissioners, the Town of Belville by its mayor, the Town of Leland by its mayor, the Town of Navassa by its mayor, Brunswick County by its chairman of the Board of Commissioners, Pender County by its chairman of the Board of Commissioners, the Cape Fear Public Transportation Authority by its Chairman and the

# BYLAWS WILMINGTON URBAN AREA TRANSPORTATION ADVISORY COMMITTEE

# **ARTICLE I – NAME**

The name of this organization shall be the Wilmington Urban Area Transportation Advisory Committee, hereinafter referred to as the "TAC".

# **ARTICLE II – PURPOSE**

The purposes of the TAC are outlined in the most recent "Memorandum of Understanding" approved by the appropriate local governments.

# <u>ARTICLE III – MEMBERS</u>

<u>Section I – Number of Qualifications</u>: The TAC shall consist as specified in the "Memorandum of Understanding". The eligible voting member list consists of a representative from each of the appropriate boards with the City of Wilmington having two representatives.

<u>Section II – Terms of Office</u>: All elected representatives serving on the TAC may serve for the length of their elected terms. A member may serve successive terms.

<u>Section III – Alternates</u>: Each of the appropriate boards shall designate all members of their governing board who are not members of the TAC as alternate members of the TAC. In the event that a member is unable to attend, that member or the chief elected officer of that jurisdiction will designate an alternate to attend and participate in the member's absence. That alternate member may serve as a full voting member during any meeting where one of that board's representatives is not in attendance. Proxy and absentee voting are not permitted.

# <u>ARTICLE IV – OFFICERS</u>

<u>Section I – Officers Defined</u>: The TAC shall, upon majority vote of its membership, appoint one voting member of the Committee to act as Chairman and one voting member to act as Vice-Chairman. A member of the staff of the City of Wilmington Development Services Department will serve as Secretary to the Committee.

<u>Section II – Duties</u>: The Chairman shall call and preside at meetings and appoint committees. In absence of the Chairman, the Vice-Chairman shall preside and complete all duties of the Chairman.

<u>Section III – Elections</u>: The Chairman and Vice-Chairman shall be elected annually by the voting members of the TAC, with their terms to begin at that meeting. In the event that there is no Chairman or Vice-Chairman, the TCC Chairman shall preside until a Chairman and Vice-Chairman are elected. The Chairman and Vice-Chairman shall serve for a period of one (1) year from their election and may be re-elected.

# **ARTICLE V - MEETINGS**

<u>Section I – Meetings:</u> Regular schedules will be adopted by the TAC at the first meeting of the calendar year. If there is insufficient reason for a regularly scheduled meeting, as determined by the Chairman, the Secretary will notify TAC members of the meeting's cancellation. Meetings shall be conducted under parliamentary procedures consistent with <u>Robert's Rules of Order</u>.

A Special or Emergency meeting is a separate session of society held at a time different from that of a regular meeting, and convened only to consider one or more items of business specified in the call of the meeting. Notice of the time, place and exact purpose of the meeting must be mailed to all members a reasonable number of days in advance. The reason for the special or emergency meeting is to deal with important matters that may arise between regular meetings and that urgently require action by the society before the next regular meeting. As in the case of a regular meeting, the session of a special or emergency meeting in an ordinary society is normally concluded in a single meeting, unless the assembly at the special meeting schedules an adjourned meeting.

<u>Special Meetings</u> – The Chairman or a majority of board members may at any time call a special meeting of the Committee by signing a notice stating the time and place of the meeting and the subjects to be discussed. The person or persons calling the meeting shall cause the notice to be posted at City Hall in downtown Wilmington or the door of the regular meeting place at least forty-eight hours before the meeting. In addition, the notice shall be e-mailed or mailed to individuals and news organizations. Only items of business specified in the notice may be transacted at a special meeting.

Emergency Meetings- If a special meeting is called to deal with an unexpected circumstance requiring immediate consideration, the notice requirements of this rule do not apply. However, the person or persons calling an emergency meeting shall take responsible action to inform the other board members and the public of the meeting. Local news organizations having requested notice of the special meetings shall be notified of such emergency meetings by the same method

used to notify the board members. Only business connected to the emergency may be discussed at this meeting.

Section II- TAC Sub-Committees: The Transportation Advisory Committee may create Sub-Committees to assist with forwarding the mission and goals of the Wilmington MPO. These Sub-Committees shall be created by a formal vote of the Transportation Advisory Committee. The notice of Sub-Committee meetings shall be posted at City Hall in downtown Wilmington or the door of the regular meeting place at least forty-eight hours before the meeting. In addition, the notice shall be e-mailed or mailed to all Transportation Advisory Committee members and news organizations.

<u>Section III– Quorums and Majority Vote:</u> A quorum is required for the transaction of all business, including conducting meetings or hearings, participating in deliberations or voting upon or otherwise transacting public business. A quorum consists of 51% of the members of the TAC, plus as many additional members as may be required to ensure that 51% of the possible votes are present.

<u>Section IV– Attendance</u>: Each member shall be expected to attend each scheduled meeting.

# **ARTICLE VI – VOTING PROCEDURES**

<u>Section I – Majority Votes</u>: Any member may call for a vote on any issue provided that it is seconded and within the purposes set forth in the "Memorandum of Understanding." Each voting member of the TAC shall have one vote, and a majority vote of those present and voting shall constitute approval of any motion, provided a quorum exists. Abstentions are not included in the tally of the votes. Proxy and absentee voting are not permitted.

Section II – Agenda: The agenda is the list of items suggested for discussion at a TAC meeting. Agenda items originate as a carry-over from previous meetings, are placed on the agenda prior to its distribution by any member of the TAC, by request from any jurisdiction party to the "Memorandum of Understanding," or by the request of a member of the Technical Coordinating Committee (TCC). TCC and TAC members may submit an item(s) to their respective TCC and TAC agendas. In order for a Board member to submit an item(s) to the TCC or TAC, the item(s) must be submitted no later than 5:00 p.m. the first business day of the calendar month in which the item is requested to be considered. The item must include all pertinent background materials (resolution, maps, etc.). The TAC shall approve the agenda at the beginning of each meeting. At this time, the TAC shall have the ability to add or remove any item on the agenda by a majority vote of the TAC's voting members present. An item added to the agenda will may also be placed on the agenda for consideration at the end of the meeting. by a majority vote of the voting members present.

### ARTICLE VII – AMENDMENTS TO BYLAWS

Amendments to these Bylaws of the TAC shall require the affirmative vote of at least two-thirds (2/3) of the eligible voting members, provided that written notice of the proposed amendment has been received by each member at least seven (7) days prior to the meeting at which the item is to be considered and provided that such amendment does not conflict with the letter or the fundamental intent of the "Memorandum of Understanding" governing this document.- In the event of any conflict, the "Memorandum of Understanding" shall carry precedence over these Bylaws.

#### **Project Description**

Roadway extending from the vicinity of US 17 Bypass and I-140 in Brunswick County to US 421 in New Hanover County, including a crossing of the Cape Fear River.

#### **Current Status**

The following list includes completed and ongoing tasks during the month of January:

- The project team continues to coordinate and correspond with project stakeholders.
- Functional Design Plans for the 12 detailed study alternatives (DSAs) have been reviewed by NCDOT; the project team is currently working on revising the designs.
- Hydraulic analysis of the DSAs is ongoing.
- Hurricane evacuation modeling of the DSAs is ongoing.
- The Historic Architecture Eligibility Report has been accepted by NCDOT and reviewed by the North Carolina State Historic Preservation Office (SHPO). NCDOT is currently working with SHPO to determine what resources within the project study area are eligible for listing on the National Register of Historic Places.
- Studies for the Traffic Noise Analysis and Air Quality Analysis are ongoing.
- An update to the Draft Natural Resources Technical Report is ongoing.
- Draft utility plans and relocation estimates have been prepared and are under review by NCDOT.
- NCDOT is currently evaluating an additional alternative proposed by the WMPO near the Port of Wilmington. There
  are currently 12 alternatives being designed and evaluated for inclusion in the draft environmental document.
   NCDOT is coordinating with the NCSPA regarding this alternative; if it is determined this alternative is reasonable,
  studies may need to be redone to include this alternative.
- The Cape Fear Crossing project is programmed in the 2016-2025 STIP for planning and environmental studies only using STPDA funding from the Wilmington MPO.
- The project team will plan to present the status of the project to the WMPO TAC before the next NEPA/Section 404 Merger Team Meeting.

# WILMINGTON MPO TRANSPORTATION PLANNING FEBRUARY 2016

#### **CONGESTION MANAGEMENT PROCESS**

Project Description/Scope: Comply with a Federal mandate to create and adopt a process to evaluate the region's most congested corridors through locally-defined multi-modal performance measures in an effort to suggest improvements that would alleviate traffic congestion in the region. The CMP was adopted by the TAC on December 11, 2013. Data collection procedures have been developed. A schedule for collection logistics has been drafted and data collection will continuously be monitored and updated as needed.

#### **Next Steps:**

- Continue data collection and monitoring of congestion
- Document data collection in a Biennial Report

#### **COLLEGE ROAD UPGRADES (U-5702), (U-5704) and (U-5792)**

**Project Description/Scope:** The Strategic Transportation Investments is a new formula to determine how the North Carolina Department of Transportation (NCDOT), in partnership with local governments, will fund and prioritize transportation projects in the state of North Carolina. The Strategic Transportation Investment Formula allocates funding at the statewide, regional and division tiers. Prioritization 3.0 was the process used to determine the projects that are to be funded in the State's Transportation Improvement Program (STIP). The adopted 2016-2025 State Transportation Improvement Program includes several projects on College Road.

U-5704: Construction of an interchange at College Road and Oleander Drive

U-5702: Construction of Access Management Improvements on College Road between Gordon Road and Carolina Beach Road. The Department has several spot safety and intersection improvements that are anticipated would be completed under this project. This project may also include median modifications, access management strategies, etc. to improve traffic flow and safety on College Road. Another project that may be funded in the Statewide Mobility Category is an Upgrade of College Road between New Centre Drive and Gordon Road to include an additional through lane and an interchange at College Road and the Martin Luther King Jr. Parkway.

U-5792: Convert at-grade intersection to interchange

#### **Next Steps:**

• Complete Planning, Environmental Review and Design for the projects

#### **METROPOLITAN TRANSPORTATION PLAN**

Project Description/Scope: Update the Federally-mandated Metropolitan Transportation Plan/Long-Range Transportation Plan for the Wilmington Urban Area Metropolitan Planning Organization. The draft plan was finalized by the Transportation Advisory Committee on July 22, 2015. The plan has now been adopted by all Wilmington Urban Area Metropolitan Planning Organization member jurisdictions. The TAC adopted the plan on November 18, 2015.

Next Steps:

- Implementation of the plan
- Develop a Strategic Business Plan

#### MILITARY CUTOFF ROAD/EASTWOOD ROAD (U-5710)

**Project Descriptions/Scope:** The adopted 2016-2025 State Transportation Improvement Program identified funding to upgrade the intersection of Military Cutoff Road/Eastwood Road to an interchange. HDR has been selected by NCDOT to complete this work. The Department is evaluating several alternatives to include a single point urban interchange, at-grade quadrant, continuous flow intersection, etc.

#### 17<sup>™</sup> STREET STREETSCAPE

**Project Descriptions/Scope:** The 17<sup>th</sup> Street streetscape project will include upgrades to 17<sup>th</sup> Street between Wrightsville Avenue and Princess Place Drive. The project will provide for a more efficient transportation system by reduced travel speeds, removal of the lateral shift, improved pedestrian crossings, improved safety and enhance the aesthetics of the area. The project may also include aesthetic improvements that will enhance the entryway into Carolina Heights and provide a pocket park. The project had a bid opening planned on September 24<sup>th</sup> however the bid exceeded budget. The project was advertised for re-bid on January 27<sup>th</sup>.

#### TRANSPORTATION DEMAND MANAGEMENT PROGRAM

The MPO adopted "Work Cape Fear: Expanding Commuter Options in the Cape Fear Region" TDM Short Range Plan on January 28, 2015 and also authorized staff to apply for a TDM grant through NCDOT that if approved would fund a full-time TDM Coordinator position. The Agreement with NCDOT for the full-time TDM Coordinator position was approved on November 4, 2015. The Wilmington MPO has hired a full-time TDM Coordinator.

#### MAYOR'S RAIL RE-ALIGNMENT TASK FORCE

The City of Wilmington has appointed a Mayor's Task Force to evaluate the feasibility of re-aligning the rail line that currently traverses the City of Wilmington and potentially re-purpose this rail line for another use. This project is jointly funded by the City of Wilmington and Wilmington MPO. It is anticipated that NCDOT will also contribute towards the completion of the study. On January 21<sup>st</sup>, the City released a Request for Proposals for a consultant to complete the feasibility study. Proposals are due back to the City on February 24<sup>th</sup>.

# Cape Fear Public Transportation Authority Project Update February 2016

- 1. Bus fleet replacement & conversion to CNG (no significant change) identifying state and federal funding opportunities to replace 19 thirty-five foot buses. Bid awarded to Gillig, LLC on June 26, 2014. Two buses delivered in June 2015. One CNG shuttle delivered in August 2015. Four buses delivered in February 2016. The most recent four buses will allow additional fuel savings due to volume. The effective new rate will be 0.162¢ per gallon plus delivery fee and electricity to compress the gas. The final rate will be significantly lower than the historically low current rate of 0.96¢ per gallon of diesel. CNG also emits significantly less CO2 and particulate matter than diesel.
- 2. Wilmington Multimodal Transportation Center Interlocal Agreement between Authority, City of Wilmington, WMPO and NCDOT finalized. Relocation of U-Haul tenants complete and demolition waiting final approval from Wilmington Historic Preservation Commission on 02/11/2016. Project awarded \$2.4M in STP-DA funding from WMPO TAC on January 27, 2016. Historic building stabilization to occur soon after U-Haul demolition. Design and construction of downtown transfer center to begin in spring 2016. Current target date for completion of project is winter 2017.
- 3. Short Range Transportation Plan Following adoption of Cape Fear Transportation 2040 by the Wilmington Metropolitan Planning Organization (WMPO), Wave Transit is preparing to begin its latest short range plan. The plan will set a course for public transportation initiatives, route structure and revenue programming for the next five years. The plan will also encompass a financial element to ensure that transit programs are compliant with FTA rules and regulations.
  Under the direction of the Authority's Operations and Planning Committee made up of Board members, staff, WMPO planners, passengers, interested citizens, and professional transit planning consultants, the 12-18 month plan is an important tool in meeting the public transportation needs of the community. Marketing, public relations and community support for financing transit in Southeastern North Carolina will also be a focus of the plan. A key component of the plan will be extensive surveying to assess the needs of current and prospective passengers.
- **4.** Long Term Funding an initiative to analyze long term revenue stability of Wave Transit has also been proposed by the City of Wilmington. This effort is critical to the long term financial health of the Authority which currently has no source of dedicated funding. No timetable for the analysis has been developed.
