1. Call to Order

Mr. Barfield called the meeting to order at 4:04 PM.

2. Approval of Minutes:

The motion to approve the March 30, 2011 TAC meeting were approved unanimously.

3. Public Comment Period

Mr. Tyler Newman, representative from Business Alliance for a Sound Economy (BASE) and the Wilmington Home Builders' Association spoke in opposition to the resolution opposing Senate Bill 214. He told members his organization felt the current corridor mapping process could be made more efficient by the Bill. He asked members that instead of out-right opposition, BASE would like to encourage TAC members to give guidance to staff with suggestions for alternatives language for the Bill as the General Assembly moves forward.

Mr. Andy Koeppel noted that conceptually members should not out-right oppose the Bill but should modify it. He noted that property owners are impacted by corridor preservation and he felt that after a certain period of time, if NCDOT does not have funding to build the highway through the corridor then the Department should be willing to pay the property taxes until funds are available for acquisition of the right-of-way. He told members we are extremely behind in the construction of needs throughout the state to build highways that are critically necessary to the state's economy. He asked that members modifying the resolution to reflect the changes he suggested as a means to give the General Assembly the message that there is a middle-ground that could help property owners while at the same time still not hurt our future transportation needs.

4. Presentations

a. Interstate - 74

Mr. Dan Ryan, Southeast Coastal Plain Program Director for The Nature Conservancy gave a presentation on alternative routes developed by a study completed for the Nature Conversancy for

the proposed Interstate-74 corridor that would bypass the Green Swamp and Juniper Creek Preserves.

b. NCDOT Prioritization 2.0

Mr. Kozlosky gave a presentation on the Prioritization 2.0 (P 2.0). He told members that the North Carolina Department of Transportation is building off the foundation of Prioritization 1.0 and expanding the criteria based on input sessions and feedback received last fall. P2.0 will rank projects for years 2018 through 2022. Mr. Kozlosky noted that safety projects will be submitted directly to the state traffic engineer's office with P2.0, He also advised members that the Department is not asking for enhancement projects for prioritization because funds are not available at this time.

In discussion regarding the health and safety projects deemed to be needed by the Department, Ms. Padgett stated that she would like to caution the Department that sometimes the local community doesn't want the Department's intended solution to the safety issue. Community stakeholders would like to have a voice early enough for their concerns to be taken into consideration.

Mr. Kozlosky announced that the Department will be holding educational sessions at several locations in the state next month. Following his presentation, Mr. Kozlosky noted that the presentation will be posted to the WMPO website.

5. Old Business

a. Resolution Opposing Changes to Senate Bill 214

Mr. Barfield told members that because staff needs clear direction from this board on Senate Bill 214, he wanted to open it back up for discussion after members have had time to think things through. He opened the floor for comments.

Mr. Batson noted that his concern is not with the Bill so much as it is with the procedure. He said members voted on the resolution at the last meeting and it was 5 to 5. He thought it was a failed resolution. Ms. Padgett suggested that we start with a fresh resolution that says we have a request that there be changes in the Bill.

Following some discussion, Ms. Campos suggested that Mr. Kozlosky write a letter explaining that we have suggestions that we would like to see incorporated into the Bill.

Mr. Barfield asked members if in taking all of what has been said into account, would the members feel comfortable with the Chair writing a letter to our delegation advising them that the committee has concerns in regards to the time frame and that we would rather see DOT have resources to buy property versus holding people up. He noted that he could word it in that manner, with no resolution included, but just give them thoughts from this collective body indentifying the pros and cons. Ms. Campos asked if members could see the letter prior to sending to the legislators. All members agreed that it would be appropriate. Mr. Barfield directed Mr. Kozlosky to prepare a letter and send it out to TAC members for review.

6. Public Hearing

a. 2011-2012 Unified Planning Work Program (UPWP)

Mr. Barfield called for a motion to open the public hearing on the 2011-2012 Unified Planning Work Program. Mr. Ballard made the motion and Mr. Sue seconded the motion. The motion carried unanimously.

Mr. Kozlosky told members the 2011-2012 Unified Planning Work Program is the budget for the MPO over the next fiscal year and the budget includes two special studies. They are the update of

the collector street plan for the Town of Leland and the completion of a comprehensive transportation plan for the Town of Wrightsville Beach. He stated that staff conducted the required 30-day public comment period and received no comments on the proposed budget. The budget is due to the Department by the beginning of May. He noted that staff recommends approval of UPWP.

With no one speaking in favor or against the item during the public hearing, Mr. Batson made the motion to close the public hearing. Mr. Sue seconded the motions and it carried unanimously.

Mr. Sue made the motion to adopt the FY 2011-2012 Planning Work Program and Ms. Padgett seconded the motion. The motion carried unanimously.

Mr. Sue made the motion to certify the Wilmington Metropolitan Planning Organization's Transportation Planning process for FY 2011. Ms. Padgett seconded the motion. The motion carried unanimously.

7. New Business

a. Amendment to the Wilmington MPO Bylaws

Mr. Kozlosky told members staff was directed to look at how items are added to the agenda by TCC and TAC members. At the last meeting, members approved recommended changes that stated that members "may add items along with all pertinent information to the agenda by submitting them no later than 5 PM the first business day of the calendar month in which the item is requested to be considered. Items may also be placed on the agenda for consideration at the end of the meeting by a majority vote of the members present." Mr. Kozlosky noted that changes to the bylaws will require passage by a two-thirds vote and the amendments being considered must be received by each member by at least seven days prior to the meeting.

Ms. Campos made the motion to amend the MPO Bylaws and Ms. Padgett seconded the motion. The motion carried with nine members voting in favor and Ms. Batleman voting no.

8. Discussion

a. Public Involvement Policy

Mr. Kozlosky told members at the last meeting concerns were expressed about the public involvement policy of the MPO as well as the Department of Transportation. The MPO has a Public Involvement Plan that was adopted by the TAC in September of 2009. The plan outlines a number of options for public involvement. Mr. Kozlosky asked members if they would like him to bring the current Public Involvement Plan back for review in an effort to identify additional options in getting the word out to the public regarding events.

Members agreed that the MPO's Public Involvement Plan seems to be satisfactory as written.

8. Updates

a. City of Wilmington/Wilmington MPO

• **US 17/NC 210 Corridor Study in Pender County** - Mr. Kozlosky told members a public workshop is scheduled for May 12th at Topsail High School.

• Market Street Corridor Study - Mr. Kozlosky told members staff will be conducting two additional informational workshops on the corridor study. The meetings will be held May 9th and 10th.

 Multimodal Transportation Center – Mr. Kozlosky told members work is continuing on the environmental assessment. Ms. Padgett briefed members on the meeting she attended in Raleigh regarding transportation center.

b. Cape Fear Public Transportation Authority

Mr. Eby updated members on the activities for the Cape Fear Public Transportation Authority. He told members the grand opening of the Forden Station was held on April 18th. He invited everyone to come tour their new facility.

Mr. Barfield noted that the next TAC meeting will be held at the Cape Fear Public Transportation Authority Boardroom on Cando Street.

c. NCDOT

Mr. Pope updated members on the activities for the Department.

STATEMENT OF MUTUAL BENEFIT AND INTEREST

The Lower Cape Fear Consortium has been brought together to support multijurisdictional planning efforts that integrate housing, land use, economic and workforce development, transportation, and infrastructure investments integrating the six Livability Principles adopted by the United States Department of Housing and Urban Development (HUD), Environmental Protection Agency (EPA), and Department of Transportation's (DOT) Sustainable Communities Partnership. The Consortium members recognize the importance of the creation of a consortium for the purpose of strengthening the capacity of the three-County region to accomplish the following:

- 1. Provide More Transportation Choices.
- 2. Promote Equitable, Affordable Housing.
- 3. Enhance Economic Competitiveness.
- 4. Support Existing Communities.
- 5. Coordinate Policies and Leverage Investments.
- 6. Value Communities and Neighborhoods.

The consortium is organized as a group of equal partners, each bringing their unique strengths and capabilities in order to assist in different ways to fulfill the needs of the project.

PURPOSE:

Lower Cape Fear Sustainable Communities Consortium Partners represent a wide array of leadership representing environmental, housing, economic development, infrastructure and transportation interests.

The Consortium will oversee the development of Regional Initiatives geared towards Sustainable Development. These initiatives will integrate the six livability principles into comprehensive programs for Brunswick, New Hanover and Pender Counties. Ultimately, these initiatives will be guided by one comprehensive & region-specific Sustainability Plan integrating planning documents from member agencies to create a holistic guide that incorporates existing and new ideas. This plan will be created and maintained by the Consortium as part of its annual adopted Work Plan.

Each member of the Consortium is responsible for bringing their unique strengths and capabilities to the Consortium. Project resources will be allocated based upon each partner's relevant role, expertise and level of commitment.

CONSORTIUM GOVERNANCE & STRUCTURE:

Lower Cape Fear Sustainable Communities Consortium Partner agencies are represented by appointed staff from each member agency. The Consortium will not have the power to adopt policies that will directly affect the member agencies. Rather, the Consortium will come to consensus on issues/draft policies/practices. After coming to consensus on draft policies/practices, the Consortium representatives may individually bring these items to their voting boards that have the power to adopt, modify & adopt, or to deny adoption of policies/practices.

MEMBERSHIP REPRESENTATIVE APPOINTMENT:

Representatives shall be appointed by the governing boards of participating organizations. Representation should be from the policy-drafting staff of the member organizations.

VOTING PROCEDURES:

Representatives shall have the right to vote on administrative matters concerning the Consortium. Representatives will also have the right to vote on model policies and practices in order to come to a consensus. Voting by the representatives at the Consortium shall in no way constitute binding directives or laws applicable to member organizations but shall be used to come to a consensus and to move forward through the adopted work plan.

RESPONSIBILITY OF CONSORTIUM MEMBERS:

Lower Cape Fear Sustainable Communities Consortium Partner agencies are represented by appointed staff from each member agency. Partners are required to adopt a work plan each year and shall provide staffing & other resources as outlined in the work plan for specific projects. Generally, partners are required to:

- 1. *Participate in the Consortium.* Consortium Members must play an active participatory role in the process.
- 2. Share Information. Consortium Members will assist with circulating information about projects and helping to bring others to the table. Consortium Members will assist with outreach both to members of the public and to members of their organization or local government. Consortium Member representatives will serve as the primary contact for the projects and will be responsible for communicating the activities of the Consortium to their organization and constituents. If a Consortium Member's representative changes, the Consortium must be notified.

3. Assist with carrying out the adopted Work Plan. Consortium Members will help: to review and draft projects identified in the Work Plan; to identify opportunities to implement the projects in the Work Plan; to identify elements of existing regional plans and other documents that need revision in order to be consistent with common regional goals; and to help facilitate revisions to other regional planning documents as needed.

WORK PLAN:

Each year, the consortium will adopt a work plan valid for the fiscal year that will list specific goals, commitments, and funding sources for sustainability projects that address the following requirements:

- 1. Provide More Transportation Choices.
- 2. Promote Equitable, Affordable Housing.
- 3. Enhance Economic Competitiveness.
- 4. Support Existing Communities.
- 5. Coordinate Policies and Leverage Investments.
- 6. Value Communities and Neighborhoods.

LIABILITY

The participants hereto agree that they shall each be responsible for their own individual, direct liabilities and not for any other stakeholder actions, omissions or liabilities, unless otherwise provided by law and the specific consent of each member.

AMENDMENTS AND REVIEW

This Memorandum of Understanding (MOU) is subject to revision and can be amended, or modified by the mutual written consent, signed and dated, by all of the participating organizations, prior to any changes being performed.

New participating organizations may be added to the MOU by consensus, written or otherwise, of the current participants.

OTHER PROVISIONS

Nothing herein is intended to or has the effect of extending any legal authority or responsibilities of any of the members herein nor is any provision herein intended or has the effect of modifying, restricting, enhancing or changing the legal authorities, obligations, restrictions, liabilities or requirements of any of its members. This MOU is intended only to provide the basis for a voluntary cooperative relationship among the signatories and is not intended to, nor does it create any right, entitlement, or benefit, substantive or procedural, or

trust responsibility, enforceable at law or equity, by any individual, organization, private or governmental third party, participant party or any member thereof against any party to this agreement or the United States, its agencies, its officers, or any person. This MOU shall not be construed to create any right to judicial review involving the compliance or noncompliance with the terms of this MOU by any signatory or the United States, its agencies, its officers, or any other person. To the extent that any provision of this MOU conflicts with current directives, or applicable regulations or laws of any of the parties of this agreement, the provisions of this MOU will have no effect.

The creation of the partnership in no way substitutes for the decision-making process that each participating agency is required to follow by regulation, directive, or law. The creation of the partnership helps to facilitate discussion among the participants, without making decisions for those agencies.

TERMS OF THE MOU

<u>WITHDRAWAL.</u> Any of the parties, in writing, may withdraw from the instrument at any time.

Neither party shall incur any new obligations for the terminated portion of the instrument after the effective date and shall cancel as many obligations as possible. Full credit shall be allowed for each Party's expenses and all non-cancelable obligations properly incurred up to the effective date of termination.

MODIFICATION. Modifications within the scope of the instrument shall be made by mutual consent of the parties, by the issuance of a written modification, signed and dated by all parties, prior to any changes being performed.

<u>PARTICIPATION IN SIMILAR ACTIVITIES</u>. This instrument in no way restricts the Cooperator(s) from participating in similar activities with other public or private agencies, organizations, and individuals.

COMMITMENT TO PARTNERSHIP.

- 1. The collaborative service area includes the Wilmington Metropolitan Statistical Area.
- 2. The partners agree to collaborate and provide in-kind support pursuant to the purpose of this agreement.
- 3. We, the undersigned, have read and agree with this MOU.







BYLAWS WILMINGTON URBAN AREA TRANSPORTATION ADVISORY COMMITTEE

ARTICLE I - NAME

The name of this organization shall be the Wilmington Urban Area Transportation Advisory Committee, hereinafter referred to as the "TAC".

ARTICLE II - PURPOSE

The purposes of the TAC are outlined in the most recent "Memorandum of Understanding" approved by the appropriate local governments.

ARTICLE III - MEMBERS

<u>Section I – Number of Qualifications</u>: The TAC shall consist as specified in the "Memorandum of Understanding". The eligible voting member list consists of a representative from each of the appropriate boards with the City of Wilmington having two representatives.

<u>Section II – Terms of Office</u>: All elected representatives serving on the TAC may serve for the length of their elected terms. A member may serve successive terms.

<u>Section III – Alternates</u>: Each of the appropriate boards shall designate all members of their governing board who are not members of the TAC as alternate members of the TAC. In the event that a member is unable to attend, that member or the chief elected officer of that jurisdiction will designate an alternate to attend and participate in the member's absence. That alternate member may serve as a full voting member during any meeting where one of that board's representatives is not in attendance. Proxy and absentee voting are not permitted.

<u>ARTICLE IV – OFFICERS</u>

<u>Section I – Officers Defined</u>: The TAC shall, upon majority vote of its membership, appoint one voting member of the Committee to act as Chairman and one voting member to act as Vice-Chairman. A member of the staff of the City of Wilmington Development Services Department will serve as Secretary to the Committee.

<u>Section II – Duties</u>: The Chairman shall call and preside at meetings and appoint committees. In absence of the Chairman, the Vice-Chairman shall preside and complete all duties of the Chairman.

Section III – Elections: The Chairman and Vice-Chairman shall be elected annually by the voting members of the TAC, with their terms to begin at that meeting. In the event that there is no Chairman or Vice-Chairman, the TCC Chairman shall preside until a Chairman and Vice-Chairman are elected. The Chairman and Vice-Chairman shall serve for a period of one (1) year from their election and may be re-elected.

ARTICLE V - MEETINGS

<u>Section I – Meetings:</u> Regular schedules will be adopted by the TAC at the first meeting of the calendar year. If there is insufficient reason for a regularly scheduled meeting, as determined by the Chairman, the Secretary will notify TAC members of the meeting's cancellation. Meetings shall be conducted under parliamentary procedures consistent with <u>Robert's Rules of Order</u>.

<u>Section II – Quorums and Majority Vote:</u> A quorum is required for the transaction of all business, including conducting meetings or hearings, participating in deliberations or voting upon or otherwise transacting public business. A quorum consists of 51% of the members of the TAC, plus as many additional members as may be required to ensure that 51% of the possible votes are present.

<u>Section III – Attendance</u>: Each member shall be expected to attend each scheduled meeting.

<u>ARTICLE VI – VOTING PROCEDURES</u>

Section I – Majority Votes: Any member may call for a vote on any issue provided that it is seconded and within the purposes set forth in the "Memorandum of Understanding." Each voting member of the TAC shall have one vote, and a majority vote of those present and voting shall constitute approval of any motion, provided a quorum exists. Abstentions are not included in the tally of the votes. Proxy and absentee voting are not permitted.

Section II – Agenda: The agenda is the list of items suggested for discussion at a TAC meeting. Agenda items originate as a carry-over from previous meetings, are placed on the agenda prior to its distribution by any member of the TAC, by request from any jurisdiction party to the "Memorandum of Understanding," or by the request of a member of the Technical Coordinating Committee (TCC). TCC and TAC members may submit an item(s) to their respective TCC and TAC agendas. In order for a Board member to submit an item(s) to the TCC or TAC, the item(s) must be submitted no later than 5:00 p.m.

the first business day of the calendar month in which the item is requested to be considered. The item must include all pertinent background materials (resolution, maps, etc.). An item may also be placed on the agenda for consideration at the end of the meeting by a majority vote of the voting members present.

ARTICLE VII - AMENDMENTS TO BYLAWS

Amendments to these Bylaws of the TAC shall require the affirmative vote of at least two-thirds (2/3) of the eligible voting members, provided that written notice of the proposed amendment has been received by each member at least seven (7) days prior to the meeting at which the item is to be considered and provided that such amendment does not conflict with the letter or the fundamental intent of the "Memorandum of Understanding" governing this document. In the event of any conflict, the "Memorandum of Understanding" shall carry precedence over these Bylaws.

WILMINGTON BYPASS (No significant change)

Project Description/Scope: Construct the Wilmington Bypass from US 421 in New Hanover County to US 17 in Brunswick County.

Current Status: NCDOT has let the design and construction of the Wilmington Bypass Section "A" from US 17 to US 74/76 as a "design-build" project. They anticipate completing this section of the Bypass in 2013. The Wilmington Bypass "Section B" is funded from FY 2013 through 2020. All of the municipalities and counties within the Wilmington MPO adopted resolutions encouraging NCDOT to explore funding options to accelerate the "B" section of the Wilmington Bypass.

Next Steps: NCDOT announced the acceleration of the Bypass and a new expected completion date of 2018.

ARTERIAL SIGNAL RETIMING: (No significant change)

Project Description/Scope: Per NCDOT agreement, all signals in the system must have timing evaluated on an 18-month cycle.

Current Status: All existing signal timing plans verified and updated. Final migration of back-up time-of-day programming is nearing completion.

Next Steps: Begin GPS timing evaluation runs on existing timing plans to establish baseline performance. Identify critical signals and begin timing plan development.

CAPE FEAR COMMUTES 2035 TRANSPORTATION PLAN

Project Description/Scope: Cape Fear Commutes 2035 is a federally-mandated assessment of the current and future transportation needs of people and goods within the Wilmington MPO area.

Current Status: The MPO's Transportation Advisory Committee adopted *Cape Fear Commutes 2035 Transportation Plan* on December 15th. **All municipalities and counties have formally adopted the plan.**

Next Steps: The Wilmington MPO is utilizing Cape Fear Commutes 2035 Transportation Plan to develop the first strategic business plan for the Wilmington MPO, expected to be complete in July.

CAPE FEAR SKYWAY

Project Description/Scope: Construct the Cape Fear Skyway that will link from in the vicinity of US 17 to Independence Boulevard and Carolina Beach Road.

Current Status: The NHC Board of Commissioners, Brunswick County Board of Commissioners and Wilmington City Council passed resolutions supporting the preservation of the potential northern route and directed staff to work with the MPO to file a map for the potential northern alignment. On November 18th,

the Town of Leland voted to decline to approve a transportation official corridor map for the Cape Fear Skyway within the Town of Leland. The North Carolina Turnpike Authority (NCTA) held a public workshop on March 22nd in Brunswick County and March 24th in New Hanover County.

Next Steps: The NCTA continues to work through the environmental review process.

CITY OF WILMINGTON COLLECTOR STREET PLAN

Project Description/Scope: Complete a city-wide area collector street plan including Monkey Junction.

Current Status: The Steering Committee met on April 5th to discuss the plan and street cross-sections. Staff is awaiting comments from the steering committee on a draft collector street map.

Next Steps: The DRAFT collector street map plan will be completed by the end of May. The project is expected to be completed in July.

MARKET STREET CORRIDOR PLAN

Project Description/Scope: Develop a corridor plan for Market Street from Colonial Drive to the Pender County line.

Current Status: The MPO presented the corridor plan to the County Commissioners in February and City Council in February/March. The City and County have expressed concern regarding the number of participants in the study process. Staff provided additional public presentations at the HR Training Center at the New Hanover County Government Complex on May 9th and Ogden Elementary School on May 10th. There were 115 people that attended the meetings.

MULTI-MODAL TRANSPORTATION CENTER (No significant change)

Project Description/Scope: Purchase right-of-way, develop design plans and construct the Wilmington Multi-modal Transportation Center between N. 3rd, N. 4th, Hanover and Red Cross streets.

NCDOT hired Moffit & Nichol Associates and Ko & Associates to complete the Environmental Assessment (EA) for the Wilmington Multi-modal Transportation Center. NCDOT is continuing the development of the EA. The work group has decided to separate the environmental documents for the rail and public transportation elements. The EA for the public transportation element is expected to be completed by the end of the calendar year. NCDOT is pursuing securing an option on the U-Haul property until completion of the EA.

NEIGHBORHOOD TRAFFIC MANAGEMENT PROGRAM - PINE VALLEY EAST

Project Description/Scope: Construction of long-term neighborhood traffic management in the Pine Valley East neighborhood.

Current Status: Barnhill Construction Company began construction in Pine Valley East on March 16th. Construction has been completed at 6 intersections.

Next Steps: The project is expected to be completed by the end of July.

N. 3RD STREET CORRIDOR STREETSCAPE IMPROVEMENTS

Project Description/Scope: In May 2006, a transportation bond referendum was approved that included \$5 million in improvements to the North 3rd Street corridor.

Current Status: The City has received the 100% final design plans and the 100% opinion of probable costs. **The City held a pre-bid on April 19**th.

Next Step: The City will hold the bid opening on May 19th. Award of the construction contract is expected by City Council in June with construction beginning on the project in July. Project completion is expected in August 2012.

SAFELIGHT

Current Status: All sites have been upgraded and are fully operational. Below are excerpts from system generated reports to show the staff and system performance for 3/1-3/31. Please note at the date of update 4/14/11 three traffic crashes were recorded at Safelight locations. Two involved vehicle rollover, with a SUV running the light and overturning after hitting a vehicle which also overturned. In the second case, the evidence from the SafeLight violation was critical in assigning fault in the incident.

Fiber work is required to bring Eastwood Cavalier camera and Wrightsville/Independence signals on line. Conduit work complete on Independence, awaiting arrival of fiber cable to install. During field investigation to bring Cavalier Drive on-line substandard work was discovered. Communicating with contractor to determine if product is still under workmanship warranty. If not, City will hire local firm to rework splice. City revised contract for Central Software upgrade forwarded to vendor.

Next Steps: Complete Centracs contract negotiations.
