# 1. Call to Order

Mr. Doetsch called the meeting to order at 3:00pm.

# 2. Conflict of Interest Reminder

Mr. Doetsch asked if any members had a conflict of interest with any items on the meeting agenda. No members reported having a conflict of interest.

# 3. Approval of Minutes

The minutes for the January 27, 2016 meeting were approved unanimously.

# 4. Public Comment Period

Ms. Minnie Brown, Mayor-Pro Tem for the Town of Navassa told members that she is attending today's meeting on behalf of Mayor Willis. She introduced Navassa's Town Council members Ernest Mooring and Athelston Bethel who were also in-attendance.

# 5. Presentations

# a. <u>Wilmington MPO 101: Transportation Projects from Conception to Construction, Suraiya</u> Motsinger

Ms. Motsinger gave a presentation on Transportation Projects from Conception to Construction. A brief question and answer period followed the presentation.

# b. Transportation Demand Management Activities Update, Adrienne Harrington

Ms. Harrington gave a presentation on the Transportation Demand Management activities. A brief question and answer period followed the presentation.

Ms. Batleman asked that items 6 b. and d. be pulled from the Consent Agenda for discussion.

Mr. Miller made the motion to approve items 6. a., c., e., f., g., and h. on the consent agenda. Mr. Williams seconded the motion and it carried unanimously.

Ms. Batleman told members she would like to have more information on U-5914 (NC133, US 17/74/76 to SR 1554 [Old River Road] Modernize Roadway). Mr. Kozlosky stated that NCDOT will be looking at options to add capacity and modernize the roadway from where the Diverging Diamond terminates to Old River Road. The project will also look at adding median, sidewalks, and bicycle lanes as part of the Department's complete-streets policy.

Ms. Batleman told members she has questions regarding the 2016 Legislative Agenda (item d.). She suggested inserting under Transportation Financing "...... to address the growing needs of the state and the nation. Including, but not limited to road and highway projects..." She suggested inserting bridges to that list. She also questioned the term "beach nourishment". She asked how that worked as far as being a transportation issue.

Mr. Barfield stated that "beach nourishment" was included as one of their legislative goals from the Board of County Commissioners Legislative Conference in 2015. Mr. Williams told members he would like to add the word "inlet and" before.......waterway maintenance,....." to reinforce the importance the importance of the inlets. Ms. Swearingen told members that the Coastal Storm Damage Reduction program is how it relates to transportation. The material from the dredging program provides sand for the protection of infrastructure.

Following further discussion on the Transportation Financing section, Mr. Kozlosky suggested changing the sentence to say: ".....beach nourishment, inlet and waterway maintenance, coastal storm damage reduction, port infrastructure, airports, etc." Consensus of the group was to accept Mr. Kozlosky suggested changes.

Mr. Williams made the motion to approve items 6.b and d. with the changes as discussed to item d. Mr. Miller seconded the motion and it carried unanimously.

# 7. Regular Agenda

# a. Resolution adopting the Wilmington Urban Area MPO's Amended Memorandum of Understanding

Mr. Kozlosky told members that the Amended Memorandum of Understanding (MOU) will keep the organization name as the Wilmington Urban Area Metropolitan Planning Organization but it reflects all changes that were made in the previous revision of the MOU from 2015.

Ms. Batleman told members that she would like to propose changes under Section K - Board Voting Policy. She suggested adding a new number 3 under section K to say when the population of a jurisdiction reaches 50,000, the Board will commence a process to restructure the voting allotment to a weighted voting, or some other equitable process.

Mr. Watkins asked how the weighted vote process would work. Ms. Batleman said a formula would be created to determine the numbers. She noted that it will be 10 years before Leland reaches that number in population, but she felt it would be wise to include that option. Mr. Watkins told members that in his opinion if we went ahead and enacted it, we have to do that formula now and the east side of the river would have a significant advantage. He noted that in the early years, it could actually negatively affect Brunswick County. Mr. Williams told members that he's been in discussions with other MPO's around the state and it's a double-edge sword because one entity had over half the votes by themselves. That one person cast almost half the votes so we need to think through un-intended consequences. Mr. Barfield told members that he would not be in favor of changing the voting structure.

Ms. Batleman told members that she brought up the suggestion for weighted voting for discussion purposes. She said it's an issue that will need to be discussed seriously at some point.

With no further discussion, Mr. Miller made the motion to adopt the Wilmington Urban Area MPO's Amended Memorandum of Understanding. Mr. Williams seconded the motion and it carried unanimously.

# b. Resolution adopting Amendments to the Wilmington Urban Area MPO's Bylaws

Mr. Kozlosky told members that the amendment will allow the Board to approve the agenda at the beginning of each meeting. He explained that at a recent meeting there was a request to remove an item from the agenda and there was not a process in place to do that. This amendment will allow the Board to add or remove items from the agenda following a specific protocol outlined in the bylaws at the beginning of each meeting.

Ms. Batleman told members that she would like to suggest a possible change to the Bylaws in Article V-Meetings, in Section IV- Attendance. She suggested the following change: Any members absent from three consecutive meetings will be relieved of membership in the Board and a new representative will be requested of the MPO member. Mr. Piepmeyer asked if there would be excused absence clause. Mr. Watkins told members this change would put a burden on another organization and he is not sure we have the authority to remove a designee that was appointed by another entity.

Following additional discussion, Mr. Kozlosky asked that staff be granted additional time to go back and research these possible changes to the bylaws.

Mr. Piepmeyer made the motion to table the resolution to adopt the Amendments to the Wilmington Urban Area MPO's Bylaws to allow staff to research this issues discussed regarding changes to the Bylaws until the next meeting. Mr. Williams seconded the motion and it carried unanimously.

# c. Resolution Amending the FY 15-16 Unified Planning Work Program (UPWP)

Mr. Kozlosky told members that the Board has until the end of March to amend the UPWP in order to reflect the anticipated expenditures through the end of the fiscal year. The amendments will add/decrease the funding as projected.

Ms. Batleman made the motion to approve the resolution to amending the FY 15-16 Unified Planning Work Program. Mr. Watkins seconded the motion and it carried unanimously.

# d. Resolution Approving the 2016 TAP-DA Allocation

Mr. Kozlosky noted that at the last meeting staff was directed to bring a resolution to the Board for consideration in awarding the 2016 TAP-DA funding to the Town of Navassa for the Navassa Park Multiuse Trail. He said the resolution awards the 2016 funds to the Town of Navassa and they will need to apply for the 2017 TAP-DA allocation in order to obtain the remaining funds needed to construct the project.

Mr. Barfield made the motion to approve the resolution awarding the 2016 TAP-DA funding to the Town of Navassa for the Navassa Park Multi-use Trail. Mr. Miller seconded the motion and it carried unanimously.

# e. Resolution Adopting the Pender County Collector Street Plan

Mr. Kozlosky told members that the Pender County Collector Street Plan provides a guide for future development of a collector street network in Pender County. He noted that the Pender County Board of Commissioners adopted the plan on March 21<sup>st</sup>.

Mr. Piepmeyer thanked everyone involved in the creation of the Pender County Collector Street Plan. He told members that the plan will help to better prepare them for the growth they are going to experience in the county.

Mr. Williams made the motion to adopt the Pender County Collector Plan. Mr. Miller seconded the motion and it carried unanimously.

# f. Resolution Supporting the Improvements to the Container Facility at the Port of Wilmington

Ms. Ayers told members the Port of Wilmington is working on channel improvements and expanding the turn-basin in order to accommodate larger ships. She noted that they are also purchasing new equipment to "work" the larger ships; and as part of that, they will need to make some terminal improvements. Ms. Ayers stated that the Port is asking the Federal Government to help partner with them on the terminal improvements by way of a TIGER and FASTLANE grant applications. She said members of their Board would appreciate support for their applications.

Mr. Williams made the motion to approve the resolution supporting the Improvements to the Container Facility at the Port of Wilmington. Mr. Watkins seconded the motion and it carried unanimously.

# 9. Discussion

# a. Organizational Improvements

Mr. Kozlosky told members that over the course of the next few months, staff will be using the information that came through the Board's workshop on March 14<sup>th</sup> to make improvements to the organization.

Mr. Kozlosky said staff is also working to develop a strategic plan from the information provided by the future headlines exercise at the retreat. Staff will use the PEST analysis in looking at the political,

economic, social and technological challenges for each of the headlines on the lists. Staff would like to request feedback at the April meeting in selecting to top priorities for strategic plan.

Following a general discussion on the retreat and staff's request to conduct the PEST Analysis, consensus of the members was that the analysis would be done during the April meeting.

Mr. Doetsch suggested that he would support holding a workshop/retreat once a year and perhaps include members of the Technical Coordinating Committee members. TAC members agreed to continue holding the workshop/retreat each year.

# b. Future roles and Responsibilities of the Citizen Advisory Committee (CAC)

Mr. Kozlosky told members that the CAC has been working to help the WMPO with the long range transportation planning efforts for the past 10 years. During those years there has been a lot of turnover in the TAC membership. Because each TAC member appoints the representative to the CAC, it may be the wish of the current TAC member to select someone of their choosing to be their representative on the Citizen Advisory Committee.

With the recent completion of the 2040 Long Range Transportation Plan, staff wanted to take this opportunity to seek direction from the Board on the future roles and responsibilities of the CAC. Mr. Kozlosky noted that one option would be to dissolve the current Citizen Advisory Committee and then re-create the committee in another year or so to begin the work on the next long range plan.

Mr. Kozlosky told members he and Mr. Howard Loving discussed future options for the committee. They discussed the possibility of dissolving the group at this point and when members of the TAC recreate the CAC, we reach out to the existing members and see if there is an interest to serve again. If so, it will be a decision for the sitting-TAC member.

Mr. Watkins asked Mr. Loving for his thoughts on dissolving the current committee. Mr. Loving told members that there is nothing for the committee to do right now. Members of the current committee understand that they may not be re-appointed to the next CAC; however, he wanted to stress that continuity is very important in creating the next long range plan. He suggest that members offer current CAC members the opportunity for appointment and let them be involved.

Following a brief discussion, consensus of the group was to dissolve the current CAC and the TAC members should give consideration to re-appointing the past representative to the future CAC. Mr. Kozlosky told members that staff will bring a resolution to the next meeting for consideration.

# c. <u>Section 5310 Work Group Appointment</u>

Mr. Kozlosky told members that a year ago the TAC supported that the Cape Fear Public Transportation Authority be the direct recipient of the 5310 funds and the TAC would be responsible for project selection. The Cape Fear Public Transportation Authority is developing a process for the administration for the Section 5310 funds and as such they reached out to the TAC asking for someone to participate in the process.

Mr. Barfield and Ms. Swearingen expressed interest in serving on the Section 5310 Work Group committee.

Mr. Williams made the motion nominate Mr. Barfield and Ms. Swearingen to serve on the committee. Mr. Miller seconded the motion. Mr. Barfield and Ms. Swearingen were unanimously elected to serve as members of the Section 5310 Work Group committee.

# d. Prioritization 4.0 and Draft Local Input Point Assignment

Mr. Kozlosky told members that NCDOT will be releasing the Prioritization 4.0 Statewide Mobility scores within the next few days. Staff will be bringing a draft point assignment for the Regional projects in April to open the public comment period. It will then come back to the Board for adoption in May.

# e. Joint FHWA/FTA Certification Review (added to the agenda)

Mr. Kozlosky told members that there will the joint FHWA/FTA Certification Review is tentatively scheduled for April 19, 2016. He invited members of the TAC to attend.

## 9. Updates

Project updates for the Crossing over the Cape Fear River Work Group, Wilmington MPO, Rail Realignment Task Force, CFPTA. NCDOT Division and NCDOT Planning Branch are included in the agenda packet.

Ms. Batleman told members that the Rail Re-alignment Task Force received 3 proposals for the feasibility study. The Task Force will be conducting interview tomorrow to select the firm to complete the study.

# 10. Adjournment

With no further business, the meeting was adjourned at 4:50pm

THIS FEASIBILITY STUDY AGREEMENT (Agreement) is made and entered into on the last date executed below, by and between The NORTH CAROLINA DEPARTMENT OF TRANSPORTATION, an agency of the State of North Carolina, hereinafter referred to as the "Department", the WILMINGTON URBAN AREA METROPOLITAN PLANNING ORGANIZATION, a regional transportation planning agency for the Lower Cape Fear Region, hereinafter referred to as the "WMPO", and the CITY OF WILMINGTON, a local government agency, hereinafter referred to as the "Municipality", and individually, hereinafter referred to as "Party," and collectively, as "Parties."

# WITNESSETH:

**WHEREAS**, the Municipality, WMPO, and the Department desire to investigate the impacts of proposed and future railroad relocation plans in the Municipality, specifically the Wilmington Rail Realignment and Cape Fear River Rail Crossing; and;

**WHEREAS**, the Municipality, WMPO, and the Department have agreed to fund a Feasibility Study (hereinafter, "FS") to determine the viability and return-on-investment of said proposed railroad improvements, and;

**WHEREAS,** it is understood by all Parties the terms and conditions of this Agreement are dependent upon, and subject to, the allocation of funds for the purpose set forth in this Agreement and the Agreement shall automatically terminate if funds cease to be available; and,

**WHEREAS**, the Municipality agrees to coordinate and oversee the FS in accordance with the provisions hereinafter set forth.

**NOW, THEREFORE**, the Parties hereto, each in consideration of the promises and undertakings of the other as herein provided, do hereby covenant and agree, each with the other, as follows:

# 1. OBLIGATORY:

#### a. Best Effort

All Parties to this Agreement will participate with the Municipality in the review of the draft FS and will endeavor to implement FS recommendations that are pertinent and agreeable to all Parties.

# b. Implementation

Recommended projects identified in the FS will be programmed and funded through separate agreements, if at all. Separate agreements, involving public funding sources from the Department related to these projects, will be funded at a level and arrangement which will be consistent in level and arrangement with the usual and customary practices, including the Department's Strategic Transportation Investments (STI) Program, based on funding availability and local, regional, and state transportation priorities.

# 2. DELIVERABLES

In order for the Department to participate in the cost of the FS, the following conditions must be included in the FS:

- i. Feasibility study of the potential relocation of the rail traffic across the Cape Fear River onto a new location serving the North Carolina State Ports Authority (NCSPA) from CSXT Davis Yard.
- ii. Conceptual engineering of proposed improvements and engineering cost estimation.
- iii. Market analysis to determine benefits of proposed improvements.
- iv. Return-on-investment analysis based on costs and benefits.
- v. Potential environmental impacts (positive and negative) screening.
- vi. Data and analysis for the project to respond to criteria for potential federal funding which may include TIGER or Federal Freight Funding.
- vii. Data and analysis for the project to be scored in the STI Program.

# 3. SCOPE OF WORK

The Municipality, and/or its agent, shall initiate a FS to investigate the costs and impacts of a proposed Wilmington rail realignment and Cape Fear River rail crossing. The FS shall be prepared with input from the Parties to this Agreement and other stakeholders. The FS shall be prepared in accordance with regulatory policies and procedures of the Department and the Municipality.

The FS process will include, but not be limited to, the following:

# a. Preliminary Public Involvement

- i. Identification of stakeholders and community organizations/focus groups
- ii. Documented meetings with stakeholders by the Municipality, and/or its agent
- ii. Documented contact by Consultant with stakeholders, and a record of comments and any recommendations.

The Public Involvement Plan will be jointly agreed to by the Parties prior to beginning the Feasibility Study.

# b. Existing Conditions Inventory and Analysis

- Collection of data related to rail and auto traffic, land use, existing at-grade and gradeseparated crossing characteristics, neighborhood characteristics and multi-modal networks.
- ii. Assessment and reporting of current conditions and analysis of data.

# c. FS Contents

- i. Data and analysis for the project to respond to criteria for potential federal funding which may include TIGER or Federal Freight Funding.
- ii. Data and analysis for the project to be scored in the Strategic Transportation Investment (STI) Program.
- iii. An existing conditions report outlining current rail providers/activity, traffic counts, access and travel times, safety issues of current at-grade rail crossings, and environmental screening.
- iv. A feasibility report of relocation of rail traffic across the Cape Fear River and out of downtown Wilmington, including traffic forecasts, downtown traffic capacity & impacts analysis, potential environmental impacts (positive and negative), potential Downtown economic impacts, and applicable case studies of similar projects. Coordination with the NCSPA on traffic will be critical in forecasting and assessment.
- v. Compilation of comments received during initial public meetings and from stakeholders and community/focus groups.
- vi. A report including traffic forecasts for all modes as available, surrounding network traffic capacity & impacts analysis, potential environmental impacts, market analysis, potential economic impacts, and policy/regulatory recommendations for use in area planning.
- vii. A conceptual engineering evaluation of improvements along the corridor, conceptual designs, and preliminary cost estimates.
- viii. Return-on-investment analysis weighing the costs of the improvements versus benefits of the improvements.

# d. Final Public Involvement

Additional public meeting to present the recommendations to the public.

# e. Changes to the Scope

Any changes to the scope of work must be approved in writing by all Parties prior to any additional work being performed.

#### 4. NOTICE TO PROCEED

Upon execution of this Agreement by all Parties, the Department shall establish funding, and issue the Municipality a written Notice to Proceed. Any work performed by the Municipality prior to receipt of the Department's written Notice to Proceed will be ineligible for reimbursement.

The Municipality shall endeavor to commence its responsibilities within forty-five (45) calendar days following receipt of the Notice to Proceed.

# 5. PROFESSIONAL AND ENGINEERING SERVICES

The Municipality, and or its agent, shall be responsible for the preparation of the FS. The Municipality shall follow the procurement procedures set out below for the use of a professional consulting/engineering firm to prepare the FS.

#### a. Professional Services

The Municipality, through an equitable selection process, shall be responsible for procuring a qualified consulting firm to perform the FS. The Municipality shall ensure the firm will perform the work in a timely manner and at a just and reasonable cost.

#### **b.** Procurement Procedures

When procuring professional services, the Municipality must adhere to the current applicable portions of 49 C.F.R. §18.36; 23 C.F.R. § 172; 40 U.S.C. Ch. 11, § 1101-1104, North Carolina General Statute 143-64, Part 31 and 32 and the Department's *Policies and Procedures for Major Professional or Specialized Service Contracts*. Said current policies and standards are incorporated in this Agreement by reference as if fully herein set out. The terms of this Agreement shall be incorporated into and made part of any new assignment or subcontract pursuant to this Agreement.

# i. Small Professional Services Firms Requirements

Any contract entered into with another party to perform work associated with the requirements of this Agreement shall contain appropriate provisions regarding the utilization of Small Professional Services Firms (SPSF). This policy conforms to the SPSF Guidelines as approved by the NC Board of Transportation. These provisions are incorporated into this Agreement by reference.

# ii. E-Verify Compliance

E-Verify is the federal program operated by the United States Department of Homeland Security and other Federal agencies, or any successor or equivalent program, used to verify the work authorization of newly hired employees pursuant to federal law. The Parties warrant that they and any subcontractor performing work under this Agreement: (i) uses E-Verify if required to do so by North Carolina law; and (ii) otherwise complies with the requirements of Article 2 of Chapter 64 of the North Carolina General Statutes. A breach of this warranty by any Party will be considered a breach of this Agreement, which entitles the other Parties to terminate this Agreement, without penalty, upon notice to the breaching Party.

# iii. Pre-Negotiated Audit

The Municipality shall submit all professional services contract proposals to the Department for review and approval prior to execution of the professional services contract by the Municipality. A pre-negotiation audit will be conducted by the Department's External Audit Branch. The Municipality shall not execute a consultant contract until the Department's review has been completed.

# 6. COMMUNICATION AND SCHEDULE

### a. Initial Meeting

Prior to the consulting firm beginning work, a meeting will be held between the Municipality, the Department, WMPO, and the engineering consultant to discuss the scope of work, deliverables and schedule. The Municipality shall be responsible for scheduling this meeting at a mutually convenient time.

If desired and deemed necessary, a quarterly meeting will be scheduled to discuss and review the progress of the FS.

# b. Report Updates

Upon execution of this FS, the Municipality, the Department, and the WMPO shall initiate a monthly conference call schedule to discuss the progress of the FS. This monthly call will continue until the final FS has been presented and approved by all Parties to this Agreement.

# c. Final Meeting:

Upon completion of the FS, the Municipality, the Department, WMPO, and the engineering consultant shall meet to discuss the findings and ensure all scoping items have been adequately addressed.

#### 7. REVIEWS

The Department, the Municipality, and the WMPO shall jointly review draft and final documents. The study findings shall be made available to all Parties. The findings are not binding to any party but are intended to facilitate sound decisions regarding future transportation improvements at said location. All technical memoranda, and associated materials, will become the joint property of the Department, the Municipality, and the WMPO, except for original photogrammetric products, which will become the property of the Municipality.

#### 8. DELIVERY OF FEASIBILITY STUDY RESULTS

The Municipality shall provide the Department and WMPO with a complete copy of the final FS as soon as it is available, but not later than thirty (30) days after acceptance of the FS by all Parties. The final documents along with distribution letters shall be submitted to the Department in sufficient quantities to meet normal distribution requirements. The total number of documents will be determined at a later date. The Department and the Municipality shall be jointly responsible for the distribution of the final documents.

#### 9. PROPOSED FUNDING:

The Parties to this Agreement have agreed to participate in the cost of the FS as follows:

The estimated total cost of the FS is \$300,000. It is understood by all Parties that the estimated cost is subject to change. However, no Party will be responsible for any amount in excess of that presented above (hereinafter, their "cost share") unless so agreed in a supplemental agreement.

#### 10. TIMEFRAME

The Municipality shall complete said FS within a total of 14 months from the date of execution of this Agreement. If the Municipality has not completed its responsibilities within the specified number of months, the unexpended balance of funds may be recalled by the Department and assigned to other projects by the Board of Transportation. The FS process will conclude after the final report has been submitted and accepted by the Department, WMPO and the Municipality.

#### 11. REIMBURSEMENT

The Parties to this Agreement shall reimburse the Municipality as follows:

The WMPO, the Department, and the Municipality shall each provide \$100,000 (for a total of \$300,000) to advance the FS to the level of final completion. The WMPO, and the Department, shall reimburse the Municipality, based on the percentage of work completed, not more frequently than every thirty (30) days.

If the cost of the FS is more than the estimated cost of \$300,000, the Municipality shall inform the other Parties and shall not allow the consulting firm to proceed. All Parties will work together to either (i) redefine the scope of work to be within the estimated \$300,000, by amending the Scope of Work contained in this Agreement in a writing signed by all Parties; or (ii) retain the approved scope of work and enter into a supplemental agreement signed by all Parties agreeing to new cost shares for the additional costs.

The Parties shall be advised of and concur in writing with any scope changes that could increase the cost of the study before the Department authorizes additional work. Work on the study shall not proceed until the estimated cost shares are submitted to the Department.

All services must be performed to the satisfaction of Department prior to any payment being made and approved by the Department's Project Manager.

#### 12. INVOICING THE DEPARTMENT

## a. Procedures

Based on percentage of work completed, the Municipality may bill the Department for the Department's cost share, which is \$100,000. Proper supporting documentation shall accompany each invoice, as may be required by the Department. If the work is performed by a consultant, said invoices shall show the contract cost.

Billing by the Municipality shall be based on completion percentages of 25%, 50%, 75%, and 100%, but shall be submitted no more frequently than monthly.

The Municipality may bill the Department by submitting an invoice to the Department's Rail Business Office. Reimbursement to the Municipality shall be made upon approval of the invoice by the Department's Rail Business Office, and the Financial Management Division. By submittal

of invoices, the Municipality certifies that it has adhered to all applicable state and federal laws and regulations pertaining to the development and delivery of the FS.

Any costs which exceed the total funded amount of \$300,000 shall be borne by the Municipality and the WMPO.

# b. Timely Submittal of Final Invoice

The Final Invoice associated with the FS must be submitted within six (6) months of the completion and acceptance of the FS to be eligible for reimbursement by the Department. Any invoices submitted after this time will not be eligible for reimbursement.

#### 13. PROJECT RECORDS

The Municipality and its agents shall maintain all books, documents, papers, accounting records, project records and such other evidence as may be appropriate to substantiate costs incurred under this Agreement. Further, the Municipality shall make such materials available at its office and shall require its agents to make such materials available at its office at all reasonable times during the contract period, and for five (5) years from the date of payment of the final voucher, for inspection and audit by the Department's Financial Management Section.,

# 14. AUDIT

In accordance with OMB Circular A-133, "Audits of States, Local Governments and Non-Profit Organizations", the Municipality shall arrange for an annual independent financial and compliance audit of its fiscal operations. The Municipality shall furnish the Department with a copy of the independent audit report within thirty (30) days of completion of the report, but not later than nine (9) months after the Municipality's fiscal year ends.

# 15. DESIGNATED REPRESENTATIVE

Marc Hamel, Rail Project Development Manager, shall serve as the Department's project manager and Arthur Petteway shall serve as assistant project manager. All correspondence and questions should be directed to them at <a href="mailto:mhamel@ncdot.gov">mhamel@ncdot.gov</a> (919-707-4705) or <a href="mailto:apetteway@ncdot.gov">apetteway@ncdot.gov</a> (919-707-4717).

#### 16. FAILURE TO COMPLY

Failure on the part of the Municipality to comply with any of these provisions will be grounds for the Department to terminate participation in the costs of the project.

## 17. REPAYMENT OF FUNDS

In the event the Municipality fails to complete and produce the Feasibility Study, the Department reserves the right to seek repayment of any reimbursed funds. For all monies due to the Department, reimbursement by the Municipality shall be made to the Department's Rail Business Office within sixty (60) days of receiving an invoice. A late payment penalty and interest shall be charged on any unpaid balance due in accordance with NCGS 147-86.23.

# 18. OTHER PROVISIONS

# a. Debarment Policy

It is the policy of the Department not to enter into any agreement with parties that have been debarred by any government agency (Federal or State). By execution of this Agreement, the Municipality and WMPO certify that neither it nor its agents or contractors are presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from participation in this transaction by any Federal or State Department or Agency and that it will not enter into agreements with any entity that is debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from participation in this transaction.

# b. Other Agreements

The Municipality is solely responsible for all agreements, contracts, and work orders entered into or issued by the Municipality for this FS.

# c. Improper Use of Funds

Where the Department determines that the funds paid to the Municipality for this FS are not used in accordance with the terms of this Agreement, the Department will bill the Municipality.

# d. Reimbursement by Municipality

For all monies due the Department as referenced in this Agreement, reimbursement shall be made by the Municipality to the Department within sixty (60) days of receiving an invoice. A late payment penalty and interest shall be charged on any unpaid balance due in accordance with NCGS 147-86.23.

#### e. Use of Powell Bill Funds

If the Municipality fails for any reason to reimburse the Department in accordance with the provisions for payment hereinabove provided, North Carolina General Statute (NCGS) 136-41.3 authorizes the Department to withhold so much of the Municipality's share of funds allocated to the Municipality by NCGS 136-41.1, until such time as the Department has received payment in full.

# f. Termination of Project

The Department reserves the right to terminate this Agreement at any time before the Municipality has been called upon to perform any work under the term of this Agreement. The Department shall notify the Municipality and the WMPO, in writing, in the event the Department elects to terminate this Agreement.

# g. Iran Divestment Act Certification

By signing this Agreement, the Municipality, and its agents, subcontractor (vendor, lessor/lessee, engineer, seller, etc.) hereby certifies that, as of the date of this Agreement, it is not on the Final Divestment List as created by the State Treasurer pursuant to NCGS 147-86.58. In compliance with the requirements of the Iran Divestment Act, NCGS 147-86.55, et seq., contractor (vendor, lessor/lessee, engineer, seller, etc.) shall not utilize in the performance of this Agreement any subcontractor that is identified on the Final Divestment List.

# 19. ETHICS PROVISION

"By Executive Order 24, issued by Governor Perdue, and N.C.G.S. § 133-32, it is unlawful for any vendor or contractor (i.e. architect, bidder, contractor, construction manager, design professional, engineer, landlord, offeror, seller, subcontractor, supplier, or vendor), to make gifts or to give favors to any State employee of the Governor's Cabinet Agencies (i.e., Administration, Commerce, Cultural Resources, Environment and Natural Resources, Health and Human Services, Public Safety, Revenue, Transportation, and the Office of the Governor)."

# RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO AN AGREEMENT WITH THE CITY OF WILMINGTON AND NORTH CAROLINA DEPARTMENT OF TRANSPORTATION TO THE RAIL RE-ALIGNMENT FEASIBLITY STUDY

**WHEREAS,** the Wilmington Urban Area Metropolitan Planning Organization provides transportation planning services for the City of Wilmington, Town of Carolina Beach, Town of Kure Beach, Town of Wrightsville Beach, Town of Belville, Town of Leland, Town of Navassa, New Hanover County, Brunswick County, Pender County, Cape Fear Public Transportation Authority and the North Carolina Board of Transportation; and

WHEREAS, the CSXT rail line originates in Brunswick County, crossing the Cape Fear River into the City of Wilmington just north of the Isabelle Holmes Bridge. The rail line then continues eastward through the City before turning south and west again-- back toward the river and the Port of Wilmington. The sweeping path of the rail line thus forms a large "U" (on its side) which, at one time, wrapped around the eastern limits of the City; and

WHEREAS, today, this same rail line passes through the heart of the City of Wilmington, resulting in thousands of motor vehicle rail crossings each day and adversely impacting the quiet enjoyment of many neighborhoods in the city; and

**WHEREAS**, the current route also impedes safe, efficient rail access to the Port of Wilmington and reduces the competitiveness of this important state-owned facility, as well as other nearby industries served by rail; and

**WHEREAS,** a potential solution would be to relocate the existing rail line to a crossing of the Cape Fear River close to the Port property, thereby eliminating rail traffic through the heart of the city, and dramatically improving rail access to the Port; and

WHEREAS, in addition, this proposal would provide an opportunity to convert the existing heavy rail corridor, with all of its related safety and noise issues, into a quiet transit corridor; and

**WHEREAS,** on December 8, 2014 the Wilmington Urban Area Metropolitan Planning Organization's Transportation Advisory Committee encouraged the MPO, NCDOT and CSXT to complete a feasibility study to evaluate the relocation of the CSXT rail line across the river via a route that eliminates rail traffic through the heart of the City and which would provide a more direct rail access corridor to the Port of Wilmington; and

**WHEREAS,** the estimated cost to complete a feasibility study is \$300,000 and this cost could be shared between the City of Wilmington, Wilmington Urban Area Metropolitan Planning Organization and North Carolina Department of Transportation; and

**WHEREAS,** on August 18, 2015 the Wilmington City Council affirmed support for a future allocation of funds in the amount of \$100,000 for the completion of the feasibility study; and

**WHEREAS,** on August 26, 2015 the Wilmington Urban Area MPO's Transportation Advisory Committee approved the allocation of \$100,000 for the completion of the feasibility study; and

WHEREAS, on March 3, 2016 the North Carolina Board of Transportation approved \$100,000 for the completion of the study; and

**WHEREAS,** funding is included in the approved FY 2017 Unified Planning Work Program to complete this study; and

**WHEREAS**, the agreement will formalize the commitment of funds by each entity.

**NOW, THEREFORE,** be it resolved that the Wilmington Urban Area Metropolitan Planning Organization's Transportation Advisory Committee hereby authorizes the Executive Director to enter into an agreement with the City of Wilmington and North Carolina Department of Transportation for the completion of the Rail Re-alignment Feasibility Study.

# BYLAWS WILMINGTON URBAN AREA TRANSPORTATION ADVISORY COMMITTEE

# <u>ARTICLE I – NAME</u>

The name of this organization shall be the Wilmington Urban Area Transportation Advisory Committee, hereinafter referred to as the "TAC".

# **ARTICLE II – PURPOSE**

The purposes of the TAC are outlined in the most recent "Memorandum of Understanding" approved by the appropriate local governments.

# <u>ARTICLE III – MEMBERS</u>

<u>Section I – Number of Qualifications</u>: The TAC shall consist as specified in the "Memorandum of Understanding". The eligible voting member list consists of a representative from each of the appropriate boards with the City of Wilmington having two representatives.

<u>Section II – Terms of Office</u>: All elected representatives serving on the TAC may serve for the length of their elected terms. A member may serve successive terms.

<u>Section III – Alternates</u>: Each of the appropriate boards shall designate all members of their governing board who are not members of the TAC as alternate members of the TAC. In the event that a member is unable to attend, that member or the chief elected officer of that jurisdiction will designate an alternate to attend and participate in the member's absence. That alternate member may serve as a full voting member during any meeting where one of that board's representatives is not in attendance. Proxy and absentee voting are not permitted.

# <u>ARTICLE IV – OFFICERS</u>

<u>Section I – Officers Defined</u>: The TAC shall, upon majority vote of its membership, appoint one voting member of the Committee to act as Chairman and one voting member to act as Vice-Chairman. A member of the staff of the <u>Wilmington Urban Area Metropolitan Planning Organization City of Wilmington Development Services Department will serve as Secretary to the Committee.</u>

<u>Section II – Duties</u>: The Chairman shall call and preside at meetings and appoint committees. In absence of the Chairman, the Vice-Chairman shall preside and complete all duties of the Chairman.

Section III – Elections: The Chairman and Vice-Chairman shall be elected annually by the voting members of the TAC, with their terms to begin at that meeting. In the event that there is no Chairman or Vice-Chairman, the TCC Chairman shall preside until a Chairman and Vice-Chairman are elected. The Chairman and Vice-Chairman shall serve for a period of one (1) year from their election and may be re-elected.

# **ARTICLE V - MEETINGS**

<u>Section I – Meetings:</u> Regular schedules will be adopted by the TAC at the first meeting of the calendar year. If there is insufficient reason for a regularly scheduled meeting, as determined by the Chairman, the Secretary will notify TAC members of the meeting's cancellation. Meetings shall be conducted under parliamentary procedures consistent with <u>Robert's Rules of Order</u>.

A Special or Emergency meeting is a separate session of society held at a time different from that of a regular meeting, and convened only to consider one or more items of business specified in the call of the meeting. Notice of the time, place and exact purpose of the meeting must be mailed to all members a reasonable number of days in advance. The reason for the special or emergency meeting is to deal with important matters that may arise between regular meetings and that urgently require action by the society before the next regular meeting. As in the case of a regular meeting, the session of a special or emergency meeting in an ordinary society is normally concluded in a single meeting, unless the assembly at the special meeting schedules an adjourned meeting.

<u>Special Meetings</u> – The Chairman or a majority of board members may at any time call a special meeting of the Committee by signing a notice stating the time and place of the meeting and the subjects to be discussed. The person or persons calling the meeting shall cause the notice to be posted at City Hall in downtown Wilmington or the door of the regular meeting place at least forty-eight hours before the meeting. In addition, the notice shall be e-mailed or mailed to individuals and news organizations. Only items of business specified in the notice may be transacted at a special meeting.

Emergency Meetings- If a special meeting is called to deal with an unexpected circumstance requiring immediate consideration, the notice requirements of this rule do not apply. However, the person or persons calling an emergency meeting shall take responsible action to inform the other board members and the public of the meeting. Local news organizations having requested notice of the special meetings shall be notified of such emergency meetings by the same method

used to notify the board members. Only business connected to the emergency may be discussed at this meeting.

Section II- TAC Sub-Committees: The Transportation Advisory Committee may create Sub-Committees to assist with forwarding the mission and goals of the Wilmington MPO. These Sub-Committees shall be created by a formal vote of the Transportation Advisory Committee. The notice of Sub-Committee meetings shall be posted at City Hall in downtown Wilmington or the door of the regular meeting place at least forty-eight hours before the meeting. In addition, the notice shall be e-mailed or mailed to all Transportation Advisory Committee members and news organizations.

<u>Section III– Quorums and Majority Vote:</u> A quorum is required for the transaction of all business, including conducting meetings or hearings, participating in deliberations or voting upon or otherwise transacting public business. A quorum consists of 51% of the members of the TAC, plus as many additional members as may be required to ensure that 51% of the possible votes are present.

<u>Section IV– Attendance</u>: Each member shall be expected to attend each scheduled meeting. <u>For members not attending three (3) consecutive TAC meetings, the Chairman will send to the chief elected officer of the jurisdiction of the member in question, a letter indicating the number of absences and requesting re-affirmation or re-designation of the jurisdiction's representative.</u>

# **ARTICLE VI – VOTING PROCEDURES**

Section I – Majority Votes: Any member may call for a vote on any issue provided that it is seconded and within the purposes set forth in the "Memorandum of Understanding." Each voting member of the TAC shall have one vote, and a majority vote of those present and voting shall constitute approval of any motion, provided a quorum exists. Abstentions are not included in the tally of the votes. Proxy and absentee voting are not permitted.

Section II – Agenda: The agenda is the list of items suggested for discussion at a TAC meeting. Agenda items originate as a carry-over from previous meetings, are placed on the agenda prior to its distribution by any member of the TAC, by request from any jurisdiction party to the "Memorandum of Understanding," or by the request of a member of the Technical Coordinating Committee (TCC). TCC and TAC members may submit an item(s) to their respective TCC and TAC agendas. In order for a Board member to submit an item(s) to the TCC or TAC, the item(s) must be submitted no later than 5:00 p.m. the first business day of the calendar month in which the item is requested to be considered. The item must include all pertinent background materials (resolution, maps, etc.). The TAC shall approve the agenda at the beginning of each meeting. At this time, the TAC shall have the ability to add or remove any item on the agenda by a super-majority vote of the TAC's voting members present. An

item <u>added to the agenda will may also</u> be placed <del>on the agenda for</del> consideration at the end of the meeting. by a majority vote of the voting members present.

# **ARTICLE VII – AMENDMENTS TO BYLAWS**

Amendments to these Bylaws of the TAC shall require the affirmative vote of at least two-thirds (2/3) of the eligible voting members, provided that written notice of the proposed amendment has been received by each member at least seven (7) days prior to the meeting at which the item is to be considered and provided that such amendment does not conflict with the letter or the fundamental intent of the "Memorandum of Understanding" governing this document.- In the event of any conflict, the "Memorandum of Understanding" shall carry precedence over these Bylaws.



#### PROJECT STATUS REPORT

April 4, 2016

#### **Project Description**

Roadway extending from the vicinity of US 17 Bypass and I-140 in Brunswick County to US 421 in New Hanover County, including a crossing of the Cape Fear River.

#### **Current Status**

The following list includes completed and ongoing tasks during the month of March:

- The project team continues to coordinate and correspond with project stakeholders.
- Functional Design Plans for the 12 detailed study alternatives (DSAs) are currently being reviewed by NCDOT.
- Hydraulic analysis of the DSAs is ongoing.
- The Draft Hurricane Evacuation Analysis Technical Memorandum has been submitted to NCDOT and the New Hanover and Brunswick County emergency management departments for review.
- The Historic Architecture Eligibility Report has been accepted by NCDOT and reviewed by the North Carolina State Historic Preservation Office (SHPO). NCDOT is currently working with SHPO to determine what resources within the project study area are eligible for listing on the National Register of Historic Places.
- Studies for the Traffic Noise Analysis and Air Quality Analysis are ongoing.
- An update to the Draft Natural Resources Technical Report is ongoing.
- Draft utility plans and relocation estimates are being reviewed based upon NCDOT's comments.
- NCDOT is currently evaluating an additional alternative proposed by the WMPO near the Port of Wilmington. There
  are currently 12 alternatives being designed and evaluated for inclusion in the draft environmental document.
   NCDOT is coordinating with the NCSPA regarding this alternative; if it is determined this alternative is reasonable,
  studies may need to be redone to include this alternative.
- The Cape Fear Crossing project is programmed in the 2016-2025 STIP for planning and environmental studies only using STPDA funding from the Wilmington MPO.
- The project team will plan to present the status of the project to the WMPO TAC before the next NEPA/Section 404 Merger Team Meeting.

# WILMINGTON MPO TRANSPORTATION PLANNING APRIL 2016

#### **CONGESTION MANAGEMENT PROCESS**

Project Description/Scope: Comply with a Federal mandate to create and adopt a process to evaluate the region's most congested corridors through locally-defined multi-modal performance measures in an effort to suggest improvements that would alleviate traffic congestion in the region. The CMP was adopted by the TAC on December 11, 2013. Data collection procedures have been developed. A schedule for collection logistics has been drafted and data collection will continuously be monitored and updated as needed.

#### **Next Steps:**

- Continue data collection and monitoring of congestion
- Document data collection in a Biennial Report

#### **COLLEGE ROAD UPGRADES (U-5702), (U-5704) and (U-5792)**

**Project Description/Scope:** The Strategic Transportation Investments is a new formula to determine how the North Carolina Department of Transportation (NCDOT), in partnership with local governments, will fund and prioritize transportation projects in the state of North Carolina. The Strategic Transportation Investment Formula allocates funding at the statewide, regional and division tiers. Prioritization 3.0 was the process used to determine the projects that are to be funded in the State's Transportation Improvement Program (STIP). The adopted 2016-2025 State Transportation Improvement Program includes several projects on College Road.

U-5704: Construction of an interchange at College Road and Oleander Drive

U-5702: Construction of Access Management Improvements on College Road between Gordon Road and Carolina Beach Road. The Department has several spot safety and intersection improvements that are anticipated would be completed under this project. This project may also include median modifications, access management strategies, etc. to improve traffic flow and safety on College Road. Another project that may be funded in the Statewide Mobility Category is an Upgrade of College Road between New Centre Drive and Gordon Road to include an additional through lane and an interchange at College Road and the Martin Luther King Jr. Parkway.

U-5792: Convert at-grade intersection to interchange

#### **Next Steps:**

• Complete Planning, Environmental Review and Design for the projects

#### **METROPOLITAN TRANSPORTATION PLAN**

Project Description/Scope: Update the Federally-mandated Metropolitan Transportation Plan/Long-Range Transportation Plan for the Wilmington Urban Area Metropolitan Planning Organization. The draft plan was finalized by the Transportation Advisory Committee on July 22, 2015. The Agreement with NCDOT for the full-time TDM Coordinator position was approved on November 4, 2015. The Wilmington MPO has hired a full-time TDM Coordinator.

#### MAYOR'S RAIL RE-ALIGNMENT TASK FORCE

The City of Wilmington has appointed a Mayor's Task Force to evaluate the feasibility of re-aligning the rail line that currently traverses the City of Wilmington and potentially re-purpose this rail line for another use. This project is jointly funded by the City of Wilmington and Wilmington MPO. It is anticipated that NCDOT will also contribute towards the completion of the study. On January 21<sup>st</sup>, the City released a Request for Proposals for a consultant to complete the feasibility study. The City received 3 proposals. The Task Force reviewed the proposals and interviewed all 3 firms. The Task Force met on April 7<sup>th</sup> to discuss the selection of a firm to complete the study.

# Cape Fear Public Transportation Authority Project Update April 2016

- 1. Bus fleet replacement & conversion to CNG identifying state and federal funding opportunities to replace 19 thirty-five foot buses. Bid awarded to Gillig, LLC on June 26, 2014. Two buses delivered in June 2015. FTA issued a Notice of Funding Availability (NOFA) on March 25, 2016 for 49 CFR §5339(b) and §5339(c) bus and bus facility grants equaling \$266M nationally. Wave Transit is coordinating with NCDOT and state transit agencies to develop a consolidated application for replacement bus funding.
- 2. Wilmington Multimodal Transportation Center Interlocal Agreement between Authority, City of Wilmington, WMPO and NCDOT finalized. Demolition of Haul building scheduled for April 2016. The Authority is working to complete NEPA Document, stabilize Neuwirth Brothers and Thomas Grocery buildings, and design and construct transit portion of WMMTC. The NEPA RFP is scheduled to be let on April 14, 2016. A community stake holder meeting is scheduled for Wednesday, April 6th from 5:30 pm to 6:30 pm at the Brooklyn Arts Center to discuss the impact of the project on Downtown Wilmington. Preliminary completion date for construction of the facility is late 2017.
- 3. Short Range Transportation Plan (no significant change) following adoption of Cape Fear Transportation 2040 by the Wilmington Metropolitan Planning Organization (WMPO), Wave Transit is preparing to begin its latest short range plan. The plan will set a course for public transportation initiatives, route structure and revenue programming for the next five years. The plan will also include a financial element to ensure that transit programs are compliant with FTA rules and regulations.

  Under the direction of the Authority's Operations and Planning Committee made up of Board members, staff, WMPO planners, passengers, interested citizens, and professional transit planning consultants, the 12-18 month plan is an important tool in meeting the public transportation needs of the community. Marketing, public relations and community support for financing transit in Southeastern North Carolina will also be a focus of the plan. A key component of the plan will be extensive surveying to assess the needs of current and prospective passengers.
- **4.** Long Term Funding (no significant change) currently, the Authority does not have a dedicated source of local funding. An initiative to analyze long term revenue stability of Wave Transit has also been proposed by the City of Wilmington. This effort is critical to the long term financial health of the Authority. No timetable for the analysis has been developed.
- 5. Shelter Program (no significant change) a program to replace and add up to 50 bus shelters and 25 benches at bus stops is nearing construction. Partial funding has been identified. Engineering and design are underway as is permit acquisition. Depending on site requirements, bus shelters can exceed \$15,000 per location. The first shelter is scheduled to be constructed in April 2016.
