1. Call to Order

Mr. Doetsch called the meeting to order at 3:00pm.

2. Conflict of Interest Reminder

Mr. Doetsch asked if any members had a conflict of interest with any items on the meeting agenda. No members reported having a conflict of interest.

3. Approval of Agenda

Mr. Williams made the motion to approve the agenda for today's meeting. Mr. Piepmeyer seconded the motion and it carried unanimously.

4. Approval of Minutes

The minutes for the March 14, 2016 workshop meeting and the May 25, 2016 regular meeting were approved unanimously.

5. Public Comment Period

No one wished to speak during the Public Comment Period.

6. Presentation

a. <u>Economic Impacts of Airports in NC and the Wilmington region- Julie Wilsey, Airport Director</u> for the Wilmington International Airport

Ms. Wilsey, Director of the Wilmington International Airport gave a presentation on the economic impacts of airports in North Carolina and how they servet the Wilmington region. A brief question/answer period followed.

7. Consent Agenda

- b. Resolution approving the STIP/MTIP Amendments (April and May)
- c. Resolution approving the STIP/MTIP Administrative Modifications (May)

d. Opening of the 30-day public comment period for STIP/MTIP Amendments (June)

e. Resolution authorizing the deletion of U-5534R (Doral Drive sidewalk) and returning the funding to the STP-DA program

Ms. Batleman made the motion to approve consent agenda. Mr. Breault seconded the motion and it carried unanimously.

8. Regular Agenda

a. Resolution approving point sharing for the Local Input Point Assignment

Ms. Motsinger told members that NCDOT allows point sharing to occur between MPOs and RPOs if mutually agreed upon between both organizations. She said the Cape Fear RPO expressed a desire to share points with the Wilmington MPO. The resolution supports the transfer of points from the RPO to the MPO.

Mr. Watkins made the motion to approve point sharing for the Local Regional Point Assignment. Mr. Williams seconded the motion and it carried unanimously.

9. Resolution approving the Wilmington Urban Area MPO's Regional Local Input Point Assignment

Ms. Motsinger reviewed the process involved for the local point assignment. She noted that the MPO will allocate 1,500 points at the Regional tier and 1,500 points at the Division tier. Using the adopted Local Input Methodology for Prioritization 4.0, projects were reviewed and assigned a draft ranking and scoring. Ms. Motsinger noted that only the Regional tier point assignment was in the TAC's packet for consideration at this month's meeting and that the Division tier point assignment would come at a future date.

Ms. Motsinger told members that last month TAC members opened the public comment period for the Regional Local Point Assignment. During that time, staff received comments from the Pender County Planning Department director regarding the P 4.0 preliminary scores and data. They requested that the WMPO coordinate with Division 2 and 3 and the RPO regarding point sharing for the Hampstead Bypass.

Ms. Motsinger stated that if RPO decides to donate 89 points to the MPO, those points will be allocated to the US 74/US 76 project, contingent upon the approval and donation of the points.

Ms. Motsinger told members that staff also did a preliminary analysis based on consulting with all the MPOs, RPOs and Divisions in Region B asking how they anticipate allocating their local points. Based on staff's preliminary analysis, the proposed Regional Local Point Assignment would allow for several WMPO projects to receive funding in the Regional Tier. The projects include: intersection improvement at Market Street and New Center Drive, Route 201 Transit Amenities, Front Street widening, Intersection improvements at Castle Hayne Road and N 23rd Street, and partial funding for a section of the Hampstead Bypass. She noted that the analysis was very preliminary and that the results could change.

Mr. Piepmeyer told members that the Pender County Commissioners would like to have 100% funding for the Hampstead Bypass, but the partial funding will show further commitment to the bypass project. It will allow land to be purchased and help move the Northern portion forward.

Mr. Watkins said from a regional prospective, the Northern portion will help take some of the pressure off US 17. Mr. Piepmeyer told members that it will also offer an option for beach evacuation to I-40 and for a more direct route between Sunny Point and Camp Lejeune.

Mr. Williams made the motion to approve the Wilmington Urban Area MPO's Regional Local Point Assignment. Mr. Breault seconded the motion and it carried with 8 members voting in favor. Ms. Batleman voted against the motion.

10. Discussion

a. Wilmington Downtown Greenway Phase I

Ms. Motsinger told members that staff is working with the City of Wilmington and NCDOT Rail Division to develop a master plan for the inactive rail corridor between 3rd and McCrae Streets. Thanks to Senator Lee, Senate Bill 174 allows the City and NCDOT to enter into a lease agreement for that portion of rail right-of-way. Staff will be working to create a master plan for the project.

Mr. Kozlosky told members that staff wanted to make TAC members aware that the master plan will be completed "in-house" and staff will be assisting the City of Wilmington in that effort.

b. <u>Strategic Business Plan Development – Possible Meeting on July 13th from 2 to 4pm</u>

Mr. Kozlosky told members that during discussions with the Chair and Vice-chair regarding the development of the strategic business plan, it was suggested that members hold a worksession to continue that work. He suggested meeting on July 13th from 2 to 4pm.

Following a brief discussion, Mr. Piepmeyer made the motion to amend the meeting calendar to add the July 13th meeting. Ms. Swearingen seconded the motion and it carried unanimously.

c. Cape Fear Public Transportation Funding

Mr. Kozlosky told members that staff is seeking direction from the Board on how to proceed regarding the funding request from Cape Fear Public Transportation Authority (CFPTA). He said CFPTA believe this will be a one-time infusion to replace some of the Rural General Public (RGP) funding that was lost because of the county was designated as urban rather than rural.

Mr. Williams asked what is the current percentage of STP-DA money that goes to mass transit. Mr. Kozlosky told members that the modal target investment strategy for mass transportation is 20%, which equates to \$459,000. However the Authority only requested \$350,000, so there is sufficient capacity in the STP-DA program to cover this request.

Following a brief discussion, Mr. Watkins made the motion to request that staff bring a resolution of support for the allocation of additional funds to CFPTA to the next meeting. Ms. Swearingen seconded the motion and it carried unanimously

11. Updates

RESOLUTION REQUESTING FUNDING ASSISTANCE

WHEREAS, the Cape Fear Public Transportation Authority was created in July 2004 by Joint Resolution of the City of Wilmington and New Hanover County to provide public transportation services throughout the adopted boundary of the Wilmington Urban Area; and

WHEREAS, the Wilmington Urban Area Metropolitan Planning Organization provides transportation planning services for the City of Wilmington, Town of Carolina Beach, Town of Kure Beach, Town of Wrightsville Beach, Town of Belville, Town of Leland, Town of Navassa, New Hanover County, Brunswick County, Pender County, Cape Fear Public Transportation Authority and the North Carolina Board of Transportation; and

WHEREAS, urbanization of the region has led to a loss in funding under the Rural General Public (RGP) program administered by NCDOT; and

WHEREAS, RGP funding has been used to provide revenue for Route 207 which served an area that was classified as rural prior to the 2010 census; and

WHEREAS, New Hanover County has included additional financial assistance to offset a portion of the loss in RGP funding; and

WHEREAS, gap funding to continue the level of service in the unincorporated areas of New Hanover County for FY 2017 has been estimated at \$75,000;

NOW THEREFORE BE IT RESOLVED that the Cape Fear Public Transportation Authority respectfully requests consideration by the Wilmington Urban Area Metropolitan Planning Organization Transportation Advisory Committee for increased funding under the FY 2017 Surface Transportation Program - Directly Attributable (STP-DA) of \$75,000.

WHEREAS, the Wilmington Urban Area Metropolitan Planning Organization provides transportation planning services for the City of Wilmington, Town of Carolina Beach, Town of Kure Beach, Town of Wrightsville Beach, Town of Belville, Town of Leland, Town of Navassa, New Hanover County, Brunswick County, Pender County, Cape Fear Public Transportation Authority and the North Carolina Board of Transportation; and

WHEREAS, the Rural General Public (RGP) funds are administered by the North Carolina Department of Transportation and are used to provide public transportation service to rural parts of the state; and

WHEREAS, urbanization of the region has led to a loss in RGP funding; and

WHEREAS, New Hanover County included additional funding assistance in their FY 2017 budget to offset a portion of the loss in RGP funding; and

WHEREAS, a gap still remains and there is a need for funding in the amount of \$75,000 to continue the current level of service to the unincorporated areas of New Hanover County for FY 2017; and

WHEREAS, on June 23, 2016 the Cape Fear Public Transportation Authority requested the Wilmington Urban Area MPO consider increasing the funding under the FY 2017 Surface Transportation Program-Direct Attributable in the amount of \$75,000; and

WHEREAS, sufficient funds exist to accommodate this request.

NOW THEREFORE, be it resolved that the Board of the Wilmington Urban Area Metropolitan Planning Organization hereby supports the allocation STP-DA funding in the amount of \$75,000 to the Cape Fear Public Transportation Authority to continue the current level of service to the unincorporated areas of New Hanover County.

Introduction

In compliance with Federal law and in the spirit of cooperation, the Wilmington Urban Area conducts a "cooperative, comprehensive, and continuing...." transportation planning process. This Planning Work Program (PWP) outlines the tasks and associated funding sources dedicated to the Wilmington Urban Area MPO transportation planning process during fiscal year 2016-2017. Depending on the specific funding source, tasks funded through the PWP are eligible for reimbursement of 80-90% of their cost from the Federal Highway Administration and Federal Transit Administration through the North Carolina Department of Transportation.

The PWP for the Wilmington Urban Area identifies four separate funding sources for Urban Area transportation planning. A brief description of these funding sources follows:

- -Statewide Planning and Research Programs (SPR)-These funds are used by NCDOT to conduct work for the Wilmington Urban Area MPO.
- -Federal Highway Administration Section 104(f) Funds-These funds are dedicated to the urban area to perform transportation planning. They require a 20% local match.
- -Federal Transit Administration Section 5303 Funds-These funds are used for transit planning in the urban area. The Federal Transit Administration provides 80% of these funds, NCDOT 10%, and there is a required 10% local match.
- -Surface Transportation Program-Direct Attributable Funds- These funds are dedicated to Transportation Management Areas and these funds can be used to perform transportation planning. They require a 20% local match.

The local match requirements will be shared by all members of the Wilmington Urban Area MPO in direct proportion to population as defined in the Wilmington Urban Area MPO Memorandum of Understanding.

<u>II-A2 Vehicle Miles of Travel-</u> Establish VMT as measure of effectiveness of transportation system. Measure the VMT with the new travel demand model.

II-A3 Street System Changes- No tasks foreseen.



WMPO FY 2016 STP-DA & TAP-DA FUNDING ALLOCATION








WMPO FY 2016 STP-DA & TAP-DA FUNDING ALLOCATION



MODAL INVESTMENT TARGETS



PROJECT STATUS REPORT

July 1, 2016

Project Description

Roadway extending from the vicinity of US 17 Bypass and I-140 in Brunswick County to US 421 in New Hanover County, including a crossing of the Cape Fear River.

Current Status

The following list includes completed and ongoing tasks during the month of June:

- The project team continues to coordinate and correspond with project stakeholders.
- Hydraulic analysis of the Detailed Study Alternatives (DSAs) is currently being reviewed by NCDOT.
- The Draft Hurricane Evacuation Analysis Technical Memorandum has been reviewed by the New Hanover and Brunswick County emergency management departments. Comments from NCDOT are currently being reviewed and incorporated.
- The Historic Architecture Eligibility Report has been accepted by NCDOT and reviewed by the North Carolina State Historic Preservation Office (SHPO). An updated eligibility report has been sent to SHPO for review. The project team will meet with SHPO in the next few months to determine potential effects to these resources from the 12 DSAs.
- Updates to the project website are ongoing.
- Studies for the Traffic Noise Analysis and Air Quality Analysis are ongoing.
- An update to the Draft Natural Resources Technical Report is ongoing.
- A Sea Level Rise Assessment of the DSAs is ongoing.
- An update to the Archaeological Predictive Model is ongoing.
- Right-of-Way cost estimates and relocation reports have been initiated.
- NCDOT is currently evaluating an additional alternative proposed by the WMPO near the Port of Wilmington. There
 are currently 12 alternatives being designed and evaluated for inclusion in the draft environmental document.
 NCDOT is coordinating with the NCSPA regarding this alternative; if it is determined this alternative is reasonable,
 studies may need to be redone to include this alternative.
- The Cape Fear Crossing project is programmed in the 2016-2025 STIP for planning and environmental studies only using STPDA funding from the Wilmington MPO.
- The project team will plan to present the status of the project to the WMPO TAC before the next NEPA/Section 404
 Merger Team Meeting.

WILMINGTON MPO TRANSPORTATION PLANNING JUNE 2016

CONGESTION MANAGEMENT PROCESS

Project Description/Scope: Comply with a Federal mandate to create and adopt a process to evaluate the region's most congested corridors through locally-defined multi-modal performance measures in an effort to suggest improvements that would alleviate traffic congestion in the region. The CMP was adopted by the TAC on December 11, 2013. Data collection procedures have been developed. A schedule for collection logistics has been drafted and data collection will continuously be monitored and updated as needed.

Next Steps:

- Continue data collection and monitoring of congestion
- Document data collection in a Biennial Report

COLLEGE ROAD UPGRADES (U-5702), (U-5704) and (U-5792)

Project Description/Scope: The Strategic Transportation Investments is a new formula to determine how the North Carolina Department of Transportation (NCDOT), in partnership with local governments, will fund and prioritize transportation projects in the state of North Carolina. The Strategic Transportation Investment Formula allocates funding at the statewide, regional and division tiers. Prioritization 3.0 was the process used to determine the projects that are to be funded in the State's Transportation Improvement Program (STIP). The adopted 2016-2025 State Transportation Improvement Program includes several projects on College Road.

U-5704: Construction of an interchange at College Road and Oleander Drive

U-5702: Construction of Access Management Improvements on College Road between Gordon Road and Carolina Beach Road. The Department has several spot safety and intersection improvements that are anticipated would be completed under this project. This project may also include median modifications, access management strategies, etc. to improve traffic flow and safety on College Road. Another project that may be funded in the Statewide Mobility Category is an Upgrade of College Road between New Centre Drive and Gordon Road to include an additional through lane and an interchange at College Road and the Martin Luther King Jr. Parkway.

U-5792: Convert at-grade intersection to interchange

METROPOLITAN TRANSPORTATION PLAN

TRANSPORTATION DEMAND MANAGEMENT PROGRAM

Project Description/Scope: UNCW is taking the role as lead employer for the Cape Fear region. The WMPO will coordinate with UNCW to work with other major employers in the region to identify opportunities for public outreach, marketing, carpooling, vanpooling, alternative/compressed work schedules, Emergency Guaranteed Ride Home, park and ride lots, etc. The MPO established 2 park and ride lots in Brunswick County and a ridesharing program that began on January 5, 2015. The MPO adopted "Work Cape Fear: Expanding Commuter Options in the Cape Fear Region" TDM Short Range Plan on January 28, 2015 and also authorized staff to apply for a TDM grant through NCDOT that if approved would fund a full-time TDM Coordinator position. The Agreement with NCDOT for the full-time TDM Coordinator position was approved on November 4, 2015. The Wilmington MPO has hired a full-time TDM Coordinator.

Next Steps:

- Continue regularly scheduled TDM Committee meetings
- Review responses from the marketing plan RFP and make a recommendation to hire a marketing firm
- Develop program brand (name and logo)
- Partner with schools in WMPO jurisdiction to provide carpool opportunities to parents

MAYOR'S RAIL RE-ALIGNMENT TASK FORCE

The City of Wilmington has appointed a Mayor's Task Force to evaluate the feasibility of re-aligning the rail line that currently traverses the City of Wilmington and potentially re-purpose this rail line for another use. This project is jointly funded by the City of Wilmington, North Carolina Department of Transportation and Wilmington MPO. All three entities have agreed to participate financially in the study. The City will contract with Moffatt & Nichol to complete the study. A steering committee project kick-off meeting was held on July 15th.

Cape Fear Public Transportation Authority Project Update July 2016

- 1. Bus fleet replacement & conversion to CNG (no change) identifying state and federal funding opportunities to replace 19 thirty-five foot buses. Bid awarded to Gillig, LLC on June 26, 2014FTA issued a Notice of Funding Availability (NOFA) on March 25, 2016 for 49 CFR §5339(c) bus and bus facility grants equaling for lo and no emission buses. Wave Transit has applied for grant funding in the amount of \$4.6M for ten replacement buses. Award is expected in the summer of 2016.
- 2. Wilmington Multimodal Transportation Center Interlocal Agreement between Authority, City of Wilmington, WMPO and NCDOT finalized. Demolition of Haul building has been completed. The Authority is working to complete NEPA Document, stabilize Neuwirth Brothers and Thomas Grocery buildings, and design and construct transit portion of WMMTC. A contract with John Davenport Engineering for the NEPA document was approved on June 23, 2016. The environmental document is expected to take approximately 6 weeks. Transfer of the property is currently underway.
- 3. Short Range Transportation Plan (no significant change) following adoption of Cape Fear Transportation 2040 by the Wilmington Metropolitan Planning Organization (WMPO), Wave Transit is preparing to begin its latest short range plan. The plan will set a course for public transportation initiatives, route structure and revenue programming for the next five years. The plan will also include a financial element to ensure that transit programs are compliant with FTA rules and regulations.
 Under the direction of the Authority's Operations and Planning Committee made up of Board members, staff, WMPO planners, passengers, interested citizens, and professional transit planning consultants, the 12-18 month plan is an important tool in meeting the public transportation needs of the community. Marketing, public relations and community support for financing transit in Southeastern North Carolina will also be a focus of the plan. A key component of the plan will be extensive surveying to assess the needs of current and prospective passengers.
- **4. Long Term Funding** (no change) currently, the Authority does not have a dedicated source of local funding. An initiative to analyze long term revenue stability of Wave Transit has also been proposed by the City of Wilmington. This effort is critical to the long term financial health of the Authority. No timetable for the analysis has been developed.
- 5. **Shelter Program** a program to replace and add up to 50 bus shelters and 25 benches at bus stops is nearing construction. A contract to install five shelters was awarded to Paragon Building Corp. on May 26, 2016. Construction of the first five shelters is underway.
- Short Term Funding (no significant change) as reported to the WMPO TAC in May, significant reduction in state funding has left the routes to South College Road and

Pleasure Island in jeopardy. New Hanover County has agreed to increase its contribution by \$55,000 annually if the Authority can identify the remainder of the funding needed to continue the routes. Gap funding is estimated to be \$75,000. A Resolution formally requesting gap funding from the WMPO in STP-DA funding in the amount of \$75,000 was adopted by the Authority on June 23, 2016 and transmitted to the WMPO for consideration.
