1. Call to order

• C. Stein called the meeting to order.

2. Approval of the agenda

• Motion to approve by P. Boykin, second by S. Whitney. Approved.

3. Public Comment Period

- There was one sign-in for the public comment period.
- B. McLelland discussed the E-bike ordinance and different classes identified. He noted
 that a lot of e-bikes are created using aftermarket parts and do not fit any of the
 classifications and language to address that could be included.
- B. McLelland also noted that helmet requirements are identified in state laws and Ebicycles are identified as bikes in those documents
- B. McLelland wanted to make sure that the ordinance was defendable and clear

4. Approval of minutes from December 11th, 2019

Motion to approve by K. Ryan, second by P. Boykin. Approved

5. Presentation

- H. Cockburn with the NCDOT Integrated Mobility Division presented on the new complete street policy.
- The new integrated mobility division and complete street policy is expected to streamline the inclusion of alternative transportation options in all projects.
- The new complete street policy means that it is even more important to include multimodal projects in comprehensive and long range plans to ensure they are funded.

- N. Cannon questioned how the NCDOT would measure performance on new projects and how they would prioritize improvements and H. Cockburn stated that solutions would have to be context sensitive to each project.
- S. Whitney asked about updated road standards, and H. Cockburn noted that standards are currently being updated and are continually updated to include additional transportation standards to accommodate multimodal infrastructure.
- K. Mills asked about future enforcement and H. Cockburn noted that local jurisdictions are responsible for enforcement.
- M. Lindquist asked if NCDOT provides support for the creation of local bicycle and pedestrian committees, and H. Cockburn noted that she would email her additional information.
- N. Cannon presented on the Be A Looker campaign report
- N. Cannon described the outreach efforts and noted that 285 citizens took the pledge to be a looker.

- The draft E-Bicycle modal ordinance was provided to members and will be adopted by TCC and the Board and create a resolution for local jurisdictions to adopt.
- M. Lindquist motioned to approve the ordinance and S. Whitney seconded. All approved.

- A. Schroetel noted that it is important to communicate with developer's community bicycle and pedestrian infrastructure goals.

- N. Cannon updated the group on Bike Share progress, Zagster's contract was terminated and a committee will be created to help find another bike share vendor.
