1. Call to order

• C. Stein called the meeting to order.

2. Approval of the agenda

• Motion to approve by A. Schroetel, second by P. Boykin. Approved.

3. Public Comment Period

- There were two sign-ins for the public comment period.
- Bill Graham introduced himself as the CEO of the Renaissance Wilmington Foundation
 and gave his background. He stated that he wanted to make the Committee aware of a
 public interest group that his foundation is trying to create. The group would focus on
 bicycling and bicycling safety in the area. He also wanted to make the Committee aware
 of what actions should be taken, including protected bike lanes and helmet laws.
 Graham introduced Steven Burnett, a local bicyclist from Wrightsville Beach.
- Bruce McLellan addressed the Committee regarding the E-Bicycle Ordinance. He stated
 his belief that the paragraph requiring helmets should be removed. McLellan
 emphasized that, although helmets are a good idea, enforcing the use of helmets by ecyclists would be difficult and place an unnecessary burden on law enforcement.

4. Approval of minutes from October 8th, 2019

• Motion to approve by K. Ryan, second by M. Linquist. Approved

5. Old Business

- N. Cannon presented the E-Bicycle Model Ordinance, which defines what an e-bicycle is, where they can and cannot be ridden, and other requirements of e-cyclists.
- A. Lorenzo stated that the next steps are to ask the WMPO's Technical Coordinating Committee (TCC) to form a subcommittee to review the Model Ordinance from a planning perspective. Any recommendations from the TCC would be brought back to this Committee before moving forward. Finally, the WMPO Board would pass a resolution endorsing it as a model ordinance.
- A. Schroetel stated that he was concerned about including the requirement for helmets, as he does not see this as enforceable. He also stated that it needs to be clear that the Category 2 and 3 e-bicycles can be ridden to parks, just not in the parks.
- B. Sutton stated that he thought the requirement to wear a helmet should be left in the
 model ordinance for safety and liability reasons, but that the enforcement piece could
 be removed. A. Lorenzo emphasized that bicycling safety is an important goal of the
 WMPO and that the enforcement of the helmet requirement could be left up to each
 individual member jurisdiction that may adopt the ordinance.
- J. Boyd stated that the enforcement piece should remain in the model ordinance, because member jurisdictions who may eventually adopt the ordinance may not think to include it otherwise. Others agreed to leave in the enforcement piece, stating that the ordinance is a model and individual jurisdictions would have the option to remove it.
- Motion to refer the E-Bicycle Model Ordinance as written, with the comments made, to the TCC for review and recommendations by K. Mills, second by K. Ryan. All were in favor.

6. New Business

- Motion to approve the 2020 Meeting Schedule by K. Ryan, second by M. Linquist. All were in favor.
- Motion to approve the 2020 Work Plan by A. Schroetel, second by J. Boyd. All were in favor.
- A. Lorenzo proposed re-electing Carol as Chair and Katie as Vice-Chair. Both accepted.
 Motion to appoint Carol Stein as Chair for the 2020 calendar year by A. Lorenzo, second by M. Linquist. All were in favor. Motion to appoint Katie Ryan as Vice-Chair for the 2020 calendar year by A. Lorenzo, second by P. Boykin. All were in favor.
- N. Cannon reported that the Go Coast website is up and running, but not yet live. It has been approved by the WMPO Board and will be live on January 6th. The "Be a Looker" campaign report was too large to email out but will be on the Go Coast website. Once live, he will send a link to everyone. He also reported that 285 people took the "Be a Looker" pledge and that the pledge will continue to be made available. He stated that funds for these types of campaigns are available on a year-to-year basis.
- N. Cannon gave an update on the 2020 River to Sea Bike Ride. He stated that there will be a subcommittee for planning this event. He also stated that the date isn't set yet, but the event typically occurs on the first Saturday of May, which would be May 2nd, 2020.

N. Cannon recommended capping the ride. Over 600 people registered online last year, but only about 400 showed up. N. Cannon stated that 600 people would have been too many. In order to cap the ride, and have everyone who signed up show up, N. Cannon suggested a small registration fee. A. Lorenzo stated that the WMPO Board agrees with capping the ride at 500 but does not want to charge a fee to participate. N. Cannon stated that law enforcement, which provides free support for the event, recommended capping at around 400 participants. N. Cannon will send out an email with a date by which committee members should volunteer, if they would like to join the subcommittee.

7. Updates and Announcements

- C. Stein provided a recap of the Bike Walk NC Summit 2019, which she attended in Winston-Salem in November. M. Linquist and Sam Spencer also attended. C. Stein will send a link to A. Lorenzo with a list of speakers and the topics covered, which included first mile/last mile connections, bike share, scooters and e-bicycles, etc.
- N. Cannon provided an update on the Wilmington Bike Share. He reported that Zagster
 was unable to provide a no-cost bike share solution to the City of Wilmington as
 required by the contract. Zagster is now being unresponsive to emails regarding
 cancellation of the contract. The contract automatically expires in May, but N. Cannon is
 working to actively cancel the contract so that the City can release an RFP to find
 another vendor.
- A. Schroetel updated the group on the Cape Fear Cyclists. He noted that the organization has been trying to rebuild their bicycling education capacity for some time, which is why they created a scholarship for League Certified Instructor (LCI) certification through the League of American Bicyclists. He reported that, in addition to Tammy Brown and scholarship recipient Dusty Casteen with Switchin' Gears, there is an LCI with UNCW now, Leah Mayo. By rebuilding their bicycling education capacity, the organization hopes to help local jurisdictions with helmet fittings and bike rides. A. Schroetel reported that the Cape Fear Cyclists recently did a bike rodeo with New Covenant Holiness Church. He also noted that NCDOT has a bike helmet initiative through which communities can get free helmets and that the application deadline is January 6th, 2020.
- A. Lorenzo announced the NCDOT Watch for Me NC 2020 call for applications, which are due by January 31st, 2021. She noted that communities selected for this program will receive free law enforcement training, technical assistance, and safety tools. Committee members interested should talk to their member jurisdictions. There will be a webinar offered by NCDOT on December 16th at 11am. A. Lorenzo can forward information about the webinar to anyone interested. She will also forward the email about the program that was sent to the WMPO Board and TCC members. N. Cannon noted that the program is largely a law enforcement-led initiative.
- C. Stein announced the next meeting of the WMPO Technical Coordinating Committee (TCC), which will be held on Wednesday, January 15th, 2020 at 10am.
- C. Stein announced that the next WMPO Board Meeting will be held Wednesday,
 January 22nd, 2020 at 3pm in the 6th Floor Conference Room at 320 Chestnut Street.

WMPO Bicycle and Pedestrian Advisory Committee Model Electric Bicycle Ordinance

The purpose of this model ordnance is to provide clarity on how electric bicycles may be regulated in any of the WMPO Member Jurisdictions. This document provides guidelines on how e-bikes must be equipped and operated in order to protect the safety of e-bike operators, the riders of traditional bicyclists, and pedestrians.

Commented [NC1]: Statement of purpose

A. Applicability

- i. The provisions of this section shall apply to all public land and right of way.
- It is at the discretion of the member jurisdiction to review and determine what public parks and gardens shall permit Classes 1 and 2 Electric Bicycles to be ridden on paths and trails.

B. Definitions

- i. Electric bicycle or electric-assist bicycle: a bicycle that uses an electric component to augment human power. The Consumer Product Safety Act (H.R. 727) defines a "low speed electric bicycle" as "a two or three wheeled vehicle with fully operable pedals and an electric motor of less than 750 watts (1 h.p.), whose maximum speed on a paved level surface, when powered solely by such a motor while ridden by an operator who weighs 170 points, is less than 20 mph." The styles of e-bikes vary and can be classified in three ways.
- ii. Class 1 Electric Bicycle: a bicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the bicycle reaches a speed of 20 miles per hour or greater.
- iii. Class 2 Electric Bicycle: a bicycle that is equipped with a motor that may be used exclusively to propel the bicycle, and that is not capable of providing assistance when the bicycle reaches speeds of 20 miles per hour or greater.
- iv. Class 3 Electric Bicycle: a bicycle equipped with a motor that provides assistance only when the rider is pedaling, and that ceases to provide assistance when the bicycle reaches a speed of 28 miles per hour or greater and is equipped with a speedometer.

For all classes, the maximum power output is 750 watts. Manufacturers and distributors of electric bicycles are required to apply a class identification label to each electric bicycle.

C. Regulations pertaining to riding electric bicycles on public facilities

i. The top priority of these regulations is safety. Class 1 and 2 bicycles are permitted to travel anywhere traditional bikes are permitted, as maximum assisted speeds of these vehicles is similar to the speeds traveled by traditional bicycles. Class 3 electric bicycles may be

ridded on streets and roadways where traditional bicycles are permitted, including bicycle lanes, but are restricted from slower speed areas such as multiuse paths and sidewalks.

- Electric bicycles that are in class 1 and 2 are permitted to be ridden on designated off-road bicycle routes, designated park trails, multiuse paths and greenways, as well as the public roadway.
- iii. Electric bicycles in class 3 are not permitted on any off-road facility including unpaved park trails, sidewalks and multiuse paths. Class 3 electric bicycles are only permitted to be ridden on the public roadway, excluding fully controlled access highways.
- iv. Because of an electric bicycle's ability to reach speeds of 20 miles per hour with little to no pedal effort, every person operating any form of electric bicycle shall wear a helmet or hard-shell head cover secured to the head by a strap or retention device that complies with Federal Motor Vehicle Safety Standard 2018. The failure to wear a helmet shall be considered an infraction and is subject to a penalty of twenty-five dollars and fifty cents (\$25.50) plus the following court costs. This figure is derived from Chapter 20-140.4 of the North Carolina General Statutes pertaining to the operation of mopeds.
- v. Every person operating any form of electric bicycle on the public right of way must follow all bicycling traffic laws provided in Chapter 20 of the North Carolina General Statutes.

WILMINGTON URBAN AREA MPO FEBRUARY 2020

2045 METROPOLITAN TRANSPORTATION PLAN

Project Description/Scope: The Wilmington Urban Area Metropolitan Planning Organization is required by federal law to update the Metropolitan Transportation Plan every 5 years. The last plan was adopted by the MPO Board on November 18, 2015. The next update is required to be adopted by November 2020. This plan will guide the regional transportation priorities and actions, and be used for project selection in the State/Metropolitan Transportation Improvement Programs. The MPO Board appointed a Citizen Advisory Committee (CAC) to help guide the development of this plan. A four month public outreach period was held between April 3, 2018 and July 31, 2018. During this period, there were 2,287 transportation survey responses, 563 comments on the public input map tool, and 4,554 votes on map comments, totaling 7,404 responses collected. In July 2018, the six modal subcommittees began meeting with the initial task of developing modal goals and objectives, which were completed in October 2018 and officially adopted by the Board in November 2018. The Modal Subcommittees have completed scoring criteria, evaluation of projects and development of the draft policies. The CAC, TCC and Board received the financial forecasts and potential alternative funding sources in March 2019. The consultant completed the project cost estimates and alternative funding forecasts in June 2019. A red line, fiscal constraint analysis of ranked modal projects were prepared and presented by staff to the CAC, TCC, and Board in July. The WMPO Board proposed changes at its August meeting and adopted a resolution endorsing the amended draft project lists in September 2019. In November 2019 the Board passed a resolution to include the estimated toll revenues for the Cape Fear Crossing project within the fiscally constrained projects list as a supported alternative form of funding. WMPO planning staff is working on finalizing draft plan.

Next Steps:

- Release of draft plan to public in March 2020 for 30-day public comment period
- Revisions to draft plan based on public comments and approval by WMPO Board in Spring 2020
- Presentation of plan to WMPO members in Summer 2020
- Adoption of final plan in October 2020

U-5534C - WRIGHTSVILLE AVENUE/GREENVILLE AVENUE TO HINTON AVENUE

Project Descriptions/Scope: The project is for construction of intersection re-alignment improvements at the intersection of Wrightsville Avenue/Greenville Avenue and bike lanes and sidewalks along Greenville Avenue from Wrightsville Avenue to Hinton Avenue.

Project Status and Next Steps:

- Complete review of final design package and submit to NCDOT for review—Spring 2020
- NCDOT final design approval and City to request Construction Funds Authorization Summer 2020
- Begin Construction Late 2020

U-5534D - TOWN OF LELAND - OLD FAYETTEVILLE ROAD MUP

Project Descriptions/Scope: This project is for design and construction of a ten foot (10') wide multi use path, separate but adjacent to Old Fayetteville Road, beginning at or around the corner of the Leland Town Hall Campus and ending at the driveway of the North Brunswick High School.

Project Status and Next Steps:

- ROW certification has been issued
- Construction funds have been requested for release
- Updated PCE approved on December 4, 2018
- Davenport identified potential utility conflicts; The Town has authorized Level A S.U.E. services
 to be performed to verify where conflicts exist; AECOM will revise plans to reflect any utility
 relocations that must be done; revised plans must then be approved by NCDOT.
- Supplemental underground utility conflict drawings were sent to Ron VanCleef on September 30, 2019 and these drawings were approved on October 17, 2019.
- Supplemental Agreement #3 dated March 28, 2019 extends project completion deadline to July 1, 2020.
- On November 21, 2019, MPO requested DOT to issue Supplemental Agreement #4 to provide supplemental appropriation of federal funds for the additional amount of \$517,477 with an additional local match for the amount of \$129,370. The Town also requested an extension of the project completion deadline to June 30, 2021. The Town is waiting on Supplemental Agreement #4.

- Town sent the following documents to Ron VanCleef on November 12, 2019: VCER-1 Form, NPDES Stormwater Certification, DOT Encroachment Agreement with plans. Waiting to receive signed encroachment agreement from DOT.
- Received plan comments from NCDOT's Traffic Engineering Division pertaining to the encroachment agreement plans. AECOM will address the comments and send revisions for approval.
- Bid and award timeline will depend upon receipt of signed encroachment agreement and Supplemental Agreement #4; prefer to bid this and projects U-5534I, J and K at the same time.

U-5534N -CITY OF WILMINGTON- SHIPYARD BOULEVARD SIDEWALK

Project Description/Scope: The construction of a sidewalk and bus pull-out along Shipyard Boulevard between Vance Street and Rutledge Drive. This will be a partnership between the City of Wilmington, Cape Fear Public Transportation Authority and Wilmington MPO. The project consists of building a bus turn out and sidewalk along US 117 (shipyard Boulevard) from Vance Street to Rutledge Drive in Wilmington. Carolina Civil Works, Inc was awarded the \$352,590.00 contract September 23, 2019.

Project Status and Next Steps:
