**1) Call to Order**

Chairman Mike Kozlosky called the meeting to order at 10:00 a.m. A quorum was present, as follows:

Zachary Bugg, Kittelson & Associates, gave an overview of the Navassa Bicycle and Pedestrian Plan and acknowledged the presence of Andrew Ooms, Kittelson, who provided oversight for the project.

Chairman Kozlosky said that this item was presented to the committee for discussion at its last meeting and to the MPO Board, which raised the question of electric assist bicycles, support for which has been included. He noted that regulations per jurisdiction have been included in the memo.

- b. Resolution adopting the Wilmington Urban Area Metropolitan Planning Organization's Conflict of Interest Policy

Chairman Kozlosky said that at the last MPO Board meeting, the Board expressed the desire for staff to bring forward a conflict-of-interest policy. He noted that the proposed draft policy was crafted by staff and the MPO attorney to provide guidelines for recusals.

Ms. Parker made a motion to adopt the WMPO Board's Conflict of Interest Policy. Chairman Kozlosky seconded the motion, and it carried unanimously by roll call vote, as follows:

6) Discussion

- a. 2020-2029 STIP/MPO Transportation Improvement Program Administrative Modifications #23-2

Chairman Kozlosky said that this item is for information purposes only and will be included for consideration at the next meeting.

- b. 2020 Urbanized Area (UZA) Census Data- Organizational Boundaries, Structure, and Governance

Chairman Kozlosky said that as discussed at the last meeting, the Census released the Wilmington MPO's Urbanized Area (UA) population of 255,329 on December 29th, and the Urbanized Area data on January 11th. He noted that the MPO is awaiting federal guidelines for the creation of MPOs and MPO planning area boundaries. He pointed out that the MPO anticipates having one year from the issuance of the guidance to set its Urban Area boundary.

Chairman Kozlosky said that the agenda packet includes the maps for the Urbanized Area as well as a map demonstrating the proximity of other MPOs and the Urbanized Areas. He pointed out that Hampstead is a separate Urbanized Area from the Wilmington Urbanized Area, and the WMPO's boundary encompasses a significant portion of the Hampstead Urbanized Area. Additionally, the Census released data showing that there is an Urbanized Area in Brunswick County.

Chairman Kozlosky said that since the Census released the 2020 data, the MPO is required by state law to evaluate and consider its boundary as well as its organizational structure and governance. He noted that he anticipates this topic to be included on the committee's agenda for the next several months as the MPO moves forward with discussing the future of its organizational boundary. He added that it will be a collaborative process.

A brief question/answer and discussion period was held regarding the difference between the Urban Area and the MPO planning area boundaries.

**c. Military Cutoff Road/Eastwood Road interchange**

Chairman Kozlosky said that in October, the Board requested MPO staff to bring forward ideas for potential project swaps to delay the Military Cutoff Road and Eastwood Road interchange project (U-5710). He noted that the discussion moved into conflicts of interest and a request for a policy, which the committee approved on its regular agenda today. He added that no action has been taken by the Board on consideration of the potential project swap of Military Cutoff Road/Eastwood Road for the College Road/Oleander Drive intersection improvements. He reminded committee members that any project swaps must be approved by March 17th and by the Division.

Chairman Kozlosky announced that although there has been no press release yet, the NC Board of Transportation approved awarding several feasibility studies for paved trails and sidewalks to the MPO and its members. He reminded the committee that at its January meeting, it approved the MPO applying for studies for the Downtown Trail Phases 2 and 3, as well as the Gullah Geechee Heritage Corridor in

Brunswick County and the East Coast Greenway's submission in Kure Beach. He said that the Board of Transportation approved all three studies yesterday.
