## 1) Call to Order

Chairman Hank Miller called the meeting to order at 3:00 PM. MPO Executive Director Mike Kozlosky called the roll, and a quorum was present as follows:

## 2) Conflict of Interest statement and recusals

Chairman Miller read the conflict-of-interest statement for the board.

## 3) Approval of Board Member Excused Absences

Mr. Kozlosky requested a motion to excuse Commissioner Wendy Fletcher-Hardee from the meeting.

Mr. Barbee made a motion to excuse Commissioner Wendy Fletcher-Hardee from the meeting and Mr. Ellen seconded.

## 4) Approval of the Agenda

Vice Chairman Waddell made a motion to amend the agenda by moving item 9C Remote Participation Policy before public comment on the agenda, seconded by Mr. Williams, and the motion carried unanimously by roll call vote as follows:

Mr. Kozlosky opened the floor for a motion on agenda item 9C. He explained that MPO staff is requesting an update to the Remote Participation Policy. The current policy states that there will be a roll call vote. Staff is requesting to modify the policy to streamline meetings to a voice vote and have only a roll call vote if it is requested by a Board member.

Mr. Ellen made a motion to accept the WMPO Board Member Remote Participation Policy as presented. Commissioner Scalise seconded.

## 6) Presentations

## a. North Carolina Department of Transportation Bridge Repairs Update- Chad Kimes, NCDOT

Chad Kimes stated that everything he is presenting and discussing today is subject to change and he will remind everyone throughout the presentation of this. He showed pictures and explained the different components of the bridge deck and how it had been repaired. He stated the bridge is inspected everyday and repairs are being made. Mr. Kimes stated that he wants to make sure everyone understands that it is safe, and they are keeping it maintained. He stated that a lot of work is being put into it daily.

Mr. Kimes went on to explain the plan and the challenges being faced with repairs. He stated that the mill that makes the riding decks for bridges is shutting down and is the only company in the United States that makes them. The company has promised NC DOT that this bridge will be one of their last jobs before they shut down. He stated that he is sure there is another mill around that will pick this up but before they have a contractor, they want to order the materials and hopefully start work in January. He did express concern with getting the materials by December since the mill is shutting down. He stated that all the projects must be made in the US in case anyone was thinking about overseas. Mr. Kimes said that they already have a specialty firm, Madjeski and Masters and they are experts on movable bridges, and they are putting the plans together and ordering the materials. The stringers that he showed needing repair will be done, he stated those are a little easier to get fabricated so those will continue to be replaced and repaired.

Mr. Kimes said that permitting is going well, he explained that the work that is needed can be done within the clearance over the river, so it appears that all the work can be done without any concerns from the United States Coast Guard. There are still some regular environmental permits that need to be obtained as well.

The next item Mr. Kimes discussed was the scope of work and the impacts. Currently, random nightly closures are happening to identify and weld cracks as they are identified. The goal is for contract crews to begin working this winter. He reminded everyone that again all of this is subject to change. An analysis done resulted with 95 working days utilizing 2 crews. He explained that the stringers go across 2 lanes of traffic so the two lanes in one direction will have to be shut down. It will take about 10 weeks. Once that direction is completed the the other direction will be shut down and work completed in another 10 weeks. Mr. Kimes stated that is doing everything they can to get the repairs completed before Memorial Day.

Mr. Kimes then presented a potential timeframe that is subject to change. He said the goal is to have existing stringers and grid deck repaired and fully restored to traffic by Memorial Day.

Mike Kozlosky, verified with Mr. Kimes that one direction will not be coming in for 10 weeks and one direction will not be going out for 10 weeks. It was clarified that neither side will be bi-directional, the traffic will be diverted to the Isabel Holmes Bridge. Mr. Kimes states that on the last repair project, the stringers could not be completely replaced with having bi-directional traffic on the bridge.

Mr. Kimes concluded that if for some reason the materials are not obtained that they will not proceed with this type of work during the summer or hurricane seasons and that they will wait until fall.

Mr. Barbee confirmed with Mr. Kimes that a deck like the one on the Cape Fear Memorial Bridge has a standard life of 10 years with the amount of traffic that crosses the bridge and there are some across the state that have longer lives but less traffic.

Mr. Barfield asked Mr. Kimes if the work could be performed at night. Mr. Kimes stated that if the work was done at night, it would prolong the project time.

Mr. Forte confirmed with Mr. Kimes that we really don't have an option regarding the repairs that need to be made. Mr. Kimes stated that the design firm is one of the best in the world regarding this type of structure.

Mr. Kimes also stated the Military Cutoff Road is slated to open September 28<sup>th</sup> and will include a ribbon cutting and everyone will receive an invite.

Vice-Chairman Waddell made a motion to approve the Consent Agenda as presented, seconded by Mr. Zimmer, and the motion carried unanimously.

## 8) Regular Agenda

a. <u>Resolution adopting the 2024-2033 State/Metropolitan Transportation Improvement Programs</u>

Mr. Kozlosky requested the adoption of the 2024-2033 State/Metropolitan transportation programs.

The NC Board of Transportation adopted this program in June of this year, and the MPO's public participation policy requires a 30-day public comment period. A public hearing was also held as part of the public participation policy. This is a combination of over 2 years of work with NCDOT, the WMPO Board and staff is recommending approval.

Mr. Ellen made a motion to adopt the resolution adopting the 2024-2033 State/Wilmington Urban Area MPO transportation improvement program as depicted in pages 29 through 37 of the agenda packet. Mr. Barbee seconded the motion and the motion carried unanimously. Mr. Kozlosky turned the meeting over to Abby Lorenzo to give an overview of items b through g.

## b. Resolution approving the Wilmington Urban Area Metropolitan Planning Organization's Prioritization 7.0 Aviation Project Submittals

Ms. Lorenzo stated that the next 6 items are all related to our Prioritization 7.0 project list. She discussed the results of the 14-day public comment period. Ms. Lorenzo stated that during that 2-week comment period they received a total of 19 public comments and an additional 2 shortly after the comment period closed for a total of 21 comments. She stated that most of those comments are regarding the widening of Independence Boulevard which is RW-222 on the roadway project list. There were also comments in support of the draft bike and pedestrian projects, Cape Fear Memorial Bridge replacement project, and a comment expressing support of returning passenger rail service to Wilmington.

Ms. Lorenzo explained the rail project is the only one that has been updated since the list was first presented at the Board's July 26<sup>th</sup> meeting. The changes to the rail project list consist of the removal of two projects due to their being submitted through the Cape Fear Rural Planning Organization. Ms. Lorenzo noted those projects were the freight rail connection from Castle Hayne to Wallace as well as a freight rail connection from Malmo to Whiteville.

Ms. Lorenzo noted that project descriptions and limits for the two Murrayville Roadway projects were adjusted in coordination with NC DOT Division 3. Roadway project 42 which is US Highway 17 access management improvements from Carol Lynn Road to Diane Church Road, Northeast was swapped out and off our list and replaced with North 23<sup>rd</sup> Street widening (MLK Jr. Parkway to Aviation Drive). She stated that NC DOT Division 3 in collaboration with Cape Fear Rural Planning Organization will be submitting the access management improvements from Carol Lynn Road to all the way to NC Highway 87.

She concluded by stating there are no other updates to the project lists that were presented to the Board in July and staff is requesting the Board to consider approval of Prioritization 7.0 Projects lists.

Mr. Ellen made a motion to approve items B. through F. Motion was seconded by Ms. Bozeman. Motion was carried unanimously by the Board.

Mr. Kozlosky explained that this was a new policy to clarify some items regarding Closed Sessions.

Commissioner Barfield made a motion to approve the Wilmington Urban Area Metropolitan Planning Organization's Closed Session Policy. The motion was seconded by Vice Chairman Waddell. Motion carried unanimously.

  Mr. Kozlosky said that this item is for information purposes only and will be brought back for consideration at the Board's next meeting.
- b. Wilmington Urban Area MPO Boundary, Governance, and Structure Subcommittee Update

Mr. Kozlosky stated that a subcommittee was created by this Board to consider any changes to the governance, boundary, and structure. The subcommittee met August 14, 2023, and no changes to our boundary to add new members or changes to the voting structure were recommended.

Mr. Barbee made a motion to approve the recommendations of the Wilmington Urban Area MPO Boundary, Governance, and Structure subcommittee as noted on pages 75 and 76. Commissioner Barfield seconded the motion. Motion carried unanimously.

Mr. Kozlosky thanked all the members of the subcommittee for their participation. He stated that Commissioner Barfield, Mayor Barbee, Commissioner Williams, Councilman Waddell, and Commissioner Hardee's hard work is much appreciated by staff.

Mr. Kozlosky stated that submittals were due and introduced Mr. Scott James to provide some comments. Mr. James stated that this is just a reminder we are approaching the deadline for applications for the fiscal year. He said they had received 7 applications and 6 of which were determined to be qualified. Any member jurisdiction or candidate projects that are considering submitting please prepare your packets and and get them to us by September 15<sup>th</sup>, 5 P.M, hardcopies, or midlines.

### b. 2050 MTP Outreach

Mr. Kozlosky introduced Ms. Lacer to give a brief update on the outreach. Ms. Lacer stated that they had a fruitful first month, phase one public outreach period for the Metropolitan Transportation Plan. They conducted five public meetings and launched a survey which is hovering around 1,200 responses. She stated the last time this planning process was done they had a total of 2,000 responses so they are on their way for the first month of public participation. This will continue through November and the survey will be open. We will conclude our public meetings next Friday and that will be a virtual meeting on the 8<sup>th</sup> from noon to 1:00 p.m. and the link is available on our website <a href="www.wmpo.org">www.wmpo.org</a>. She concluded by stating that outreach will continue through September and November and throughout the year at festivals, and pop up events as well.

Mr. Barbee stated the group conducted an outreach meeting with the community of Carolina Beach and noted that a big group came to the event. He also thanked the group for doing the outreach and for their professionalism in dealing with residences.

Mr. Ellen announced that on September 6<sup>th</sup> between 5:30 and 7:30 PM at the Kure Beach Community Center the town will hold an open house to discuss extending the greenway from where it terminates in Carolina Beach on down through Kure Beach. The company that is under contract will be mediating the meeting.

Commissioner Barfield commended Scott James and Jamar Johnson on their presentation at the Planning Board and County Commissioner joint meeting on Tuesday. They gave an overview of the MPO, land use review, and traffic impact analysis.

Mr. Barbee made a motion to go into closed session to consult with our attorney in order to preserve the attorney client privilege pursuant to the North Carolina General Statue section 143-318.11A3. Mr. Ellen seconded. Motion to go into closed session carries unanimously at 3:35 PM.

Mr. Ellen made a motion at 4:22 PM to return to open session. The motion was seconded by Mr. Barbee. Motion carries unanimously.

## Next meeting – September 27, 2023

There being no further business, Mr. Ellen made a motion to adjourn, seconded by Mr. Barbee, and the motion carried unanimously.

The meeting adjourned at 4:23 p.m.

**Subject:** Go Coast Committee Bylaw Updates

On August 17, 2023, the Go Coast committee approved changes to committee bylaws, and staff are now seeking approval of these changes by the WMPO Board. The changes contain revisions for clarity and further define officer responsibilities. An overview of the Go Coast Committee endorsed changes are as follows:

## Creation of a Presiding Officer

The Go Coast committee desires more clarity in the bylaws on how the Chair is selected and who can serve as Chair. Historically, the TDM Coordinator has carried out the Chair's responsibilities with a member of the committee elected as Vice Chair. For simplicity and efficiency, WMPO staff and the Go Coast committee propose to revise the bylaws to eliminate the current positions of Chair and Vice Chair, instead creating an appointed Presiding Officer position which shall be filled by the WMPO's TDM Coordinator. The creation of this position saves committee meeting time by eliminating the need to elect officers each May.

The Presiding Officer's duties include calling the meeting to order, ascertaining that quorum is present, producing and distributing the agenda, presiding over meetings and putting to a vote all necessary items, declaring meeting adjournment, keeping a record of all proceedings, minutes, and relevant documentation, and sending meeting notices to members.

## **Bylaw Amendments Approving Authority**

The proposed revision includes a statement clarifying that that changes to the Committee's Bylaws must be approved by the WMPO Board.

## **General Grammatical Edits**

The proposed revision also includes several grammatical edits for improved clarity and understanding.

## WILMINGTON UBRAN AREA METROPOLITAN PLANNING ORGANIZATION TRANSPORTATION DEMAND MANAGEMENT ADVISORY COMMITTEE BYLAWS

## **ARTICLE I - NAME**

The name of this organization shall be the Wilmington Urban Area Metropolitan Planning Organization (WMPO) Transportation Demand Management (TDM) Advisory Committee, hereinafter referred to as the "Go Coast Committee."

## **ARTICLE II - PURPOSE AND DEFINITIONS**

The purposes of the Go Coast Committee are as follows:

- To provide advice and direction to the Transportation Demand Management (TDM) Coordinator on Go Coast Program initiatives.
- To share Go Coast Program initiatives with affiliates of the organizations and member jurisdictions represented on the Go Coast Committee.
- To help determine transportation demand <u>management</u> needs for the Wilmington Urban Area MPO's planning <u>boundaryarea</u>.

The definitions of pertinent terms are as follows:

- Representative: the primary voting member that is representing an organization on the Go Coast Committee.
- Alternate: the secondary voting member that is representation an organization on the Go Coast Committee. Alternate's may only vote in the absence of the Representative of the same organization.

## ARTICLE ##-III - MEMBERS

Section I- Qualifications:

The Go Coast Committee shall consist of Representatives from the WMPO region's major employers, member jurisdictions, and other community stakeholders. Representatives should submit a letter of acceptance to the Go Coast Committee presented on the organization's letterhead with the name and signature of the Representative. The Go Coast Committee shall strive to have representation from a variety of interests and perspectives in the WMPO planning region. The Go Coast Committee will select members to have representation from, including but not limited, to the following:

- A minimum of one employer with more than 1,000 employees
- An minimum of one employer with between 500 and 1,000 employees
- An minimum of one employer with between 100 and 500 employees
- The Cape Fear Public Transportation Authority
- A minimum of one institution of higher learning
- The WMPO member jurisdictions
- · Organizations or governmental departments that focus on public and environmental safety

 An organization or governmental department with a focus on public and/or environmental safety

### Section II- Terms of Committee Membership:

All Representatives serving on the Go Coast Committee are obligated to remain on the Committee for the entire fiscal year (June July to JulyJune of the following year) and attend one meeting each quarter of the fiscal year. If a Representative is no longer able to serve on the Go Coast Committee for any reason including leaving thetheir organization, it is the responsibility of the Representative to find a replacement to represent thetheir organization. If the Representative of the Go Coast Committee are presented on the organization should submit a letter of acceptance to the Go Coast Committee presented on the organization's letterhead with the new name and signature of the Representative. If an organization or member jurisdiction represented on the Go Coast Committee wishes to no longer be on the Committee, the Representative should provide a letter of resignation presented on the organization's letterhead.

### Section ##\_III-\_Alternates:

Each Representative on the Go Coast Committee may appoint one (1) Alternate. The Alternate member may attend quarterly Go Coast Committee meetings and receive Committee communications via email. In the event of a vote, each organization will receive one (1) vote even if both the Alternate and Representative are present. The Alternate may vote in place of the Representative if the Representative is absent from a meeting. If the Representative has not selected an Alternate but cannot attend a meeting, they should not send a Proxy to attend. In the event that the Representative of an organization changes, it is not mandatory that the selected Alternate become the new Representative. Absentee voting is not permitted.

## ARTICLE IV -- PRESIDING OFFICERS

## Section 1- Officers Defined:

The Committee's Presiding Officer shall be the WMPO's Transportation Demand Management
Coordinator. The Presiding Officer shall call the meeting to order at the appointed time, ascertain that
quorum is present, produce and distribute the agenda, preside over meetings, put to a vote all
necessary items, declare meeting adjournment, keep a record of all proceedings, committee minutes
and relevant documentation, and send meeting notices to members. In event of the absence of the
Transportation Demand Management Coordinator, a Presiding Officer Pro Temp shall be appointed
from among WMPO staff members., upon majority vote of its membership, shall appoint one
Representative of the Committee to act as Chairman and one Representative to act as Vice Chairman.
The Chairman shall call to order and preside over meetings and appoint Committee members. In
absence of the Chairman, the Vice-Chairman shall preside and complete all duties of the Chairman.
Alternates are not permitted to be elected as Chairman and Vice-Charmin. If any officer resigns from the
committee, an election will be held at the following scheduled meeting.

Section III- Elections

Officers shall be elected annually at the last quarterly meeting of the fiscal year by the voting members of the Go Coast Committee, with their terms to begin at that first meeting of the following fiscal year. Officers shall serve for a period of one (1) year from their election and may be re-elected. In the event that the position of Transportation Demand Management Coordinator is vacant, the interim Chairman shall be a staff member of the WMPO appointed by the WMPO Executive Director.

## **ARTICLE V - MEETINGS**

## Section I- Meetings:

Regular schedules will be adopted by the Committee at the last meeting of the fiscal year except upon adoption of these bylaws in which the schedule will be adopted in the first meeting of the fiscal year. Meetings shall be scheduled one per quarter. If there is insufficient reason for a regularly scheduled meeting, as determined by the Chairman, the Chairman will notify members of the meeting's cancellation. Meetings shall be conducted under parliamentary procedures consistent with Robert's Rules of Order. A Special or Emergency meeting is a separate session held at a time different from that of a regular meeting, and convened only to consider one or more items of business specified in the call of the meeting. Notice of the time, place and exact purpose of the meeting must be emailed to all members ten (10) days in advance. The reason for the special or emergency meeting is to deal with important matters that may arise between regular meetings and that urgently require action by the Committee before the next regular meeting.

## Section **!!!**- Quorums and Majority Vote:

A quorum is required for the transaction of all business, including conducting meetings or hearings, participating in deliberations, or voting upon business. A quorum consists of 51% of the members of the Go Coast Committee, plus as many additional members as may be required to ensure that 51% of the possible votes are present.

## Section III- Attendance:

Each Representative shall be expected to attend each scheduled meeting. Any Go Coast Committee member asking to be excused shall require a call or email to the WMPO's Transportation Demand Management Coordinator, or the acting <a href="Presiding OfficerChairman">Presiding OfficerChairman</a> at least 24 hours in advance of the meeting unless in the case of an emergency or sickness. If an Alternate attends a meeting in place of the member, this will not count as an absence for the Representative. Representatives may only acquire one (1) unexcused absence each year. ## ARTICLE VI -VOTING PROCEDURES

Section I-- Majority Votes:

Any Representative may call for a vote on any issue provided that it is seconded by another Representative. Each voting member of the Committee shall have one vote, and a majority vote of those present and voting shall constitute approval of any motion, provided a quorum exists. Absentee voting is not permitted.

### Section II- Agenda:

The agenda is the list of items suggested for discussion at a Committee meeting. Agenda items originate from the Transportation Demand Management Coordinator or as a carry-over from previous meetings, and are placed on the agenda prior to its distribution. In order for a Committee member to submit an item(s) to the Go Coast Committee, the item(s) must be submitted no later than 5:00 p.m. seven (7) business days before the following meeting.

## ARTICLE **HIVII** - AMENDMENTS TO BYLAWS

The bylaws may be amended or repealed and new bylaws adopted by the affirmative vote of at least two-thirds (2/3) of the eligible voting members. Amendments can take place during any regular or special meeting.

Amendments to Committee bylaws must be approved by the WMPO Board.

#### PENDER COUNTY BICYCLE AND PEDESTRIAN PLAN

**Project Description/Scope:** Pender County, in collaboration with the WMPO and consultant WSP, seeks to develop a comprehensive Bicycle and Pedestrian Plan to direct multi-modal development within the southern portion of the County. The final plan will be used to prioritize bicycle and pedestrian infrastructure implementation that will improve mobility, increase safety, and strengthen the connectivity for multi-modal transportation options in southern Pender County. The notice to proceed was issued in late September 2022.

#### **Project Status and Next Steps:**

- The Draft Plan has been finalized.
- The Plan is expected go before the Pender County Board of Commissioners and the WMPO Board for consideration of approval in fall of 2023.

#### **NCDOT IMD FEASIBILITY STUDY GRANTS**

**Project Description/Scope:** In July 2022, the North Carolina Department of Transportation (NCDOT) was allocated \$2 million in one-time funding from the North Carolina General Assembly to establish a Paved Trails Feasibility Study Program. The Integrated Mobility Division (IMD) was also awarded \$500,000 in State Planning and Research (SP&R) funds to support sidewalk and shared-use path feasibility studies. The purpose of the Paved Trails and Sidewalk Feasibility Studies Grant Program is to improve the pipeline of bicycle and pedestrian projects accessing state and federal funding, resulting in successful implementation of projects led by communities prioritizing multimodal infrastructure.

### Wilmington Downtown Trail Phases 2 & 3:

The Downtown Trail will eventually connect the River to Sea Bikeway to the future Multimodal Transportation Center, Cape Fear Community College, and the Riverwalk. In between these locations, the trail will provide a recreational facility for several communities in proximity to the downtown. The project currently consists of three phases. The first phase, from 3rd Street to Archie Blue Park, is in the preliminary engineering phase. The purpose of this study would be to assess the feasibility of constructing Phases 2 and 3. A scoping meeting with NCDOT IMD and the selected consultant, Kittelson, was held on May 2, 2023.

#### **Project Status and Next Steps:**

- The first steering committee is anticipated to take place in September 2023
- The first public outreach sessions are anticipated to take place in early October 2023.
- Final study report anticipated in late spring/early summer 2024.

### **Gullah Geechee Heritage Trail:**

The purpose of this study would be to assess the feasibility of constructing a 10'-12' multi-use path facility in the Gullah Geechee Heritage Corridor from Phoenix Park in Navassa to Brunswick Nature Park in unincorporated Brunswick County. The Gullah Geechee Heritage Corridor is designated as a Cultural Heritage Area by U.S. Congress, presenting an opportunity to educate the public about the history of the Gullah Geechee people and highlight historical sites within Brunswick County. A scoping meeting with NCDOT IMD and the selected consultant, Kittelson, was held on May 2, 2023.

#### **Project Status and Next Steps:**

- The first steering committee and public outreach sessions are anticipated to take place in October 2023.
- Final study report anticipated in late spring/early summer 2024.

#### TC - 0021 WAVE PASSENGER AMENITIES AND UPGRADES

Shelters only represent 6% of our passenger amenities, while other NC agencies average 14%. To meet the peer average for statewide systems, CFPTA needs to install an additional twenty-six (26) benches and twenty (20) shelters. This project will support the installation of a total of nine (9) bus stop benches and ten (10) bus stop shelters along eight (8) transit routes located within the City of Wilmington. The project includes engineering and design, construction of concrete pads, ADA ramps, ADA access, and purchase and installation of durable bench and/or shelter, waste receptacle, and solar lighting, where applicable.

#### TRANSPORTATION DEMAND MANAGEMENT PROGRAM

**Project Description/Scope**: The TDM "Go Coast" program works to increase the use of alternative transportation by WMPO residents and decrease Vehicle Miles Traveled (VMT). The WMPO Board approved Cape Fear Change in Motion 2020, the short-range TDM Plan which will guide Go Coast initiatives from 2021 to 2025. This plan identifies seven short-range strategies to increase mobility options and reduce traffic in the WMPO region. These strategies are: Alternative Work Schedules, Bike Share Program, Carpool and Vanpool, Consulting for Telecommuting Opportunities, Fostering a Bicycle and Pedestrian Friendly Culture, Improved TDM-Focused Collaboration, and Personalized Commuter Plans.

Go Coast current initiatives and project status:

- Go Coast Committee The next Go Coast committee meeting will occur on November 16, 2023, at 3 PM. The committee has also voted to amend its bylaws and request approval by the WMPO board for the changes, which include updates to officer positions.
- 2. Be a Looker WMPO and Go Coast will promote the Be a Looker campaign from April 2023 through October 2023, which encourages safety among all road users including motorists, bicyclists, and pedestrians, through attending events, presentations, distributing informational brochures, advertising, and social media. Bicycle helmets received from an NCDOT grant will be distributed during this campaign to children from low-income families. So far there have been 192 Be A Looker pledges from 11 events attended since April as well as online pledges.
- 3. Get There Greener The Go Coast committee has worked to rebrand the WMPO's annual Commuter Challenge. The new name is "Get There Greener" and the focus is on sustainable transportation and replacing single-occupancy vehicle trips with bicycling, carpooling, walking, public transportation, or teleworking. The challenge will take place during the month of October and participants can log their miles traveled by alternative transportation to win prizes donated by local businesses.
- 4. Brunswick Heritage Riverside Ride The 3<sup>rd</sup> Annual Brunswick Heritage Riverside Ride will take place Saturday, September 30, 2023. This 16-mile casual-paced ride travels along the Gullah Geechee Cultural Heritage Corridor in northern Brunswick County. This year, a StoryMap about the route featuring Gullah Geechee history was designed for the ride's web page at gocoastnc.org/brunswick-heritage-riverside-ride.



# Cape Fear Public Transportation Authority September 2023 Project Updates

#### **Ridership Updates**

For August 2023, Wave Transit showed 3.5% growth in fixed-route ridership compared to August 2022. The monthly ridership for fixed-route was 48,570.

RideMICRO's (microtransit) August 2023 ridership was 1,720 trips per month, a 20% percent increase from August 2022. That total reflects our highest monthly ridership since the pilot launched.

Combined, system ridership was up 2.1% when comparing August 2023 to August 2022. Ridership was higher in all aspects from the previous year save for UNCW shuttle ridership, which was down in part because Fall 2022 classes started a week earlier than Fall 2023.

### **Short-Range Transit Plan**

Wave Transit's Short Range Transit Plan (SRTP) will hold a Board of Directors special session workshop on September 22 at 1 PM at the New Hanover County Government Center at 230 Government Center Drive, Wilmington, NC in Room 139. Nelson/Nygaard, the Consultant, will help provide an overview and best practices of what a healthy and well-built fixed route system should resemble.

Wave's goal through the SRTP is to improve the efficiency and effectiveness of the Authority's fixed-route system to better serve the public transportation needs of the Cape Fear Region, without increasing the operating budget for the Authority and to also investigate models for service reduction due to possible upcoming budgetary shortfalls.

#### Safety Plan

Wave Transit is updating its Public Transportation Agency Safety Plan. Wave strives to provide safe, reliable, comfortable, and innovative transportation options to every member of the community.

The Public Transportation Agency Safety Plan (PTASP) was developed to integrate safety into all system operations. By using the procedures contained in the PTASP, Wave can continue to improve the safety and security of operation and services. This PTASP describes the policies, procedures, and requirements to be followed by management, maintenance, and operations personnel to provide a safe environment for Authority and contracted employees, customers, and the public. The goal of this program is to eliminate the human and fiscal cost of avoidable personal injury and vehicle accidents.

### SEPTEMBER TPD UPDATES WILMINGTON MPO

September 2023

Brunswick County Comprehensive Transportation Plan (CTP): The last steering committee meeting was on June 27<sup>th</sup>, where the committee made decisions on public involvement feedback. Updates to the report and appendix were made during the month of July by TPD engineer and submitted to TPD management in early August. Currently, the CTP is being reviewed by TPD management. After reviews are complete, report and appendix will again be updated, and TPD engineer and RPO planner will start preparing for local adopting agency presentations.

**Wilmington Model:** Recently, the Wilmington MPO verified base year socio-economic data for the TDM. Currently TPD is waiting for the Wilmington MPO to submit additional data before moving onto completing Base Year Estimates for the TDM.

**Pender County Comprehensive Transportation Plan (CTP):** The Pender County CTP will start in fall of this year. The last Pender County CTP was adopted in 2015. The base year for this CTP will be 2021 and horizon year will be 2050.
