#### 1) Call to Order

Chairman Mike Kozlosky called the meeting of the Technical Coordinating Committee to order at 10:00 a.m., confirmed a quorum was present, and called the roll as follows:

**Present In Person:** Mike Kozlosky, Michelle Howes, Sam Boswell, and Carolyn Caggia. **Present Remotely:** Helen Bunch, Mark Hairr, Adrienne Harrington, Jeremy Hardison, Jeremy Hardison, Deny Vielkanowitz, Julian Griffee, Stephanie Ayers, Beshad Norowzi, and Ashely Barefoot. **Absent:** Michelyn Alston, Robert O'Quinn, Adam Moran, Granseur Dick, and Mandy Sander.

Mike Kozlosky asked for a moment of silence to commemorate all that lost their lives 23 years ago today.

#### 2) Approval of Agenda

Mark Hairr made a motion to approve the agenda, seconded by Helen Bunch and the motion carried unanimously

#### 3) Presentations

#### a. Get There Greener/Bike to Work Day- Carolyn Caggia, WMPO

Carolyn Caggia, WMPO presented the Go Coast annual sustainable transportation challenge, Get There Greener and Bike to Work Day. Get There Greener takes place every October. In 2023 it was rebranded from the Commuter Challenge that was established in 2016. The challenge encourages participants to track their trips and report their miles when they travel by carpooling, public transportation, bicycling, walking, or teleworking. Teleworkers will log how many miles they would have traveled by single occupancy vehicle.

She stated that the spirit of the challenge is to reduce single occupancy vehicle travel and encourage alternative transportation that is sustainable. She noted the website address is GoCoastNC.org/get-theregreener. Ms. Caggia then gave a brief history of the challenge noting various platforms that were used and some fluctuating participation as well. The My Open Road application has been used in the past but it no longer exists. Ride NC was also used which is a statewide matching database that also had the functionality for trip tracking. The past two years Google forms has been used to try and reduce barriers to participation by using a familiar platform.

Ms. Caggia then stated that in 2023 there were 26 participants that logged 3,857 miles for a total of 1,542 kg of carbon dioxide savings. She stated that this year's challenge runs from October 1<sup>st</sup> though the 31<sup>st</sup> and the interest form is on the website. Stating October 1<sup>st</sup>, the tacking form will be up and running. At the end of the challenge prizes will be awarded from area businesses.

She then presented information on Bike to Work Day that will be held on October 11<sup>th</sup>. The concept is to encourage local businesses and organizations to sponsor pit stops at their place of business or at a bicycle spot nearby. They could offer coffee, snacks, and swag. A map of the pit stops is available at gocoastnc.org/bike-to-work-day-2024. She encouraged everyone to spread the word and participate.

#### b. Wrightsville Beach Bicycle and Pedestrian Plan-Katie Ryan

Katie Ryan stated that the bicycle/ pedestrian plan that was just adopted by the Board of Alderman in June had the most public involvement and enthusiasm of any plan she has worked on before.

She noted that following the award of the NCDOT bike/pedestrian planning grant in August 2022, the NCDOT selected Kimley Horn as the consultant. The Board in February 2023 appointed the Parks and Recreation Advisory Committee to serve on the steering committee as well as WMPO staff and NCDOT staff. There were four steering committee meetings and two public workshops. She stated the workshops were well attended with 64 residents at the first meeting and 27 at the second. She noted that non-residents participated as well and they had over 600 survey responses, and 81% of those were full-time or part-time Wrightsville Beach residents.

The steering committee developed a vision statement which was to create a safe, accessible, and connected bicycle and pedestrian network in and around Wrightsville Beach for people of all ages and abilities. The Wrightsville Beach Bicycle and Pedestrian Plan will consider the unique environment and geographic challenges and focus on safe connections in the Town and broader region.

Ms. Ryan noted that the committee also had to consider the environment and accessibility, public health, economic development, and equity. All this information as well as public input were included in the draft as well as the prioritized improvements. The committee developed a prioritization tool based and weighted on safety, accessibility and connectivity, public input, cost effectiveness, and demand and density.

She mentioned that some of the improvements are currently being worked on, for example, the section of sidewalk on old Causeway Drive. In addition, Causeway Drive is about to be resurfaced with added bicycle lanes.

#### a. Resolution approving Amendment #2 to the FY 25 Unified Planning Work Program

Mike Kozlosky, WMPO sated this amendment is to move \$6,300 from the management and operations line-item Ashley Barefoot, Brunswick County to the special studies line item, to allow the MPO to complete a compensation study for the organization. This is supported by the organizational assessment and strategic plan.

Motion to approve amendment #2 to the FY 25 Unified Planning Work Program was made by Adrienne Harrington and seconded by Stephanie Ayers Motion passes unanimously.

#### b. Resolution supporting the City of Wilmington's application for the USDOT's Small Bridge Grant Program

Mike Kozlosky, WMPO stated the city plans to apply for funding through the USDOT Small Bridge Grant program to replace the 4<sup>th</sup> Street Bridge, as well as the Pine Grove Bridge. Applications are due November 1<sup>st</sup>.

Motion to approve the resolution supporting the City of Wilmington applying for the USDOT's Small Bridge Grant made by Stephanie Ayers and seconded by Michelle Howes. Motion passes unanimously.

#### 6) Discussion

a. 2024-2033 STIP/MPO Transportation Improvement Program Administrative Modifications #24-9 Mike Kozlosky stated this is for informational purposes only and will be brought back at the next meeting for consideration.

#### 7) Updates

#### a. Wilmington Urban Area MPO

Mike Kozlosky introduced Tessa Jones the WMPO's new Public Information Officer, and she said a few words about herself. Mr. Kozlosky also noted that the Direct Attributable applications are due Friday, September 13 by 5 PM.

#### **b**. Cape Fear Public Transit Authority

Mark Hiarr, WAVE, stated that public outreach concludes September 15<sup>th</sup> on the Reimagine WAVE route and service improvements. There will then be a public hearing on September 26<sup>th</sup> and will move forward with consideration at the end of September.

#### c. NCDOT Division 3

Michelle Howes stated that the Banks Channel Bridge is done, and lanes restored, and they are still waiting to get the handrail materials to complete the repair. NC 133 in Belville had the final inspection on September 10<sup>th</sup> and will possibly have a few punch list items left to complete. Drysdale Drive is estimated to be open later this fall. The Hampstead Bypass is on track and is about 50% complete.

She then announced that Trevor Carroll is the new Division 3 engineer.

WHEREAS, Cornelius "Sonny" "The Oyster Man" Nixon was a lifelong Wilmingtonian who began working in the oyster business as a child to help support his family at a time when African Americans faced economic difficulties and had few opportunities; and

WHEREAS, Mr. Nixon's drive and ambition led him to start the county's first oyster shucking facility on Greenville Sound before purchasing a 10-acre parcel of land on Market Street near Military Cutoff where he built his business, Nixon's Oyster Plant; which served the community for over 55 years until his passing in 2011; and

WHEREAS, Mr. Nixon was a leading entrepreneur in Wilmington, providing jobs to area residents and retirement benefits to his workers, a benefit rarely provided by small business owners; and

WHEREAS, Mr. Nixon contributed to the long-term health of the oyster industry and coastal waters by promoting the state's oyster shell recycling program, where customers drop off shells and the Division of Marine Fisheries returns the shells to area waters to provide a habitat for young oysters. As the third largest recycling center in North Carolina, Mr. Nixon was recognized for his efforts by Marine Fisheries in 2010; and

WHEREAS, Mr. Nixon was recognized for his legacy of entrepreneurship and community service when Cape Fear Community College renamed its Minority Male Mentoring program to the Nixon Minority Male Leaders program in 2015. The program has since expanded and is now known as the Nixon Leaders Center, focused on supporting the educational and professional aspirations of underrepresented populations of students; and

**WHEREAS,** Mr. Nixon demonstrated a commitment to the betterment of Wilmington and New Hanover County throughout his life and created a legacy that lives on today.

**Projects** 

In 2012, the Wilmington Urban Area Metropolitan Planning Organization (WMPO) was designated as a Transportation Management Area (TMA) because of the urban area population exceeding 200,000 in the 2010 Decennial Census. With the TMA designation, the WMPO has additional federal reporting requirements as well as became a direct recipient for Surface Transportation Block Grant Program (STBG), Transportation Alternatives Set Aside (TA), and Carbon Reduction Program (CRP) funds to be awarded to local projects through the organization's own competitive application process.

For federal Fiscal Year 2025, beginning October 1, 2024, through September 30, 2025, the WMPO anticipates receiving the following approximate amounts in direct attributable funding:

Surface Transportation Block Grant (STBG) - \$ 4,502,892 Transportation Alternatives Set Aside (TA) - \$752,086 Carbon Reduction Efforts (CR) - \$801,858

In addition to the anticipated FY 2025 funding amounts, \$99,561 in funding is available from the WMPO's FY 24 direct attributable allocation.

The WMPO typically utilizes a portion of its annual direct attributable funding to supplement the organization's annual operations and planning activities through the Unified Planning Work Program (UPWP). Additionally, increasing construction costs over the past several years has resulted in significantly greater project costs, requiring many previously awarded and funded projects to request additional funding to complete construction. Based on these factors, WMPO staff recommend holding a total of \$2,100,000 of available direct attributable funding for the

Wilmington Urban Area Metropolitan Planning Organization

development of the FY 26 UPWP and additional funding requests for existing funded projects. This results in an estimated total of WMPO direct attributable funding to award to projects for FY 25 of **\$4,056,397**.

The WMPO issued a call for project applications for FY 25 STBGP, TA, and CRP funding on July 5, 2024, with a deadline for submittal of September 13, 2024. A total of nine (9) complete applications were received and evaluated based on the WMPO's adopted scoring process. The following table lists each of these projects, evaluated score, rank, and project cost.







#### **CAPE FEAR NAVIGATING CHANGE**

**Project Description/Scope:** The WMPO has begun the planning process for our region's 2050 Metropolitan Transportation Plan (MTP), Cape Fear Navigating Change 2050. A long-range Metropolitan Transportation Plan for the region is federally required and must be developed, updated, and adopted by the WMPO every five years. The final plan will be used by federal, state, and local governments to guide decision-making for transportation projects in our region over the next 25 years, including which projects receive state or federal funding, the design and location of local roadways, coordinating land use and development, and identifying projects for further plans and studies. Planning activities began in April of 2023 with plan adoption expected in November of 2025.

#### **2050 MTP Financial Element**

WMPO staff is continuing to work with consultant Kimley-Horn on identifying cost estimates for draft projects, exploring alternative funding sources, and fiscally constraining roadway projects. The financial element entails a review process to assess alignment between submitted modal project to available funding and overall fiscal feasibility.

#### **Project Status and Next Steps:**

- Initial cost estimation and fiscal constraints for submitted roadway projects have been received and are currently under review by staff.
- Initial revenue forecasting for all modes have been received and are currently under review by staff
- WMPO staff have worked with consultants Kimley-Horn and NCDOT Transportation Planning
  Division to run three fiscally constrained roadway project scenarios through the 2050 Travel
  Demand Model. Model runs are ongoing and WMPO staff will review results when received.
- A comprehensive update on all reviewed projects and their financial implications will be
  provided to the TCC and Board in Fall 2024. This update will include a ranked draft project list
  complete with cost estimates.

#### 2050 MTP Modal Appendices

WMPO staff have begun drafting the modal appendices for the 2050 MTP. These appendices are written for each transportation element and build from what is included in the main text of the document. So far, WMPO staff have completed a draft of the Aviation Element and are beginning to work on the Bicycle and Pedestrian Element.

#### **Project Status and Next Steps:**

- WMPO staff are conducting research on current trends within each element, including legislation, technological advancements, recommendations for implementation, and more.
- The appendices also include fiscally constrained project list, as well as full project lists that are prioritized according to the adopted goals and objectives.
- Modal policy will also be included in the appendices for each mode.
- Next steps include concluding research and putting together text and photos/illustrations.
- A draft of the 2050 MTP which includes these appendices will be provided to the TCC and MTPC in Summer 2025.

#### **NCDOT IMD FEASIBILITY STUDY GRANTS**

In July 2022, the North Carolina Department of Transportation (NCDOT) was allocated \$2 million in one-time funding from the North Carolina General Assembly to establish a Paved Trails Feasibility Study Program. The Integrated Mobility Division (IMD) was also awarded \$500,000 in State Planning and Research (SP&R) funds to support sidewalk and shared-use path feasibility studies. The purpose of the

Paved Trails and Sidewalk Feasibility Studies Grant Program is to improve the pipeline of bicycle and pedestrian projects accessing state and federal funding, resulting in successful implementation of projects led by communities prioritizing multimodal infrastructure.

#### Wilmington Downtown Trail Phases 2 & 3:

The Downtown Trail will eventually connect the River to Sea Bikeway to the future Multimodal Transportation Center, Cape Fear Community College, and the Riverwalk. In between these locations, the trail will provide a recreational facility for several communities in proximity to the downtown. The project currently consists of three phases. The first phase, from 3rd Street to Archie Blue Park, is in the preliminary engineering phase. The purpose of this study would be to assess the feasibility of constructing Phases 2 and 3. A scoping meeting with NCDOT IMD and the selected consultant, Kittelson, was held on May 2, 2023.

#### **Project Status and Next Steps:**

The purpose of this study would be to assess the feasibility of constructing a 10'-12' multi-use path facility in the Gullah Geechee Heritage Corridor from Phoenix Park in Navassa to Brunswick Nature Park in unincorporated Brunswick County. The Gullah Geechee Heritage Corridor is designated as a Cultural Heritage Area by U.S. Congress, presenting an opportunity to educate the public about the history of the Gullah Geechee people and highlight historical sites within Brunswick County. A scoping meeting with NCDOT IMD and the selected consultant, Kittelson, was held on May 2, 2023.

#### TRANSPORTATION DEMAND MANAGEMENT PROGRAM

**Project Description/Scope**: The TDM "Go Coast" program works to increase the use of alternative transportation by WMPO residents and decrease Vehicle Miles Traveled (VMT). The WMPO Board approved Cape Fear Change in Motion 2020, the short-range TDM Plan which will guide Go Coast initiatives from 2021 to 2025. This plan identifies seven short-range strategies to increase mobility options and reduce traffic in the WMPO region. These strategies are: Alternative Work Schedules, Bike Share Program, Carpool and Vanpool, Consulting for Telecommuting Opportunities, Fostering a Bicycle and Pedestrian Friendly Culture, Improved TDM-Focused Collaboration, and Personalized Commuter Plans.

#### Go Coast current initiatives and project status:

- 1. Go Coast Committee The next regular Go Coast committee meeting is scheduled to occur in person on Thursday, November 21, at 3 PM.
- 2. Bicycle Helmet Initiative In April, the WMPO was awarded 100 children's bicycle helmets through NCDOT's Bicycle Helmet Initiative for distribution to children from low-income families with bicycle safety education. Staff is participating in outreach events throughout the year to distribute helmets to children and educate families on bicycle safety. So far 58 helmets have been distributed, with more distribution opportunities planned for Fall 2024.
- 3. Short Range TDM plan update WMPO staff have begun work to update the short-range TDM plan, *Cape Fear Change in Motion 2020*. A public engagement period to inform this update is scheduled

- for September through November 2024. Steering committee meetings are ongoing with the update scheduled for completion by November 2025.
- 4. Annual WMPO-organized bike rides The 34<sup>th</sup> Annual River to Sea Bike Ride, scheduled for Saturday, September 7, 2024, was cancelled due to inclement weather. WMPO staff thanks all partners involved in the ride for their support and looks forward to the 35<sup>th</sup> Annual River to Sea Bike Ride in May 2025. The 4<sup>th</sup> Annual Brunswick Heritage Riverside Ride took place on Saturday, September 28 with 74 participants checking in to the ride.
- 5. Get There Greener Get There Greener is Go Coast's sustainable transportation challenge which occurs annually in October. Participants log their miles traveled by alternative transportation for a chance to win prizes donated by local businesses. In September, WMPO staff continued reaching out to local businesses to participate in Get There Greener with a donation of gift cards/items of \$25-50 value. Additionally, staff is planning for a fall Bike to Work Day on Friday, October 11. Organizations/businesses will be encouraged to set up "pit stops" for bicyclists in the morning or evening commute, providing water, coffee, snacks, etc. to those who bike by, in addition to any swag/info they may choose to hand out.



## Cape Fear Public Transportation Authority October 2024 Update

#### <u>Wave Route & Service Improvements Approved-Scheduled for January 2025</u> <u>Implementation</u>

The Cape Fear Public Transportation Authority Board of Directors approved a comprehensive set of route and service approvements at their September 26, 2024 meeting. Highlights of the improved service include:

- Wave's first ever frequent (15-minute) service linking Padgett Transit Station, downtown and the New Hanover Regional Medical Center-made possible by staggering departures
- New 30-minute service on high traffic routes in all sectors of the fixed-route network
- Port City Trolley operating more frequently, later into the evening, and on Sundays on a seasonal basis
- Direct connection from Padgett Station to Mayfaire every hour on new Route 206 – Oleander Dr.
- Additional bus stops on College Road to improve access

#### **Wave Begins Renewable Natural Gas Revenue-Generating Program**

This fall Wave begins an EPA-sponsored program that will generate revenue for from the sale of renewable natural gas commodities. This is program helps fulfill Wave's commitment to sustainable initiatives and involves a partnership with STX Commodities, an energy commodities company, whereby Wave's dispensing of Compressed Natural Gas (CNG) will be used as a basis for credits purchased by STX and converted into revenue for Wave. The program is expected to generate at least \$100,000 in its first full year and is part of the EPA's Renewable Fuel Program.
