1) Call to Order

Chairman Mike Kozlosky called the meeting of the Technical Coordinating Committee to order at 10:01 a.m., confirmed a quorum was present, and called the roll as follows:

2) Approval of Agenda

Mark Hairr made a motion to approve the agenda, seconded by Karlene Ellis Vitalis and the motion carried unanimously

3) Presentations

a. NCDOT Division 3 Update-Trevor Carroll P.E., NCDOT

Trevor Carroll acknowledged Chad Kimes and Landon Zimmer and gave a quick overview of Division 3. He noted that the division covers 6 counties: Brunswick, Onslow, Duplin, Pender, New Hanover and Sampson. He mentioned the number of bridges, rest areas, and road miles that Division 3 is responsible for.

Mr. Carroll presented the Prioritization timeline (P7.0). This timeframe is for regional impact points, those collective input point assignments. He stated that there are 3 tiers of projects. Statewide tier, Regional Tier, and Division Tier. All projects are scored for all these tiers, meaning if a project does not score well at the State level it may score at the regional level and so on. He presented an interactive map, outlining the WMPO area and projects included in that area. He stated that you can click on the dots, and it will give you details about each one of the projects.

He then presented the following projects in development.

- U-6202- Gordon Road widening is scheduled for later this fall. NCDOT is working through some utility conflicts that could potentially impact the exact letting date. The letting date is currently scheduled for September and once those challenges are resolved another update can be given to the exact timeframe. He showed a current picture of Gordon Road and then a drawing of the widening project. It consists of building a separated road with a multi-use path with 5-foot sidewalks. Mr. Carroll noted he will gather more details on any structures affected by the widening and share this information with the Board. He stated that contact has been made with the homeowners and processes are being established to move forward with the project. More information will be provided once the project moves from development to construction.
- U-5792- College Road from US 17 (Market Street) to SR 2048 (Gordon Road).
 He presented a concept drawing of the bridge that will be constructed going over Martin Luther King Jr.
 Parkway from College Road. The timeframe is fiscal year 2025 (Right of Way) and construction year 2028 for the price of \$137 million.
- U-5881- NC 132 (North College) from SR 2048 (New Centre Dr) to Market Street. This project is currently still in the planning process and continued development with a price tag around \$40.5 million. Once development and a timeframe are established a more detailed update will be provided.
- U-4902C- Market Street at Eastwood Road. The current right-of way date is fiscal year 2028 and a construction date of 2030 with a price of \$112 million.
- HB-0040- Replacement of bridges on US 74 (Salisbury Street) and US 76 (Causeway Drive) in Wrightsville Beach. Right-of-way date is 2025 and construction is planned for 2028. The three bridges will be phased and built under the same project. NCDOT is seeking alternative delivery methods for this project to accelerate the timeframe due to a lot of challenges with traffic flow and foundation installation. These construction methods passed through the General Assembly, but Mr. Carroll noted it has not been assigned to a Construction Manager/General Contractor (CMGC) slot yet. These bridges have low clearance, and the goal of this project is to raise the grade of these structures between a 4–6-foot in elevation and utilizing fiber reinforcing for the bridges. Currently, carbon steel is being used in the reinforcing strands. This has contributed to the accelerated deterioration of the bridges.

- U-5710- Military Cutoff at Eastwood Road. The current right-of-way date is 2023 and planned construction date is 2026 with a price of around \$75 million.
- U-3338C Kerr Avenue at Martin Luther King Jr Parkway. The purchase of some right-of-way has been done for this project. The planned construction date is 2028 with a cost around \$27 million.
- U-5954- Castle Hayne Road at N. 23rd Street roundabout. Its cost is around \$7 million and the planned construction year of 2027.
- F032023-J- N 23rd Street widening at the intersection and entrance to Wilmington Internation Airport. The current price is \$3.5 million dollars, and the right-of-way and contract times are still to be determined. NCDOT does believe that the utility and right-of-way impacts will be minimal and are working through those details.
- U-5731- US 74 at US 17/US 421 is the interchange north of the battleship. The planned construction date is 2029 with a cost around \$54.5 million dollars.
- U-6199- Wilmington Citywide Signal System. The planned construction is 2030. There is minimal right-of way impacts regarding where these new signals will be installed. The cost is around \$60.5 million dollars.
- U-5790- US 421 (Carolina Beach Road) widened from NC 132 (College Road) down to SR 1187 (Sanders Road) with a continuous flow interstation. The plan is to start construction in FY 2029 with a cost of \$35 million dollars.
- U-4434- Independence Blvd Extension. The draft environmental impact study has been completed and is being reviewed. When approval of the impact study is verified the next step with this project will be public comment this fall. The construction timeframe is 2031 with a cost of \$200.4 million. These times are based on the approval of the impact study.
- U-5704- NC 132 (College Road) and US 17/76 (Oleander Drive Interchange) is currently in project design only. NCDOT is looking at different designs and waiting on most recent traffic forecast will impact the project.
- R-3300A/B/U-5732-Hampstead Bypass A. The right-of-way for this project started back in 2018 and the department is looking to start construction in fiscal year 2026. The B portion is under construction already. Cost for section A is \$228 million.

Mr. Carroll then presented projects that are under construction at this time:

- R-3300A/B Hampstead Bypass B section. The overall project is 45% complete with detours on Hoover Road, NC 210 and Holiday Drive. Six of eight culverts have been completed and structures on NC 210 and Hoover Road have been started. He showed some updated construction photos showing the progress of the project.
- U-5914-NC 133 at US 17/US 74/US 76 to SR 1554 (Old River Road) is expected to be completed in the next few weeks.
- U-5710A Drysdale Extension is expected to be open this fall. The contractor has been doing a great job staying on timeframe.

• U-4902D Market Street is anticipated to be completed spring 2025.

Mr. Carroll then moved onto future projects that have yet to be funded.

He presented some background information on the Cape Fear Memorial Bridge Replacement project. He stated the project has been moving forward since 2020. During that time and now, the MPO Board voted to score the project as a toll project and a grant has been awarded. There are also two other grants that are out there for review. He then presented the three main options that are being considered at this time. The first being a 65-foot moveable span this comes with a high cost to build and maintain. The second option, 135-foot fixed span. The third and final option is 100-foot+/-35-foot fixed span to be determined by USACE 408 Section and the USCG. Based on the NCDOT STIP and the Large Bridge Grant the remaining fund source amount is around \$157 million. This is where the other two grant options will become a valuable option. He shared the feasibility study results showing 6-lane median- divided facility, multi-use path, and 12-foot outside shoulders.

b. Cape Fear Memorial Bridge Closure Alternative Transportation Survey Results, Carolyn Caggia, WMPO

Ms. Caggia stated the preservation project replaced the grid deck and support beams underneath the deck to extend the life of the bridge. Eastbound lane closures started January 29, 2024, through March 31, 2024, and the Westbound Lane closures lasted April 8, 2024, through May 8, 2024. The WMPO began outreach in November 2023 to member jurisdictions and to some major local and regional employers to advise them of the project.

Teleworking, alternative work schedules, carpooling, public transportation, bicycling and walking were Travel Demand Modal (TDM) strategies promoted with assistance from the GO Coast program also offering personalized commuter plans.

Ms. Caggia stated that in January, Wave Transit and the WMPO submitted a joint funding request to NCDOT's Integrated Mobility Division (IMD) for shuttles and communications to assist with congestion mitigation during the project. NCDOT agreed to provide up to \$500,000 for the expansion of RideMICRO service in Zone 1, an additional vehicle, expanded service hours, and marketing for RideMICRO and TDM strategies.

She then noted the marketing channels used such as digital billboards, google search ads, social media posts and local media advertising. The number of advertising hits were substantial with digital ad impressions hits at 98,119 and video ad impression at 146,250, Google ad impressions at 1,640, and social media ad reach at 64,330.

Ms. Caggia stated that the marketing effort was a big part of the increase in RideMICRO numbers during the closures.

The survey was opened in May, and it received 366 responses. The first question was where the respondents were from. The largest response was from Brunswick County and as far south as South Carolina. The next question was did respondents utilize any detours during the project. 210 respondents said yes, they changed their route to avoid traffic, 108 respondents stated they used NCDOT -signed detours, and 45 respondents stated they stuck to their regular route. Respondents were asked if they utilized alternative transportation during the closures. Most respondents stated they drove alone in their personal vehicles, 37 respondents stated they drove alone but were interested in utilizing alternative transportation, and 21 respondents stated they used alternative transportation at some point during the project. The follow up question was why respondents that were interested in alternative transportation did not utilize it. Out of 35 responses to this question, 34% said transit hours did not work for them, 34% said that they had no access to transit or RideMICRO in their area, 14% needed additional support to try a new option, 40% stated they could not work remotely, 34% stated they could not walk or bicycle in their area, 29% stated they could not shift work hours, and 23% stated they could not find a carpool partner, and 23% answered with other.

Ms. Caggia then noted the results of the survey for people who did utilize alternative transportation, what mode did they use. 21 respondents answered this question with 66% stating teleworking and 52% used an alternative work schedule. Then respondents were asked if they utilized alternative transportation for the first time during this project. 25% said yes, 45% said no but it was the first time in a while and 30% stated they have regular experience with alternative transportation.

She then presented the results of the question, what made you decide to use alternative transportation during the project, or what supported your decision. Advertisement and employer encouragement/support and saving time were some of the answers. She then noted how many respondents saw or heard any of the marketing advertisings.

Ms. Caggia stated that the biggest take aways from the survey information was digital billboards, TV advertising, and social media ads were most effective. Teleworking/alternative work schedules were most used. Opportunities for Go Coast included reaching employers who cannot offer teleworking with other TDM strategies and promoting personalized commuter plans. The data from the survey will also be used for the TDM short-range plan update.

Granseur Dick made a motion to approve the consent agenda; Helen Bunch seconded it. Motion passes unanimously.

5) Regular Agenda

a. Resolution approving the WMPO's Local Input Point Assignment for Regional Impact Tier Projects for P7.0

Abby Lorenzo, WMPO noted that Included in the packets is the draft Prioritization 7.0 Regional impact point assignment. Back in February the WMPO approved its Local Entry Point Methodology, which a copy is also included in the agenda packet, which outlines the criteria used to essentially score the eligible projects at their respective tier the regional impact and division needs and assign our 1,600 impact points to the highest scores and projects.

She stated the criteria for those projects or scoring those projects in between the opportunities for coordination with NCDOT consistency to adopt the plans, the status of the project and development and the number of prioritization cycles that a project has explored through.

The draft open point for regional projects was presented to the MPO Board at the July meeting. At which time they open a 14-day public comment period, which runs through the end of day today. The draft will be presented to the MPO Board at the August meeting, and the final point assignments are due to the NCDOT Strategic Prioritization Office (SPOT) office by August 30th.

She noted the importance that when looking at the general input point assignment the division needs input point assignment later in the prior decision cycle, that current estimates for the available funding to program these projects. In the regional tier is in the negative. Regarding new projects in the Regional or Division Tiers the opportunity of new projects being funded is unlikely. However, the process of creating scores with regional and

division eligible projects and local input as part of the score is still going to proceed.

Motion to approve the WMPO's Local input point assignment for Regional Impact Tier projects made by Mark Hairr and seconded by Mike Kozlosky. Motion passes unanimously.

6) Discussion

a. 2024-2033 STIP/MPO Transportation Improvement Program Administrative Modifications #24-8 Mike Kozlosky stated this is for informational purposes only and will be brought back at the next meeting for approval.

7) Updates

a. Wilmington Urban Area MPO

Mike Kozlosky noted that the updates are included in the packet. Mr. Kozlosky noted the Direct Attributable project submittals are due no later that 5:00 PM on September 13th.

b. Cape Fear Public Transit Authority

Mark Hiarr, WAVE, stated the updates were in the packet. He added that WAVE was still currently doing public outreach and has the survey located on their website and encouraged the TCC members to share the information. It is open until September 15th and hope to share all the information gathered at the September 26th Cape Fear Transportation Board Meeting.

c. NCDOT Division 3

Michelle Howes stated that the East Channel Bridge Preservation project should be finishing up in a few weeks.

d. NCDOT Integrated Mobility Division

e. NCDOT Transportation Planning Division

Amanda Killian, NCDOT, stated the fiscal year 25 approval letter for the WMPO were sent last week. The Carteret County CTP is underway and the next meeting for the Pender CTP is September 4th.

There being no further business Sam Boswell made a motion to adjourn the meeting, seconded by Michelle Howes and the motion carried unanimously.

FY 2025 PUBLIC TRANSPORTATION PLANNING SECTION 5303 GRANT AGREEMENT FOR THE WILMINGTON URBANIZED AREA

THIS AGREEMENT made and entered into this _____ day of ______, 2024 by and between the City of Wilmington, the Wilmington Urban Area Metropolitan Planning Organization, a metropolitan planning organization and the Cape Fear Public Transportation Authority d/b/a "Wave Transit", a North Carolina public transportation authority.

WITNESSETH

WHEREAS, by joint resolution the City of Wilmington and New Hanover County established the "Cape Fear Public Transportation Authority" (hereinafter referred to as "Wave") to provide public transportation services within the area designated as the Wilmington Urbanized Area (hereinafter referred to as "UZA"), effective July 1, 2004, in recognition of the fact that some traffic and transportation concerns of each entity are the same without regard for any jurisdictional boundary; and

WHEREAS, pursuant to, and in compliance with, 23 C.F.R. § 450.306, the Wilmington Urban Area Metropolitan Planning Organization (hereinafter referred to as "MPO") was designated as the policy body for cooperative transportation decision making in the UZA; and

WHEREAS, the City of Wilmington serves as the Lead Planning Agency for the MPO; and

WHEREAS, on November 18, 2020, the MPO, which includes the City of Wilmington,

New Hanover County, North Carolina Department of Transportation, and other urban area jurisdictions adopted the "Cape Fear Moving Forward 2045" which affects the UZA; and

WHEREAS, Wave is the provider of public transportation services in the UZA; and

WHEREAS, on June 22, 2005, the Secretary of Transportation for the State of North Carolina, with authority vested by the Governor of the State of North Carolina, and in accordance with Title 49 of the United States Code § 5307(a)(2) and the Transportation Equity Act for the 21st Century, declared Wave to be a designated recipient of Federal Urbanized Area Formula Program funds for the UZA; and

WHEREAS, the MPO is the recipient of Federal Transit Administration 49 U.S.C. § 5303 transit planning funds for the UZA; and

WHEREAS, the Federal Transit Administration, pursuant to 49 U.S.C. § 5303, provides 80% of transportation planning funds for the UZA, the North Carolina Department of Transportation provides 10%, and the required 10% local match is shared by the members of the MPO in accordance with the Memorandum of Understanding for Cooperative, Comprehensive, and Continuing Transportation Planning, dated June 30, 2016; and

WHEREAS, 23 C.F.R. § 450.314 requires an agreement between Wave and the MPO specifying cooperative procedures for carrying out transportation planning and programming.

NOW THEREFORE, in consideration of the mutually beneficial covenants of agreement between the parties hereinafter expressed in enumerated terms, the adequacy and sufficiency of which of hereby acknowledged by each as valuable consideration the City of Wilmington on behalf of the Metropolitan Planning Organization and Wave agree as follows:

- 1. <u>Cooperation.</u> The MPO and Wave shall cooperate in long range planning for the provision of public transportation services in the UZA, including the Metropolitan Planning Organization Transportation Improvement Program (hereinafter referred to as "MPO TIP"). Such cooperation includes, but is not limited to, estimating funds needed for the services recommended in the MPO TIP as adopted by the MPO. MPO TIP is in accordance with the State Transportation Improvement Program is updated.
- 2. <u>Planning</u>. Wave shall be afforded the opportunity for meaningful participation in the public transportation planning and decision-making process. The parties shall insure that projects in the public transportation service portion of the MPO TIP are included in the planning process.
- 3. <u>Tasks.</u> Wave agrees and covenants to dutifully and properly perform the program tasks assigned to them as evidenced by the line-item allocation shown on the MPO's budget which is known as the Unified Planning Work Program.
- 4. <u>Funding</u>. The MPO will pay to Wave seventy percent (70%) of its allocation of 49 U.S.C. § 5303 planning funds for the term of this agreement. No funds paid under this Agreement shall be paid from the City of Wilmington's funds, except those held for the MPO. No funds paid under this agreement shall exceed \$80,861 in FY25.
- 5. <u>Duration</u>. This Agreement shall commence on the date of its full execution by all parties and continue for one year or as long as Federal and State funding for public transportation planning are provided for the UZA if such funding is for less than one year.
- 6. <u>Termination</u>. This Agreement shall terminate as a result of the loss of Federal

and/or State funding for public transportation services for the UZA. Additionally, any party may terminate this Agreement upon written notice to the other party which specifies an effective date of termination. The effective date of said "Notice of Termination" shall be no earlier than thirty (30) days prior to the date the notice is sent.

- 7. <u>Governing Law</u>. All of the terms and conditions contained herein shall be interpreted in accordance with the laws of the State of North Carolina without regard to any conflicts of law principles and subject to the exclusive jurisdiction of federal or state courts within the State of North Carolina. In the event of a conflict between the various terms and conditions contained herein or between these terms and other applicable provisions, then the more particular shall prevail over the general and the more stringent or higher standard shall prevail over the less stringent or lower standard.
- 8. <u>Entire Agreement, Amendments</u>. This Agreement constitutes the entire contract between the parties, and no warranties, inducements, considerations, promises or other inferences shall be implied or impressed upon this agreement that are not set forth herein. This Agreement shall not be altered or amended except in writing signed by all Parties.

SUBJECT: FY25 Amendment #2 – Special Study – Compensation Analysis

The WMPO employees are the organizations most valuable assets and without them we would not be able to deliver the services required by federal law or expected by our members. To ensure that the WMPO is competitive in the current job market and able to maintain and recruit skilled employees necessary to carry out the function of the MPO, staff recommends hiring a consultant to complete a compensation analysis. The compensation analysis is supported by the WMPO's adopted 2022-2026 Strategic Plan and is recommended to be updated periodically in the WMPO's 2023 Organizational Assessment.

This study will review the WMPO's existing job descriptions to understand each position's key responsibilities, requirements, levels within respective career progressions, and place within the organizational reporting and decision- making hierarchy.

The result will be a market analysis of current staffing and compensation against the market as well as similar organizations to ensure the WMPO is in line with our peers. At the conclusion of the study, a virtual presentation will be presented before the Board to outline the analysis and any recommendations.

To fund the study within the FY25 budget, staff recommends shifting \$6,300 in STBG-DA funds from the Management & Operations task to a new Special Study task for a Compensation Analysis. Staff recommends contracting Catapult Employers Association, Inc, the City's approved consultant to perform compensation analyses.

II-B-3 Special Studies: Consultant – Compensation Analysis

Based on anticipated expenditures, the line item increased by \$6,300 Increase of expenditure based on contracted amount to hire Catapult Consultants to perform a Compensation Analysis.

The result will be a market analysis of current staff positions and compensation against similar organizations to ensure the WMPO is in line with our peers. In addition, Catapult will provide strategies that bolster internal equitable compensation and support the WMPO's ability to recruit and retain skilled employees necessary to meet the federal requirements and overall functions of the MPO.

At the conclusion of the study, a virtual presentation will be presented before the Board to outline the analysis and recommendations.

Based on anticipated expenditures, the line item decreased by \$6,300 Reallocate funds from the Management & Operations task to task II-B-3, Special Studies: Consultant – Compensation Analysis, per the narrative above.

Introduction

In compliance with Federal law and in the spirit of cooperation, the Wilmington Urban Area conducts a "cooperative, comprehensive, and continuing" transportation planning process. This Planning Work Program (PWP) outlines the tasks and associated funding sources dedicated to the Wilmington Urban Area MPO transportation planning process during fiscal year 2025. Depending on the specific funding source, tasks funded through the PWP are eligible for reimbursement of 80-90% of their cost from the Federal Highway Administration and Federal Transit Administration through the North Carolina Department of Transportation.

The PWP for the Wilmington Urban Area identifies seven separate funding sources for Urban Area transportation planning. A brief description of these funding sources follows:

- Federal Highway Administration Section 104(f) Funds (PL104)
 Funds dedicated to the urban area to perform transportation planning. PL104 funds require a 20% local match.
- Federal Highway Administration Safe & Accessible Transportation Options Set Aside (SATO/Y410)
 These funds are dedicated to the urban area to perform transportation planning to increase safe and accessible options for multiple travel modes for people of all ages and abilities. SATO/Y410 funds are 100% reimbursable.
- Federal Highway Administration Surface Transportation Block Grant-Direct Attributable Funds (STBG-DA)
 Funds dedicated to Transportation Management Areas and these funds can be used to perform transportation planning. STBG-DA funds require a 20% local match.
- Federal Highway Administration State and Planning Research Funds (SPR) These funds are used for statewide planning and research activities. Their purpose is to establish a cooperative, and comprehensive framework for making transportation investment decisions and research activities throughout the State. These funds require a 20% match that will be provided by the state.
- Federal Highway Administration Safe Streets for All (SS4A)
 These are discretionary grant funds to be used for the development of a multimodal, accessible safety plan for the WMPO planning area. SS4A funds require a 20% local match. The WMPO's FY 24 PWP included a 20% local match (50% from the state, 50% member contributions) for a \$400,000 SS4A planning grant for the development of a regional Comprehensive Safety Action Plan. The WMPO applied during the FY 24 funding cycle and received notification of the award in December 2023. Plan development will begin in 2024.

- Federal Transit Administration Section 5303 Funds
 These funds are used for transit planning in the urban area. The Federal Transit
 Administration provides 80% of these funds, NCDOT 10%, and there is a required 10% local match.
- Local Member Non-Grant Contributions Member Only Additional Funds Local only supplied funds for WMPO operating expenses not eligible for grant funding.

The local match requirements will be shared by all members of the Wilmington Urban Area MPO in direct proportion to population as defined in the Wilmington Urban Area MPO Memorandum of Understanding.

II-A Data and Planning Support Line-Item Codes: \$90,900

II-A-1 Networks and Support Systems: \$81,600

<u>Bike & Ped. Facilities Inventory</u> – Staff will facilitate inventory of significant municipal, state, and federal bicycle and pedestrian transportation facilities. These systems shall be incorporated in the Long-Range Transportation Plan update and analyzed in conjunction with other transportation performance measures.

<u>Traffic Volume Counts</u> – Wilmington MPO staff maintains an ongoing traffic counting program. An annual summary of the urban area traffic counts and accident data will be prepared and uploaded to the WMPO website.

II-A-2 Travelers and Behavior: \$2,300

<u>Dwelling Unit, Population, Employment Changes</u> – Changes in population and development across the service area will be identified and evaluated to determine necessary restructuring of transportation services to meet current and forecasted demand. Census data, local parcel, zoning, and tax data records; Employment Security Commission; and private vendors are acceptable sources of information for this purpose. This item may include the development and maintenance of a GIS database.

<u>Travel Time Studies</u> – Peak and off-peak travel time studies may be conducted for those street segments that are included in the Congestion Management System. Travel time studies may be required during the travel model calibration phase as well.

II-A-3 Transportation Modeling: \$7,000

<u>Financial Planning</u> – Develop realistic, best estimates of funding sources available and project cost estimates throughout the forecast years for the MTP. Ensure fiscal constraint in the update of the MTP. Implementation of the Performance Measures from the Infrastructure Investment and Jobs Act.

<u>Travel Model Updates</u> – In concert with the North Carolina Department of Transportation, MPO staff will assist in the development of the 2050 travel demand model. Tasks to include assistance with trip generation and review of trip distribution, modal split, and trip assignment.

II-B Planning Process Line-Item Codes: \$61,500

II-B-1 Target Planning: \$5,000

<u>Congestion Management Strategies</u> – Develop strategies to address and manage congestion by increasing transportation system supply, reducing demand by application of alternative mode solutions, and transportation system management strategies. Evaluate strategies developed for the Congestion Management Process. Document process and solutions in the update of the MTP and CMP reports. Implementation of the Performance Measures from the Infrastructure Investment and Jobs Act.

<u>Freight Movement/Mobility Planning</u> – Identification of freight movement deficiencies, priorities, and proposed improvement solutions and strategies. Provide documentation of process and recommendations in the update of the MTP. Implementation of the Performance Measures from the Infrastructure Investment and Jobs Act.

<u>Hazard Mitigation & Disaster Planning</u> – Hazard mitigation planning reduces loss of life and property by minimizing the impact of disasters. After identifying these risks, develop long-term strategies for protecting people and property from similar events. Mitigation plans are key to breaking the cycle of damage and reconstruction.

II-B-2 Regional Planning: \$46,500

<u>Airport/Air Travel Element of the of the Metropolitan Transportation Plan</u> – Identify airport and air service deficiencies, priorities, and proposed airport and air service improvement solutions and strategies. Provide documentation of process and recommendations in the update of the MTP.

<u>Bicycle & Pedestrian Element of the Metropolitan Transportation Plan</u> – Identify bicycle deficiencies, priorities, and proposed bicycle and pedestrian improvement solutions and strategies. Provide documentation of the process and recommendations in the update of the MTP. Implementation of the Performance Measures from the Infrastructure Investment and Jobs Act.

<u>Collector Street Element of the Metropolitan Transportation Plan</u> – Collector Street planning will be conducted as required to develop standards and preliminary locations for collector streets in advance of development. The objective of this planning activity is to ensure optimum traffic operations for the developing street system and transit accessibility to developing areas.

<u>Community Goals & Objectives</u> – Monitor public input as it pertains to goals and objectives set forth in the adopted Metropolitan Transportation Plan. Implementation of the Performance Measures from the Infrastructure Investment and Jobs Act.

<u>Highway Element of the Metropolitan Transportation Plan</u> – Identification of highway deficiencies, priorities, and proposed highway improvement solutions and strategies. Provide documentation of process and recommendations in the MTP. Implementation of the Performance Measures from the Infrastructure Investment and Jobs Act.

<u>Rail, Water, or other mode of the Metropolitan Transportation Plan</u> – Identify rail and waterway deficiencies, priorities, and proposed rail and waterway improvement solutions and strategies. Provide documentation of process and recommendations in the update of the MTP.

II-B-3 Special Studies: \$10,000

Planning Staff time allocated to managing and coordinating with the NCDOT and contracted consultant(s) to develop the Intelligent Transportation System Plan funded with STBG-DA (WMPO) and SPR (Federal and State) funds. This plan is being developed per the recommendations of the FHWA and the FTA in the WMPO's Certification renewal issued on March 1, 2023.

III-A Planning Work Program Line-Item Codes: \$4,000

III-A-1 Planning Work Program: \$1,000

Staff will develop a Planning Work Program (PWP/UPWP) with the guidance of the Technical Coordinating Committee (TCC) and MPO Board, staff will present the PWP for approval to the MPO Board and submit it to the NCDOT Transportation Planning Division (TPD) and NCDOT Integrated Mobility Division (IMD).

III-A-2 Metrics and Performance Measures: \$3,000

Facilitate updates to the UPWP, MTP, etc., to address performance tracking and reporting. This includes preparing quarterly reports, the annual report, requests for reimbursement, and establishing/developing/refinement/updating of performance measures/targets. This task also includes updated plans (CTP/MTP/TIP), as required to track performance measure requirements.

III-B Transportation Improvement Plan Line-Item Codes: \$7,000

III-B-1 Prioritization: \$2,000

Maintain the SPOT list of STIP projects across modes. Develop purpose and needs statements, as appropriate/needed. Work to update and improve local prioritization process for SPOT projects. Coordinate data, maps, and resolutions for STIP Project Recommendations as needed. Gather and enter data required for SPOT ranking of projects.

III-B-2 Metropolitan Transportation Improvement Program (TIP): \$2,500

Work cooperatively with the NCDOT and other partner agencies to review and provide comments on the draft STIP, the final STIP, and then adopt the corresponding MPO TIP. This includes reviewing and refining TIP project schedules and descriptions in the Draft TIP and coordinating meaningful public involvement in the TIP process.

III-B-3 Merger/Project Development: \$2,500

General work associated with development or amendments to the STIP/MPO TIP. Review design issues for TIP Projects and provide comments to appropriate agencies. Participate in the environmental study process for STIP/MPO TIP projects and provide an MPO representative on NEPA/404 Merger Teams. Monitor the public involvement process for STIP/MPO TIP projects and ensure adequate community input; assist PDEA as requested. Participation in project-specific workgroup meetings, as needed. Facilitate dialog between NCDOT and MPO-member communities. Participate in scoping meetings, public input, and merger meetings.

III-C Civil Rights Compliance & Other Regulatory Requirements Line-Item Codes: \$8,300

III-C-1 Title VI Compliance: \$500

Work to ensure compliance with the requirements of Title VI in urban area policies and practices.

III-C-2 Environmental Justice: \$2,000

Analysis and outreach to ensure that transportation plans and projects comply with Environmental Justice policies.

No PL104 funded tasks anticipated in FY25.

III-C-4 Planning for the Elderly: \$300

Ensure the special needs of the elderly and disabled are addressed in all transportation planning projects.

III-C-6 Public Involvement: \$5,000

Extensive Public Participation effort will be carried out to solicit input and gauge public input for planning studies within the Wilmington Urban Area MPO's planning area boundary. Outreach will be used in the development of the MTP 2050 Plan.

Activities to encourage private sector participation in planning and project activities.

<u>Management & Operations</u> – Required ongoing administrative and operational tasks to support MPO committees and reporting requirements.

Narrative of Safe & Accessible Transportation Options Set Aside (SATO/Y410) Work Tasks to be Performed in FY 25

(Primary work to be performed by lead planning agency staff except where noted.)

In 2022, the Infrastructure Investment and Jobs Act (IIJA) has added a new Metropolitan Planning set-aside for Increasing Safe & Accessible Transportation Options. The Act requires each MPO to use at least 2.5% of its PL funds on specified planning activities to increase safe and accessible options for multiple travel modes for people of all ages and abilities. [§ 11206(b)]. The 2.5% set aside is provided by a separate allocation of PL funds (federal program code Y410). The MPO's share of this amount is distributed using the same allocation formula.

This funding requires no local match and the full funding amount of \$8,200 is 100% reimbursable.

This task may include the following activities to increase safe and accessible options for multiple travel modes for people of all ages and abilities:

- 1. Adoption of Complete Streets standards or policies.
- 2. Development of a Complete Streets prioritization plan that identifies a specific list of Complete Streets projects to improve the safety, mobility, or accessibility of a street.
- 3. Development of transportation plans to:
 - a. Create a network of active transportation facilities, including sidewalks, bikeways, or pedestrian and bicycle trails, to connect neighborhoods with destinations such as workplaces, schools, residences, businesses, recreation areas, healthcare and childcare services, or other community activity centers.
 - b. Integrate active transportation facilities with public transportation service or improve access to public transportation.
 - c. Create multiuse active transportation infrastructure facilities (including bikeways or pedestrian and bicycle trails) that make connections within or between communities.
 - d. Increase public transportation ridership; and
 - e. Improve the safety of bicyclists and pedestrians.
- 4. Regional and megaregional planning (i.e., multi-jurisdictional transportation planning that extends beyond MPO and/or State boundaries) that address travel demand and capacity constraints through alternatives to new highway capacity, including through intercity passenger rail; and
- 5. Development of transportation plans and policies that support transit-oriented development.

Special Studies: Consultant - Intelligent Transportation Systems Plan – On March 1, 2023, the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) issued the certification review of the transportation planning process for the Wilmington Metropolitan Planning Organization (WMPO). FHWA and FTA are required to jointly review and evaluate the transportation planning process for each urbanized area over 200,000 in population at least once every four years to determine if the process meets the Federal planning requirements. The State Planning and Research (SPR) Program funds States' statewide planning and research activities. The funds are used to establish a cooperative, continuous, and comprehensive framework for making transportation investment decisions and to carry out transportation research activities throughout the State.

In the spirit of cooperation, the NCDOT's Transportation Mobility and Safety Division (TSMO) has offered to apply for \$200,000 in SPR funds to assist the WMPO with the Intelligent Transportation Systems Plan. The NCDOT TSMO office has agreed to manage and contract with a consultant to perform this study. WMPO Staff will contribute local/regional input to the consultant and participate in sessions with the NCDOT and consultant necessary to draft this plan. The Intelligent Transportation Systems Plan is anticipated to be completed by June 30, 2025.

<u>Special Studies: Consultant - Intelligent Transportation Systems Plan</u> – On March 1, 2023, the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) issued the certification review of the transportation planning process for the Wilmington Metropolitan Planning Organization (WMPO). FHWA and FTA are required to jointly review and evaluate the transportation planning process for each urbanized area over 200,000 in population at least once every four years to determine if the process meets the Federal planning requirements. The review includes "it is recommended that the MPO coordinate with NCDOT to update the Regional ITS Architecture/Strategic Deployment Plan, and that the MTP include stronger language directly connecting the Regional ITS Architecture/Strategic Deployment Plan to the projects identified in the MTP." \$100,000 in STBG-DA funds (\$80,000 Federal/\$20,000 Local) will be used in conjunction with \$200,000 in State Planning and Research (SPR) funds to provide a more comprehensive plan. (See page 11 for STBG-DA funds.)

Narrative of Safe Streets and Roads for All (SS4A) Continued Funding for a Special Study (Primary work to be performed by a contracted consultant.)

The federal Infrastructure Investment and Jobs Act (IIJA) established the new Safe Streets and Roads for All (SS4A) discretionary program with \$5 billion to be dispersed over the life of the program. The grant program funds are to be awarded on a competitive basis to support planning, infrastructure, behavioral, and operational initiatives to prevent death and serious injury on roads and streets involving all roadway users, including pedestrians; bicyclists; public transportation, personal conveyance, and micro-mobility users; motorists; and commercial vehicle operators.

The SS4A program provides funding for the completion of Comprehensive Safety Action Plans and Implementation. To access the implementation funding, a Comprehensive Safety Action Plan meeting the USDOT standards must first be completed. Applications are accepted annually. The estimated cost to complete A Comprehensive Safety Action Plan for the Wilmington MPO's planning area is \$500,000. The grant provides federal funding in the amount of 80% and requires a 20% local match. The North Carolina Department of Transportation is not an eligible applicant but has committed to provide \$50,000 in funding as a local match and if awarded MPO members would provide the remaining \$50,000. The match requirements from NCDOT and MPO members were committed in the FY 24 PWP and the WMPO applied during the SS4A FY 24 funding cycle call for \$400,000 to develop a regional Comprehensive Safety Action Plan. The grant was awarded in December 2023 and development of the plan will begin in 2024.

Following adoption of the Comprehensive Safety Action Plan, this plan will provide an opportunity for our members with the ability to seek SS4A Implementation funding to improve and enhance safety in the communities served by the MPO.

II-B-3 Special Studies: Consultant – Compensation Analysis

Based on anticipated expenditures, the line item increased by \$6,300 Increase of expenditure based on contracted amount to hire Catapult Consultants to perform a Compensation Analysis.

Catapult will compile a competitive market-based compensation analysis for the WMPO's twelve current positions. This study will review the WMPO's existing job descriptions to understand each position's key responsibilities, requirements, levels within respective career progressions, and place within the organizational reporting and decision- making hierarchy.

The result will be a market analysis of current staff positions and compensation against similar organizations to ensure the WMPO is in line with our peers. In addition, Catapult will provide strategies that bolster internal equitable compensation and support the WMPO's ability to recruit and retain skilled employees necessary to meet the federal requirements and overall functions of the MPO.

At the conclusion of the study, a virtual presentation will be presented before the Board to outline the analysis and recommendations.

RESOLUTION SUPPORTING THE CITY OF WILMINGTON'S APPLICATION FOR THE U.S. DEPARTMENT OF TRANSPORTATION / FEDERAL HIGHWAY ADMINISTRATION'S BRIDGE INVESTMENT PROGRAM (BIP) GRANT FOR THE REPLACEMENT OF THE 4TH STREET BRIDGE AND THE PINE GROVE DRIVE BRIDGE

WHEREAS, the Wilmington Urban Area Metropolitan Planning Organization provides transportation planning services for the City of Wilmington, Town of Carolina Beach, Town of Kure Beach, Town of Wrightsville Beach, Town of Belville, Town of Leland, Town of Navassa, New Hanover County, Brunswick County, Pender County, Cape Fear Public Transportation Authority, and the North Carolina Board of Transportation; and

WHEREAS, the U.S. Department of Transportation / Federal Highway Administration's (FHWA) Bridge Investment Program (BIP) is part of a larger suite of discretionary federal funding authorized under the Bipartisan Infrastructure Law (BIP), which aims to significantly improve and/or rebuild America's infrastructure across all fifty states and U.S. Territories; and

WHEREAS, the funding programs offered by the United States Department of Transportation and its agencies are historic in terms of the large size of the awards, with the BIP offering up to \$100 million per award; and

WHEREAS, applicants will be evaluated by FHWA in terms of how each proposed project addresses issues such as climate change, resiliency, equity, safety, and accessibility, among other concerns; and

WHEREAS, the BIP grant addresses these issues, funding the replacement, rehabilitation, preservation, and protection of bridges that are registered on the Federal Highway Administration's National Bridge Inventory (NBI) and in a particular State of Good Repair. NBI Bridges are designated as being in either Poor condition, or in Fair condition, but will fall into Poor condition within three years are eligible for the grant program; and

WHEREAS, the City of Wilmington (City) has identified two of such bridges—the 4th Street Bridge and the Pine Grove Bridge—both of which are currently rated in Fair condition but will fall into Poor condition within three years; and

WHEREAS, each bridge replacement will align with current DOT standards and be designed with improved safety, accessibility, mobility, and climate change concerns for all potential road users; and

WHEREAS, the 4th Street Bridge is a three span bridge that was built in 1950 with a design loading rate of 25 tons. Since 2016, the load bearing capacity of the bridge has been steadily restricted and is now at 10 tons. This means that the bridge can no longer accommodate buses and emergency response vehicles. The replacement of the 4th Street Bridge was marked as a high priority item in the City's Bridge Asset Management Plan and is to be replaced with a new three span bridge; and

WHEREAS, in cooperation with the North Carolina Department of Transportation (NCDOT), the replacement of the 4th Street Bridge is being coordinated with the potential future extension of passenger rail. This passenger rail will pass under 4th Street Bridge, and will develop alongside the first phase of the City's Downtown Trail project. The identified project area within the City is a Historically Disadvantaged Community and an area of Persistent Poverty, and the improvement would contribute to providing greater economic vitality to the neighborhood, with enhanced multimodal access for residents who do not have cars and primarily use transit or walk. All three projects will therefore act in concert to provide the surrounding neighborhoods and the greater Wilmington region with improved access to local businesses, houses of worship, jobs, medical facilities, and home; and

WHEREAS, the Pine Grove Bridge was built in 1976 and is currently an approximately 60 linear foot cored slab bridge over Hewlett's Creek. High traffic volumes and deterioration of the substructure has degraded the bridge over time. It is anticipated that continued deterioration will result in future load restrictions; and

WHEREAS, maintaining a high level of service on this primary north-south corridor for the City of Wilmington, towns of Carolina Beach and Kure Beach, and the southern portion of unincorporated New Hanover County is essential to provide emergency services access for nearby Fire Station and EMS facilities, in addition to connectivity to medical, commercial, and residential areas along the Pine Grove Drive corridor and beyond. Future load restrictions on the bridge would impact emergency response times as well as force additional traffic to South College Road. As such, the City considers the replacement of the Pine Grove Bridge as a high priority item, as is reflected in the Bridge Asset Management Plan; and

WHEREAS, the new structure that will replace the current Pine Grove Drive bridge will be an approximately 600 linear foot bridge spanning the coastal wetlands. The proposed bridge will have an increased load capacity, allow for the removal of the existing causeway and consequently provide an environmental benefit through the natural restoration of coastal wetlands. The longer and higher bridge will also improve the vertical clearance from the water surface to the low chord of the bridge. This will address concerns about future sea level rise due to climate change in addition to improving access to the navigable channel under the bridge. A 10' multi-use path will be implemented on the bridge to facilitate future connection of the Greenville Loop Trail to the Masonboro Loop Trail, which will allow residents and guests of the region improved access to area amenities; and

WHEREAS, the proposed BIP grant funding will be an integral part of transforming the existing bridges to better serve the needs of the City's residents and visitors from a variety of angles that will address safety, mobility, accessibility, the environment, resiliency, among other pressing issues; and

WHEREAS, these projects are vital to the emergency preparedness and economic vitality of not only Wilmington, but the greater Wilmington metropolitan area.

NOW THEREFORE, be it resolved that the Board of the Wilmington Urban Area Metropolitan Planning Organization hereby supports the City of Wilmington's application to the U.S. Department of Transportation / Federal Highway Administration's Bridge Investment Program for the 4th Street Bridge and Pine Grove Bridge replacement projects.

CAPE FEAR NAVIGATING CHANGE

Project Description/Scope: The WMPO has begun the planning process for our region's 2050 Metropolitan Transportation Plan (MTP), Cape Fear Navigating Change 2050. A long-range Metropolitan Transportation Plan for the region is federally required and must be developed, updated, and adopted by the WMPO every five years. The final plan will be used by federal, state, and local governments to guide decision-making for transportation projects in our region over the next 25 years, including which projects receive state or federal funding, the design and location of local roadways, coordinating land use and development, and identifying projects for further plans and studies. Planning activities began in April of 2023 with plan adoption expected in November of 2025.

2050 MTP Financial Element

WMPO staff is continuing to work with consultant Kimley-Horn on identifying cost estimates for draft projects, exploring alternative funding sources, and fiscally constraining roadway projects. The financial element entails a review process to assess alignment between submitted modal project to available funding and overall fiscal feasibility.

Project Status and Next Steps:

- Initial cost estimation and fiscal constraints for submitted roadway projects have been received and are currently under review by staff.
- Initial revenue forecasting for all modes have been received and are currently under review by staff
- The next steps include continued collaboration between the WMPO and Kimley-Horn to ensure comprehensive coverage of all relevant factors.
- A comprehensive update on all reviewed projects and their financial implications will be provided to the TCC and Board in Fall 2024. This update will include a ranked draft project list complete with cost estimates.

2050 MTP TSMO Chapter

WMPO staff began researching Transportation Systems Management and Operations (TSMO) strategies for the 2050 MTP in Summer 2024. TSMO strategies aim to optimize the performance of the existing transportation system, including to increase roadway capacity, reduce congestion, and improve safety and security.

Project Status and Next Steps:

- WMPO staff are conducting research on current TSMO strategies recommended by the FHWA and other transportation agencies, as well as current federal or state laws, regulations, or programs related to TSMO.
- TSMO strategies will be described within the MTP in chapter which will include a table which outlines the applicability, feasibility, cost, and impact of each.
- Next steps include concluding research and putting together text and photos/illustrations.
- A draft of the 2050 MTP which includes the TSMO chapter will be provided to the TCC and MTPC in Summer 2025.

NCDOT IMD FEASIBILITY STUDY GRANTS

In July 2022, the North Carolina Department of Transportation (NCDOT) was allocated \$2 million in onetime funding from the North Carolina General Assembly to establish a Paved Trails Feasibility Study Program. The Integrated Mobility Division (IMD) was also awarded \$500,000 in State Planning and Research (SP&R) funds to support sidewalk and shared-use path feasibility studies. The purpose of the Paved Trails and Sidewalk Feasibility Studies Grant Program is to improve the pipeline of bicycle and pedestrian projects accessing state and federal funding, resulting in successful implementation of projects led by communities prioritizing multimodal infrastructure.

Wilmington Downtown Trail Phases 2 & 3:

The Downtown Trail will eventually connect the River to Sea Bikeway to the future Multimodal Transportation Center, Cape Fear Community College, and the Riverwalk. In between these locations, the trail will provide a recreational facility for several communities in proximity to the downtown. The project currently consists of three phases. The first phase, from 3rd Street to Archie Blue Park, is in the preliminary engineering phase. The purpose of this study would be to assess the feasibility of constructing Phases 2 and 3. A scoping meeting with NCDOT IMD and the selected consultant, Kittelson, was held on May 2, 2023.

Project Status and Next Steps:

- The first steering committee took place on October 17, 2023.
- The first public outreach sessions took place October-December 2023. Public engagement consisted of in-person events and an online survey that included an online comment map. In all, 486 survey responses were collected, 352 map comments were received, and 59 in-person conversations were conducted.
- The second steering committee meeting was held May 8, 2024.
- The second public outreach session was conducted during summer 2024. Public engagement consisted of two in-person events (listed below) and an online survey open June through July 15, 2024. 500 survey responses were received with 58 in-person conversations.
 - Frankie's Outdoor Market, 6/15/24
 - Nir Family YMCA, 6/18/24
- The final steering committee meeting is upcoming.
- Draft study report anticipated in summer 2024.

Gullah Geechee Heritage Trail:

The purpose of this study would be to assess the feasibility of constructing a 10'-12' multi-use path facility in the Gullah Geechee Heritage Corridor from Phoenix Park in Navassa to Brunswick Nature Park in unincorporated Brunswick County. The Gullah Geechee Heritage Corridor is designated as a Cultural Heritage Area by U.S. Congress, presenting an opportunity to educate the public about the history of the Gullah Geechee people and highlight historical sites within Brunswick County. A scoping meeting with NCDOT IMD and the selected consultant, Kittelson, was held on May 2, 2023.

- The first steering committee took place in September 2023.
- The first public outreach sessions took place during September/October 2023. There was an online survey open through the entire month of October as well. 370 surveys were completed with 120+ in-person conversations during this round of public outreach.
- The second steering committee took place on January 4, 2024.
- The second public outreach session took place in March 2024. An online survey, which received 137 responses, was available throughout March and three public meetings were held to collect input.
- The third and final steering committee meeting was held on June 12, 2024. The steering committee was provided a presentation on the draft recommended preferred alignment.
- The final study report was received on August 6, 2024.

• Presentations to the WMPO Board and four Brunswick County jurisdictions in September prior to requesting consideration by governing boards for adoption.

TC - 0021 WAVE PASSENGER AMENITIES AND UPGRADES

The project includes engineering and design, construction of concrete pads, ADA ramps, ADA access, and purchase and installation of durable bench and/or shelter, waste receptacle, and solar lighting, where applicable.

Project Status and Next Steps:

- The project was awarded funds in November 2021
- NC Board of Transportation approved the flex request in January 2023
- Flex request confirmed end of April 2023
- Letters from NCDOT transmitted May 23, 2023
- Contract awarded to Tolar
- Amenities will be deployed based on outcome of Short-Range planning review

TC-0027 WAVE PASSENGER AMENITIES AND UPGRADES

Project Description: Passenger Facilities and amenities replacement, security, and improvement: acquire, construct, or replace structures, equipment, and systems that provide passenger

facilities and amenities for fixed route bus service in the Wilmington, NC UZA. Projects include acquisition and installation of bus shelters, lighting and landing platforms along existing routes; evaluation of a new customer service enclosure at Forden Transfer Station; and extension of fencing at Padgett Transfer Station.

Project Status and Next Steps:

- The fencing at Padgett was completed in May 2023 (132 linear feet at Padgett for \$3,565.00)
- Proposals were received as part of an Invitation to Bid for the shelters and benches in Spring 2023. Tolar was selected.
- A RFQ was issued in March for Forden Station designs to improve Customer Service Representative safety in the facility. A firm was selected to design those improvements in April.
 - Designs finalized in July and an Invitation to Bid was released August 30, 2024 with a deadline for submittals of September 23, 2024.
 - A notice to proceed for construction is expected by October 30, 2024, with construction expected to take 60 days.
- Amenities will be deployed based on outcome of Short-Range Transit Plan.

TRANSPORTATION DEMAND MANAGEMENT PROGRAM

Project Description/Scope: The TDM "Go Coast" program works to increase the use of alternative transportation by WMPO residents and decrease Vehicle Miles Traveled (VMT). The WMPO Board approved Cape Fear Change in Motion 2020, the short-range TDM Plan which will guide Go Coast initiatives from 2021 to 2025. This plan identifies seven short-range strategies to increase mobility options and reduce traffic in the WMPO region. These strategies are: Alternative Work Schedules, Bike Share Program, Carpool and Vanpool, Consulting for Telecommuting Opportunities, Fostering a Bicycle and Pedestrian Friendly Culture, Improved TDM-Focused Collaboration, and Personalized Commuter Plans.

Go Coast current initiatives and project status:

- 1. Go Coast Committee The next regular Go Coast committee meeting will occur in-person on August 15, 2024, at 3 PM.
- Bicycle Helmet Initiative In April, the WMPO was awarded 100 children's bicycle helmets through NCDOT's Bicycle Helmet Initiative for distribution to children from low-income families with bicycle safety education. Staff is participating in outreach events throughout the year to distribute helmets to children and educate families on bicycle safety. So far 58 helmets have been distributed, with more distribution opportunities planned for August.
- 3. Short Range TDM plan update WMPO staff have begun work to update the short-range TDM plan, *Cape Fear Change in Motion 2020*. A public engagement period to inform this update is scheduled for September through November 2024. Steering committee meetings are ongoing with the update scheduled for completion by November 2025.
- Annual WMPO-organized bike rides Planning has begun for the 34th Annual River to Sea Bike Ride and the 4th Annual Brunswick Heritage Riverside Ride. The rides will take place September 7, 2024, and September 28, 2024, respectively.
- 5 Get There Greener Get There Greener is Go Coast's sustainable transportation challenge which occurs annually in October. Participants log their miles traveled by alternative transportation for a chance to win prizes donated by local businesses. In August, WMPO staff will begin reaching

out to local businesses to participate in Get There Greener with a donation of gift cards/items of \$25-50 value. Additionally, staff is planning for a fall Bike to Work Day on Friday, October 11. Organizations/businesses will be encouraged to set up "pit stops" for bicyclists in the morning or evening commute, providing water, coffee, snacks, etc. to those who bike by, in addition to any swag/info they may choose to hand out.



Cape Fear Public Transportation Authority September 2024 Update

Public Hearing Scheduled for September 26, 2024 on Reimagine Wave Route Improvements

The Cape Fear Public Transportation Authority will hold a public hearing on Thursday, September 26, 2024 at 12:30pm at the Forden Station Board Room to consider the final recommended route and service improvements included in the Reimagine Wave Short-Range Transit Plan. Highlights of the improved service include:

- Wave's first ever frequent (15-minute) service, done by staggering departures
- New 30-minute Saturday service on Route 108
- Port City Trolley operating more frequently, later into the evening, and on Sundays on a seasonal basis
- Direct connection from Padgett Station to Mayfaire every hour on new Route 206 Oleander Dr.
- Additional bus stops on College Road to improve access

Brunswick County Comprehensive Transportation Plan (CTP): The CTP is now complete and has been adopted and endorsed by all local agencies as well as the NCDOT Board of Transportation.

Pender County Comprehensive Transportation Plan (CTP): The Pender County CTP steering committee had their last meeting on April 23rd. The meetings are on pause as the engineer is on maternity leave. The CTP, however, is ongoing. The Pender County CTP survey opened on June 1st and closed on September 1st. Just a reminder, the Pender County CTP does not cover the Wilmington MPO portion of the county.
